Call to Order: The Chair called the meeting to order at 9:04 a.m., at which time quorum was

established.

The Chair announced that in light of the COVID-19 pandemic, protecting the health and safety of the community is of utmost concern. If you wish to submit

Chair's Report:

The Chair announced that the Commission may move into executive session to consider and evaluate personal information relating to individuals applying for licensure in accordance with section 92-5(a)(1), HRS, and/or to consult with the Commission's attorney on questions and issues pertaining to the Commission's powers, duties, privileges, immunities, and liabilities in accordance with section 92-5(a)(4), HRS.

Chair Pang reported that the Commission shall function with 8 commissioners as a Maui commissioner had not been nominated. Chair Pang announced that the Senate approved the appointment of Derrick Yamane and the reappointment of Nikki Senter, who previously served on the Commission. Commissioner Senter stated she was happy to be back.

Executive Officer's Report:

The Commission shall afford all interested persons an opportunity to submit data, views, or arguments, in writing, on any agenda item and shall provide all interested parties an opportunity to present oral testimony on an agenda item subject to the conditions set forth in section 16-99-83, HAR. The Commission may remove any person or persons, who willfully disrupt a meeting to prevent and compromise the conduct of the meeting in accordance with section 92-3, HRS. Each speaker will be limited to a five-minute time period pursuant with section 16-99-83 (a)(5), HAR.

Minutes of Previous Meeting

Upon a motion by Commissioner Ginoza, seconded by Commissioner Yamane, it was voted on carried to accept the minutes of the February 28, 2020, meeting. Commissioners Ginoza, Yamane, Klein, Kyono, Lee, Love, and Pang voted aye. Commissioner Senter abstained from the vote. The motion passed.

Upon a motion by Commissioner Ginoza, seconded by Commissioner Yamane, it was voted on and carried to accept the executive session minutes of the February 28, 2020, meeting. Commissioners Ginoza, Yamane, Klein, Kyono, Love, and Pang voted aye. Commissioners Lee and Senter abstained from the vote. The motion passed.

Condominium Review Committee

Request for approval to exercise option to renew CAI Hawaii contract for one year

Senior Condominium Specialist Richelieu informed the Commission the request was to exercise the renewal of the contract's first-year option.

Commissioner Lee moved to approve the exercise of the option to renew the CAI Hawaii contract for one year, Commissioner Kyono seconded the motion. The motion was voted on and unanimously approved.

Education Review Committee

Updated Salespersons' Prelicensing Curriculum – Final

Senior Real Estate Specialist Fujimura informed the Commission that the effective date of the updated curriculum would begin on January 1, 2020.

Upon a motion by Commissioner Yamane, seconded by Commissioner Kyono, it was voted on and unanimously approved to accept the Updated Salespersons' Prelicensing Curriculum – Final.

Core B 2019-2020, "Principal Brokers: The Buck Stops Here!", Student Resource Manual and Power Point Slides

Senior Real Estate Specialist informed the Commission that this course was currently being taught online and received positive feedback.

Upon a motion by Commissioner Yamane, seconded by Commissioner Lee, it was voted on and unanimously approved to accept Core B 2019-2020, "Principal Brokers: The Buck Stops Here!".

ACE Report – meeting of June 17, 2020

Upon a motion by Commissioner Yamane, seconded by Commissioner Lee, it was voted on and unanimously carried to approve all items of the ACE Report – meeting of June 17, 2020.

Licensing – Applications:

The Executive Officer informed the Commissioners that the information provided to the Commissioners is related only to the issue that is before the Commission for consideration. The other materials submitted are available for the Commissioners review should they desire to review it. If the applicants have an issue, which is personal in nature, they have the right to request that their application be considered in executive session.

Licensing – Applications:

Deborah Ann lijima aka Deborah Ann Shinkawa

Ms. lijima was present and was asked if she wished to have her application for real estate salesperson considered in executive session. She declined the offer.

Ms. lijima stated that she made a mistake a long time ago but had been doing well since. She added that she passed her prelicensing exam and was hired by Wyndham Vacation Resorts.

Commissioner Lee asked the applicant how long she had been incarcerated and if she received any exit support upon release. Ms. lijima stated that she was incarcerated for five years and received assistance for six months after her release which included housing. Commissioner Lee asked what the applicant learned from that experience. Ms. lijima responded not to get involved and that she learned her lesson.

Commissioner Yamane inquired how the applicant had taken responsibility. Ms. lijima responded that she abided by all terms, got early release, was subjected to routine visits, and made sure she complied.

Upon a motion by Commissioner Lee, seconded by Commissioner Ginoza, it was voted on and unanimously carried to take the matter under advisement.

Danielle D. Kilbourn

Ms. Kilbourn was present and was asked if she wished to have her application for real estate salesperson application considered in executive session. She declined the offer.

Ms. Kilbourn stated that she messed up a few years ago and since then has learned never too drink and drive as it not only endangered her but also her community. Commissioner Pang inquired what the applicant learned by attending the victim impact panel course. Ms. Kilbourn answered she learned what could have happened if she had caused an accident and that the consequences were not worth the risk.

Upon a motion by Commissioner Pang, seconded by Commissioner Lee, it was voted on and unanimously carried to take the matter under advisement.

Breauna Ford

Ms. Ford was present and was asked if she wished to have her application for real estate salesperson application considered in executive session. She declined the offer.

Ms. Ford informed the Commission that she was present to answer any questions the Commission had. Commissioner Lee pointed out the letter that the applicant submitted stated her first incident occurred in 2000 and the second in 2001, however, the court data that was submitted listed different dates. Ms. Ford apologized for the typographical error. Ms. Ford stated that she quit drinking after her second DUI and now owned a juice bar. She added that having a baby has slowed her down.

Upon a motion by Commissioner Pang, seconded by Commissioner Lee, it was voted on and unanimously carried to take the matter under advisement.

Javo Coria

Mr. Coria was present and was asked if he wished to have his application for real estate salesperson considered in executive session. He accepted the offer. The Chair informed Mr. Coria that an email invitation would be sent to him to join the Commission in executive session.

Dustin Coss

Mr. Coss was present and was asked if he wished to have his application for real estate salesperson application considered in executive session. He declined the offer.

Mr. Coss informed the Commission that his two convictions occurred when he was younger, he learned from his mistakes, and that it helped to open his eyes. He stated he knew he was wrong and that he has since attended numerous classes. He added that he has been sober for two and a half years, and is now a counselor.

Upon a motion by Commissioner Pang, seconded by Commissioner Lee, it was voted on and unanimously carried to take the matter under advisement.

Dolena Elizabeth Tymchuk (fka Brand)

Ms. Tymchuk was present and was asked if she wished to have her preliminary decision request for real estate salesperson application considered in executive session. She declined the offer.

Ms. Tymchuk informed the Commission that she got into trouble because she did not have the proper tools to cope with her special needs child and stated that he is now in a safe, special needs home. She added she did not disclose her third offense on her application as she did not see it and that her attorney informed her that that offense would be deleted from her record after seven years. Ms. Tymchuk stated that she made a terrible judgment in error, and although she made mistakes, she was self-motivated and was now ready to really help people.

Upon a motion by Commissioner Pang, seconded by Commissioner Lee, it was voted on and unanimously carried to take the matter under advisement.

Mr. Ferguson was present and was asked if he wished to have his preliminary decision request for real estate salesperson application considered in executive session. He accepted the offer. HRS § 467-8 **Prerequisites for license, registration, or certificate.** (a) No license, registration, or certificate under this chapter shall be issued to:

HRS § 467-8(3):	Any person who does not possess a reputation for or record of competency, honesty, truthfulness, financial integrity, and fair dealing;" and
HRS § 436B-19	Grounds for refusal to renew, reinstate or restore and for revocation, suspension, denial, or condition of licenses. In addition to any other acts or conditions provided by law, the licensing authority may refuse to renew, reinstate or restore or may deny, revoke, suspend, or condition in any manner, any license for any one or more of the following acts or conditions on the part of the licensee or the applicant thereof:
HRS § 436B-19(1)	Failure to meet or maintain the conditions and requirements necessary to qualify for the granting of a license;
HRS § 436B-19(8)	Failure to maintain a record or history of competency, trustworthiness, fair dealing, and financial integrity;
HRS § 436B-19(12)	Failure to comply, observe, or adhere to any law in a manner such that the licensing authority deems the applicant or holder to be an unfit or improper person to hold a license;"
HRS § 436B-19(14)	Criminal conviction, whether by nolo contendere or otherwise, of a penal crime directly related to the qualifications, functions, or duties of the license profession or vocation,"

Commissioner Ginoza seconded the motion. Commissioners Pang, Ginoza, Kyono, Love, Senter and Yamane voted aye. Commissioner Lee voted nay. Commissioner Klein abstained from the vote. The motion passed.

William A.L. Boak aka Keola Boak

After review of the information presented by the applicant, Commissioner Ginoza moved to approve the real estate salesperson license of William A.L. Boak aka Keola Boak, with conditions. Commissioner Kyono seconded the motion. The motion was voted on and unanimously carried.

The conditional real estate salesperson license is **approved**, subject to the following conditions:

- 1. That during the term of this conditional license, any violation of the terms of the payment plans shall be grounds for revocation of license.
- 2. That failure to provide written notice within 30 days to the licensing authority of any judgment, award, disciplinary sanctions, order, or other determination, which adjudges or finds that the licensee is civilly, criminally or otherwise liable for any personal injury, property damage or loss caused by the licensee's conduct in the practice of the licensee's profession or vocation shall be grounds for revocation of license.

- 3. That the Applicant shall at all times be associated with and under the direct supervision of a principal broker ("PB") or one or more brokers in charge ("BIC"), for all real estate transactions.
- 4. That the Applicant shall inform the PB, sole proprietor real estate broker, or BIC of a real estate branch office with whom the Applicant associates that the Applicant holds a conditional real estate salesperson license and may only practice pursuant to certain terms of the conditional license. The Applicant shall present to the Applicant's PB, sole proprietor real estate broker, or BIC of a real estate branch office a copy of the Commission-issued conditional letter. The Applicant shall ensure that the PB, sole proprietor real estate broker, or BIC of a real estate branch office acknowledges the terms of the Applicant's conditional license by signing and returning a signed copy of the conditional letter to the Commission.
- 5. That <u>ALL</u> changes of association and/or employment by Applicant to another real estate broker shall be submitted in writing to the Commission. The new PB, sole proprietor real estate broker, or BIC of a real estate branch office shall acknowledge the terms of the Applicant's conditional license within ten (10) days of the change by submitting a completed Change Form along with a copy of the conditional letter signed by the new PB. Failure to attach the signed conditional letter by the new PB may result in disciplinary action.
- 6. That the satisfaction of the Applicant from said payment plan(s) shall not change any terms of the conditional license.
- 7. That upon completion of payment plan(s), the Applicant must submit a written request to the Commission if the Applicant desires to have the conditions removed.

Deborah Ann lijima aka Deborah Ann Shinkawa
