A brief video regarding the virtual board meeting, including meeting procedures and helpful information regarding how members of the public can participate and

interact with the board during the meeting, was played.

Call to Order:

The Chair called the meeting to order at 9:05 a.m., at which time quorum was established by roll call.

Chair's Report:

The Chair announced that the Commission may move into executive session to consider and evaluate personal information relating to individuals applying for licensure in accordance with section 92-5(a)(1), HRS, and/or to consult with the Commission's attorney on questions and issues pertaining to the Commission's powers, duties, privileges, immunities, and liabilities in accordance with section 92-5(a)(4), HRS.

Commissioner La Costa was excused from the meeting. Prior notification of her non-attendance was received.

The Chair acknowledged Commissioner Aleta Klein, and he, along with the Commissioners, thanked Commissioner Klein for serving 8 years on the Real Estate Commission, and for her excellent work on the ACE Committee. Commissioner Klein stated it was an incredible journey, that she appreciated the wisdom of fellow commissioners, and thanked them and the Real Estate Branch staff.

The Chair acknowledged Commissioner Laurie Lee and he, along with the Commissioners, thanked Commissioner Lee for serving 8 years on the Real Estate Commission and for her invaluable work on the Condominium Review Committee. Commissioner Lee stated it was a privilege and honor to work with all Commissioners and staff.

The Chair informed the Commission that P. Denise La Costa was confirmed by the Senate through June 30, 2024, and new Commissioners Jennifer Andrews and Audrey Abe were confirmed through June 30, 2025. Chair Pang recognized Jennifer Andrews who was in attendance and welcomed her to the Commission. Ms. Andrews shared an overview of her resume and stated she looked forward to serving on the Commission.

Executive Officer's Report:

The Commission shall afford all interested persons an opportunity to submit data, views, or arguments, in writing, on any agenda item and shall provide all interested parties an opportunity to present oral testimony on an agenda item subject to the conditions set forth in section 16-99-83, HAR. The Commission may remove any person or persons, who willfully disrupt a meeting to prevent and compromise the conduct of the meeting in accordance with section 92-3, HRS. Each speaker will be limited to a five-minute time period pursuant with section 16-99-83 (a)(5), HAR.

Executive Officer Ino thanked Commissioners Klein and Lee for their invaluable service while on the Commission and virtually presented them with certificates and letters from the branch and department.

Commissioner Klein felt this was a good course as it presented a good understanding of commercial real estate. Commissioner Pang echoed Commissioner Klein's statement and added this course will be useful as training is normally centered around residential real estate. Mr. Andaya informed the Commission that this was a basic course and that he will be introducing a more advanced course in the future. Commissioner Pang requested a disclaimer be added that informs attendees the course relates solely to commercial real estate.

Upon a motion by Commissioner Klein, seconded by Commissioner Kyono, it was voted on and unanimously carried to approve "Introduction to Commercial Leasing: A Tenant's Perspective", as a 3-credit hour continuing education course, under the course category Contracts, Real Estate Law, Property Management, Other: Commercial Leases.

Continuing Education Core Course – Final Version, Core A 2021-2022, "Fair Play in Fair Housing: It's Not a Game, It's the Law!"

Everett Kaneshige was present and informed the Commission that he received feedback from attendees who attended Train the Trainer on June 24, 2021, and stated he would be revising a couple of slides in the final version of Core A 2021-2022. He added Core A drives home the timely topic of the history of fair housing and includes resource material for attendees.

Commissioner Pang asked when the final course would be available. Senior Real Estate Specialist Fujimura responded July 1, 2021, was the target date. Commissioner Yamane thanked Mr. Kaneshige and Senior Specialist Fujimura for their hard work and excellent job on this course.

Commissioner Pang moved to approve the final version of Core A 2021-2022, "Fair Play in Fair Housing: It's Not a Game, It's the Law!". Commissioner Lee seconded the motion. The motion was voted on and unanimously carried by roll call vote.

Administration of Examinations – Remote Proctoring Statistics 5/1/21-5/31/21

PSI submitted the monthly proctoring statistics as requested.

Program of Work, FY21 Annual Report, Quarterly Bulletin, and School Files Request for Quotes – Real Estate Commission Bulletin

Senior Specialist Fujimura informed the Commission that 3 bids were received in response to the request for quotes for the two-year contract for the printing and mailing of the Real Estate Commission Bulletin. Trade Media Hui was the lowest responsive bidder.

Upon a motion by Commissioner Pang, seconded by Commissioner Kyono, it moved to approve Trade Media Hui for the printing and mailing of the Real Estate Commission Bulletin for the period 7/1/2021 – 6/30/2023. The motion was voted on and unanimously carried by roll call vote.

Real Estate Education Fund Budget and Finance Report – Period Ending December 31, 2020

Upon a motion by Commissioner Lee, seconded by Commissioner Yamane, it was moved to accept the Real Estate Education Fund Budget and Finance Report for the period ending December 31, 2020. The motion was voted on and unanimously carried by roll call vote.

Licensing – Applications:

The Executive Officer informed the Commissioners that the information provided to the Commissioners is related only to the issue that is before the Commission for consideration. The other materials submitted are available for the Commissioners review should they desire to review it. If the applicants have an issue, which is personal in nature, they have the right to request that their application be considered in executive session.

Licensing – Applications:

### Pedro W. Rubio

After review of the information provided by the applicant, Commissioner Pang moved to approve the real estate salesperson license of Pedro W. Rubio. Commissioner Kyono seconded the motion. The motion was voted on and unanimously carried by roll call vote.

#### Jenai Hart

The Chair informed the Commission the request of Jenai Hart was withdrawn as staff was able to handle this request as permitted by a prior staff delegation.

Chapter 91, HRS, Adjudicatory Matters: The Chair called for a recess from the meeting at 9:50 a.m., to discuss and deliberate on the following adjudicatory matters, pursuant to Chapter 91, HRS:

In the Matter of the Real Estate Salesperson's License of Manuel M. Fernandez: REC 2018-227-L

At 10:02 a.m. the floor was opened for the parties to present their oral arguments.

Chair Pang commenced the proceedings and explained that each party would be given five (5) minutes to present their oral arguments and each would be given an opportunity for rebuttal.

John Hassler, Esq., presented oral arguments on behalf of the Regulated Industries Complaints Office (RICO), Department of Commerce and Consumer Affairs, State of Hawaii ("Petitioner").

Mr. Hassler recapped RICO's allegations that charged Mr. Fernandez with violating HRS §§436B-19(12), 436B-19(17), 436B-19(1), and 436B-19(14). Although the Office of Administration's Hearings Officer found the evidence was insufficient to prove violations of HRS §§436B-19(1) and (14), Mr. Hassler reaffirmed the position that Mr. Fernandez violated all charges and asked the Commission to consider whether Mr. Fernandez's DUI conviction is related to his profession. Mr. Hassler went over similar cases and Commission's previous rulings.

Manuel Fernandez ("Respondent") addressed the Commission and presented oral arguments.

Mr. Fernandez stated that although he was not an attorney his response is that a DUI does not hinder his ability to service prospective clients. He believes fiduciary duties as a real estate salesperson is foremost and stated the five (5) main duties of the profession as he learned in a prelicensing course are accounting, confidentiality, full disclosure, honesty, and obedience.

Mr. Fernandez stated that he was not trying to minimize his actions but a DUI does not hinder his duties, qualifications, and functions as a real estate agent. He added that he received his degree in accounting and no longer drinks alcohol. He asked the Commission to allow him to pay the fine as noted in the Commission's Final Order and allow him to keep his real estate license.

Mr. Hassler stated that due to connectivity issues, he did not hear all of Mr. Fernandez's testimony. Mr. Hassler began his rebuttal and stated that although fiduciary duties are an important component of licensure, licensing laws are specific and RICO asks the Commission to reaffirm their findings. RICO is not recommending any change but stands on its ruling that a DUI is related to the duties of a real estate licensee.

Mr. Fernandez began his rebuttal and stated he agreed that a DUI does reflect the integrity of the profession but that he is not on any billboard and is not practicing real estate yet. He added that he would like the opportunity to represent the profession and to show that he can be responsible and reliable.

Chair Pang thanked the parties and informed them the Commission would confer with counsel. At 10:21 a.m., Mr. Hassler and Mr. Fernandez left the virtual meeting.

Upon a motion by Commissioner Pang, seconded by Commissioner Klein, it was voted on and unanimously carried by roll call vote to revise the Hearings Officer's conclusions of law and Recommended Order, and issue a Commission's Final Order in accordance with its discussion and deliberations.

Upon a motion by Commissioner Pang, seconded by Commissioner Kyono, it was voted on and unanimously carried by roll call vote to approve the Commission's Final Order.
