The agenda for this meeting was filed with the Office of the Lieutenant Governor, as required by section 92-7(b), Hawaii Revised Statutes ("HRS").

A brief video regarding the virtual board meeting, including meeting procedures and helpful information regarding how members of the public can participate and interact with the board during the meeting, was played.

Call to Order: The Chair called the meeting to order at 9:03 a.m., at which time quorum was established by roll call.

Chair's Report: The Chair announced that the Commission may move into executive session to consider and evaluate personal information relating to individuals applying for licensure in accordance with section 92-5(a)(1), HRS, and/or to consult with the Commission's attorney on questions and issues pertaining to the Commission's powers, duties, privileges, immunities, and liabilities in accordance with section 92-5(a)(4), HRS.

Chair Pang introduced and welcomed new Commissioners Audrey Abe and Jennifer Andrews.

The Chair informed the Commission that he attended the 2021 ARELLO Mid-Year meeting in San Antonio, Texas, that it was well-attended and that they did an excellent job. The topics of love letters and heat of the market were discussed and he would share more about material covered in his forthcoming report.

Laws and Rules Review Committee

Program of Work and Budget, FY 22-23

Upon a motion by Commissioner La Costa, seconded by Commissioner Kyono, it was voted on and unanimously carried by roll call vote to approve the Law and Rules Review Committee Program of Work and Budget, FY22-23.

Condominium Review Committee

Upon a motion by Commissioner La Costa, seconded by Commissioner Love, it was voted on and unanimously carried by roll call vote to approve the Condominium Review Committee Program of Work and Budget, FY22-23.

Condominium Laws and Education – Approval of Basics Condo Course

Condominium Specialist Stone informed the Commission that this new course is aimed to educate owners on the basics of condominium living and would be offered to owners of condominium associations registered with the Real Estate Branch.

Upon a motion by Commissioner Pang, seconded by Commissioner Kyono, it was voted on and unanimously carried by roll call vote to approve a procured event awarded to CAI Hawaii to offer a basics condominium education course to unit owners of condominium associations registered with the Real Estate Branch.

Request for Informal Non-binding Interpretation regarding HRS §514B-51(b)(3)

Commissioner Senter disclosed that she was formerly employed by Imanaka Asato. Her current employer has business transactions with Imanaka Asato but she could make an unbiased decision in this matter.

Sarah E. Kukino, Esq. of Imanaka Asato was present and spoke on behalf of the developer, Kauai Hale, Inc. Commissioner Love stated that he agreed with the Real Estate Branch staff recommendation in this case that the investors are exempt from condominium registration due to the bulk sale exception.

Upon a motion by Commissioner Pang, seconded by Commissioner Love, it was voted on and unanimously carried by roll call vote that based upon the specific facts as presented, the Commission issues the following informal non-binding interpretation that the investors are exempt from the registration requirements of HRS §514B-51(a) due to the exception contained in HRS §514B-51(b)(3).

Carolyn M. Lawpaugh Lachance

After review of the information provided by the applicant, Commissioner Pang moved to approve the real estate salesperson license of Carolyn M. Lawpaugh Lachance. Commissioner La Costa seconded the motion. The motion was voted on and unanimously carried by roll call vote.

Aaron Wai Dong Mo

Mr. Mo was present via video conference and was asked if he wished to have his request for preliminary decision for real estate salesperson considered in executive session. He declined the offer.

Mr. Mo stated that he knows his past looks bad, regrets his actions, and is now unable to pursue any job in the healthcare field. Commissioner Yamane inquired if the applicant received \$500, as the applicant stated in his letter to the Commission, for each parcel of mail he received for a total of \$3500. Mr. Mo stated that was correct. Commissioner Yamane then referred to the applicant's statement "I want to find a career that I would like to have and being a realtor might be it", and asked if the applicant looked into the responsibilities of a real estate salesperson. Mr. Mo responded that he has not looked into the profession completely but felt like he might enjoy it.

Commissioner La Costa asked the applicant about his job since his release. Mr. Mo responded that he has been employed at Domino's and worked his way up to part time manager and driver. Commissioner La Costa inquired if the applicant was planning to attend school. Mr. Mo answered that he wanted to become a respiratory therapist but is now unable to due to his conviction.

Upon a motion by Commissioner Pang, seconded by Commissioner Ginoza, it was unanimously carried by roll call vote to take the matter under advisement.

Jeffrey Thomas Onderko

Commissioner La Costa disclosed she knew the applicant and that she could make an unbiased decision in this matter.

Mr. Onderko was present via video conference and was asked if he wished to have his request to remove conditions on his real estate broker license considered in executive session. He declined the offer.

Mr. Onderko stated the civil matter regarding his other business was now complete. He added he believed the matter was not relevant to his real estate broker license.

Commissioner Pang informed the Commission that the applicant satisfied all conditions.

After review of the information and testimony presented by the applicant, Commissioner Pang moved to remove the conditions on the real estate license of Jeffrey Thomas Onderko. Commissioner Love seconded the motion. The motion was voted on and unanimously carried by roll call vote.
