COVID-19 AND THE REAL ESTATE BRANCH

As of this publication, the Covid-19 pandemic continues its hold on life as we once knew it and is creating a myriad of responses and opportunities for those willing to face a new world. Life at the Real Estate Branch, DCCA, continues on its Covid-19 path: employees teleworking from home, rotating into and out of the office, vaccination verifications required for all who enter the building, social distancing, and mask-wearing. Meetings and hearings are continuing virtually via Zoom and/or Microsoft Teams. Paperwork is being processed, in some instances, on a delayed basis, but for the most part, in a timely manner.

The Real Estate Commission continues to meet once a month, usually on the last Friday of the month, but virtually via Zoom. The Commission's three standing committees are not meeting separately at this time, but their agenda items are integrated into the Commission meeting agenda.

Be advised: All visitors seeking to enter state facilities must show identification and proof of full vaccination against COVID-19, or for those who are partially vaccinated or unvaccinated, must show proof of a negative test result taken within the last 72 hours. If visitors cannot show proof of either, they may not enter the premises.

Due to COVID-19 and for the health and safety of both consumers and staff, limited staff will be available for walk-in services at the Department of Commerce and Consumer Affairs offices during the hours between 7:45 a.m. to 4:30 p.m., Monday through Friday. Please observe proper safety protocols (e.g., face covering and social distancing) when visiting.

The new Ho'ala licensing and education systems continue to be tweaked on their slow journey to providing the necessary information and services for licensees, staff, prelicense schools, continuing education providers, etc. Mahalo for your continued patience while these bugs are addressed.

What Are These Bugs?

Education System

If you are unable to find an attendee's email and the attendee swears they created an account, have the attendee use their credentials to log into their MyPVL account using the following url: <https://mypvl.dcca.hawaii.gov>.

99% of the time this will rectify the issue. If difficulties are still encountered, please email us at roster@dcca.hawaii.gov with the student's email address, name, completion date, and course number so we can manually add it.

CE Courses Credited to the Incorrect Biennium: This has been FIXED.

Instructors Not Populating When Scheduling a Course: Not all the instructor information was carried over from the old system. If you don't see an instructor's name in the drop-down list, please add the instructor's name. You may now do so, as previously an error message appeared. This applies to both Prelicense and CE instructors.

CE Course Completion Certificates: This has been FIXED. CE course completion certificates are now populating with the course completion date.

Prelicense Student Login Instructions: Have students register for an account by using the following url: <https://mypvl.dcca.hawaii.gov>.

After registering, the student MUST login with their newly created credentials. They should be brought to a screen that says "0" linked licenses.

Listed below are the Education System issues still being addressed.

1. Ensuring that the CE Providers View of licensee's CE data in the CE Portal and the student's view in their MyPVL account is reflecting what we see in the database. Our database shows make-ups, course type, # of credits, all of which we have heard are sometimes missing in the CE Provider and student views.
2. If a licensee upgrades from RS to RB, the CE history is not being reflected under the new RB license number. Currently, if a student wants to view their CEs taken as an RS and they are now a broker, they would need to click on their RS license in their MyPVL account.
3. CE Providers unable to add attendees who took the same course 2 biennia ago.

PSI Testing: PSI has informed the Prelicense Schools that exam testing at the Honoka'a and Maui sites require proof of vaccination or a Covid-19 test within 7 DAYS of sitting for the

license exam. If the proof of vaccination or a Covid-19 test within 7 days of testing is not presented, the candidate will be turned away.

As always, please continue to alert staff as to any glitches, anomalies, errors, and/or issues that come to your attention while working with the Education System.



USE MYPVL ACCOUNT

Create an account directly through <https://mypvl.dcca.hawaii.gov>

If the user creates an account using this URL, there is no need for them to login. The students that require the extra login are either using the following url <https://myce.dcca.hawaii.gov> or some other eHawaii.gov site (some have pre-existing accounts if they used other state services that required an eHawaii.gov account).

Please have students use MyPVL to create an account to avoid their account not being found.



CE COURSE MONITORING

When offering “remote-live” CE courses, please ensure that there is adequate monitoring provided of the attendees. The instructor may be too pre-occupied with teaching the course and handling break-out groups, responding to questions, etc. and is not in the position of monitoring attendees. Some providers have strict, clear-cut requirements for attendees, e.g. they must be on-camera for the entire duration of the course, and may not “disappear” at any point during the presentation. The instructor may not be able to actually monitor this requirement. According to Hawaii Administrative Rules (“HAR”) §16-99-112(e) “For any course attended by more than fifty students, the provider shall provide at least one additional individual other than the instructor to administer the course offering, including but not limited to keeping records of attendance, preparing and distributing certificates, and assuring that physical facilities meet the requirements of this subchapter.”

While the above administrative rule may not address current reality in offering and monitoring a CE course, please be cognizant of monitoring all attendees during the course, so the appropriate course credit may be issued.



DID YOU KNOW >>> ?

If you are a real estate salesperson who would like to be a real estate broker, you may request your principal broker or broker-in-charge to complete the Experience Certification Statement (“ECS”) and you may hold the ECS until such time you submit the Broker Experience Certificate application. This may protect the salesperson from a situation where the principal broker is unable to complete an ECS due to unexpected circumstances. There is no specified time stated in the real estate licensing laws and rules as to the age of the ECS upon submission.

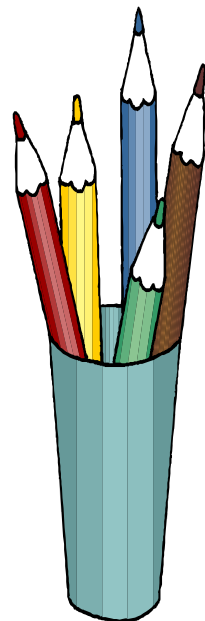
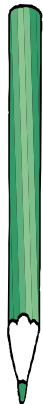
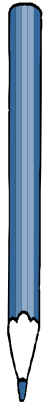
