| Call to Order: | The Chair called the meeting to order at 9:07 a.m., at which time quorum was established by roll call.  |

Chair's Report: The Chair announced that the Commission may move into executive session to consider and evaluate personal information relating to individuals applying for licensure in accordance with section 92-5(a)(1), HRS, and/or to consult with the Commission's attorney on questions and issues pertaining to the Commission's powers, duties, privileges, immunities, and liabilities in accordance with section 92-5(a)(4), HRS.

Executive Officer's The Commission shall afford all interested persons an opportunity to submit data, views, or arguments, in writing, on any agenda item and shall provide all interested parties an opportunity to present oral testimony on an agenda item subject to the conditions set forth in section 16-99-83, HAR. The Commission may remove any person or persons, who willfully disrupt a meeting to prevent and compromise the conduct of the meeting in accordance with section 92-3, HRS. Each speaker will be limited to a five-minute time period pursuant with section 16-99-83 (a)(5), HAR.

Supervising Executive Officer (SEO) Fujitani announced that Senior Condominium Specialist Carole Richelieu will be retiring from the Real Estate Branch at the end of the year. He recognized and thanked her for her hard work and years of service. Chair Pang thanked Specialist Richelieu and virtually displayed a certificate of appreciation from the Commission.

## Act 220 Relating to Sunshine Law Boards

SEO Fujitani announced that unless the Governor rescinds or postpones amendments to Act 220, effective January 2022, boards and commissions shall continue with virtual meetings, however, arrangements must be made to facilitate one (1) in-person location where the public may attend the meeting. In addition, Commissioners attending meetings virtually must announce and identify any person(s) who are present in their location.

### **Minutes of Previous Meeting**

Upon a motion by Commissioner Kyono, seconded by Commissioner Andrews, it was voted on and unanimously carried by roll call vote to accept the minutes of the November 19, 2021, meeting.

Licensing – Upon a motion by Commissioner Yamane, seconded by Commissioner Kyono, Ratification: it was voted on and unanimously carried by roll call vote to ratify the December 17, 2021, Approved Applications List.

Upon a motion by Commissioner Pang, seconded by Commissioner Yamane, it was unanimously carried by roll call vote to approve the real estate salesperson license of Leopoldo Alcides Schneidewind.

#### **Samuel James Campiformio**

Mr. Campiformio was not in attendance when the Commission reached this agenda item. Real Estate Specialist Jackson stated that Mr. Campiformio previously informed her that he would like his application to be considered in executive session.

Upon a motion by Commissioner Pang, seconded by Commissioner Ginoza, it was unanimously carried by roll call vote to take the matter under advisement.

#### Jason Mitchell Real Estate Hawaii LLC dba JMG Real Estate Hawaii

Mr. Megazar Juntilla was present via teleconference and stated that he was appearing for JMG Real Estate Hawaii as he would be the principal broker if the license was approved. He was asked if he wished to have this application for limited liability company considered in executive session. He declined the offer.

Mr. Juntilla stated that he was currently the principal broker of Ewa Point Realty and that he was approached by national company, Jason Mitchell Group (JMG), to become their principal broker. Mr. Juntilla stated that he has been a sole proprietor for 20 years and that he intended to take the position with JMG.

Upon a motion by Commissioner Yamane, seconded by Commissioner Pang, it was unanimously carried by roll call vote to take the matter under advisement.

#### Manuel Fernandez

Mr. Fernandez was present via teleconference and was asked if he wished to have his request to remove conditions on his real estate salesperson license considered in executive session. He declined the offer.

Mr. Fernandez stated that he completed the terms of his conditional license and thanked the Commission.

Upon a motion by Commissioner Pang, seconded by Commissioner La Costa, it was unanimously carried by roll call vote to take the matter under advisement.

#### Sandy Xay

Ms. Xay was present via teleconference and was asked if she wished to have her request to remove conditions on her real estate broker license considered in executive session. She declined the offer.

Ms. Xay stated that her bankruptcy was complete and thanked the Commission for the opportunity.

After review of the information and testimony presented by the applicant, Commissioner Pang moved to remove the conditions on the real estate broker license of Sandy Xay. Commissioner Andrews seconded the motion. The motion was voted on and unanimously carried by roll call vote.

Executive Session: Upon a motion by Commissioner Pang, seconded by Commissioner Ginoza, it was voted on and unanimously carried by roll call vote to enter into executive session, pursuant to section 92-5(a) (1), HRS, "To consider and evaluate personal information relating to individuals applying for professional or vocational licenses cited in section 26-9 or both.", and/or section 92-5(a)(8), HRS, "To deliberate or make a decision upon a matter that requires the consideration of information that must be kept confidential pursuant to a state or federal law, or a court order." and/or section 92-5(a)(4), HRS, "To consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities."

Upon a motion by Commissioner Pang, seconded by Commissioner La Costa, it was voted on and unanimously carried by roll call vote to move out of executive session.

#### Samuel Campiformio

After due consideration of information submitted and oral testimony provided by the applicant, Commissioner Andrews moved to deny the Restoration Application – Real Estate Broker and Application for License – Real Estate Sole Proprietor of Samuel Campiformio, basing the decision on the following grounds of the Hawaii Revised Statutes ("HRS"), which find factual support in the records and files of his application:

"§436B-19 **Grounds for refusal to renew, reinstate or restore and for revocation, suspension, denial, or condition of licenses.** In addition to any other acts or conditions provided by law, the licensing authority may refuse to renew, reinstate or restore or may deny, revoke, suspend, or condition in any manner, any license for any one or more of the following acts or conditions on the part of the licensee or the applicant thereof:

(12) Failure to comply, observe, or adhere to any law in a manner such that the licensing authority deems the applicant or holder to be an unfit or improper person to hold a license;

(14) Criminal Conviction, whether by nolo contendere or otherwise, of a penal crime directly related to the qualifications, functions, or duties of the licensed profession or vocation;..."

Commissioner Kyono seconded the motion. Commissioners Andrews, Kyono, Abe, Ginoza, La Costa, Pang and Yamane voted aye. Commissioner Senter voted nay. Commissioner Love abstained from the vote. The motion was carried by roll call vote.

#### Jason Mitchell Real Estate Hawaii LLC dba JMG Real Estate Hawaii

After review of the information and testimony provided, Commissioner La Costa moved to deny the real estate limited liability company license of Jason Mitchell Real Estate Hawaii LLC dba JMG Real Estate Hawaii, basing the decision on the following grounds of the Hawaii Revised Statutes ("HRS") which find factual support in the records and files of this application:

Matters:

#### "HRS § 467-9 License, registration, certificate, and applications.

- (b) Unless approved by the commission, no real estate broker's license shall be issued under or changed to any trade name, corporate name, or partnership name which contains the name, part of the name, initials, or nickname of
- (1) An unlicensed person;
- (2) A real estate salesperson; or
- (3) A real estate broker whose real estate license is not associated with or employed by the subject real estate broker applicant

A real estate broker's license name includes any trade name approved by the commission."

Commissioner Yamane seconded the motion. The motion was voted on and unanimously carried by roll call vote.

#### **Manuel Fernandez**

After review of the information and testimony presented by the applicant, Commissioner La Costa moved to remove the conditions on the real estate salesperson license of Manuel Fernandez. Commissioner Abe seconded the motion. The motion was voted on and unanimously carried by roll call vote.

Chair Pang recognized Megazar Juntilla who had his virtual hand raised. Mr. Juntilla asked for clarification of HRS § 467-9(b), the basis for denial of the real estate limited liability company license of Jason Mitchell Real Estate Hawaii LLC dba JMG Real Estate Hawaii. Chair Pang recited the statute for the applicant. Mr. Juntilla stated that he believed they may have received incorrect information and incorrectly interpreted the rules. Real Estate Specialist Endo reiterated that one must be a licensed Hawaii real estate broker to use their name in a Hawaii real estate company.

Chapter 91, HRS, Adjudicatory The Chair called for a recess from the meeting at 11:19 a.m., to discuss and deliberate on the following adjudicatory matters, pursuant to Chapter 91, HRS:

In the Matter of the Real Estate Brokers' Licenses of Richard P. Pascua, Sr., Kama`aina Realty LLC, and XDITTO LLC: REC 2021-76-L

Upon a motion by Commissioner Pang, seconded by Commissioner La Costa, it was voted on and unanimously carried by roll call vote to accept the settlement agreement.

# In the Matter of the Real Estate Broker's License of The Honolulu Group, Ltd., doing business as RE/MAX Honolulu: REC 2020-439-L

Upon a motion by Commissioner Pang, seconded by Commissioner La Costa, it was voted on and unanimously carried by roll call vote to accept the settlement agreement.
