THE PANDEMIC LIVES ON

With 2021 just behind us, what's in store for 2022? More of the same? Less? It's anyone's guess. For now, the DCCA will continue to require identification and proof of full vaccination against Covid-19. For those who are partially vaccinated or unvaccinated, the person must show proof of a negative test result taken within the last 72 hours. No proof for either? Then the person may not enter the DCCA. For those entering DCCA, wear your mask and social distance.

The monthly Real Estate Commission meetings will continue to be held virtually via Zoom, on the last Friday of the month. The agendas for the Commission's three standing committees (Laws and Rules Review Committee, Condominium Review Committee, Education Review Committee) will continue to be integrated into the agenda for the monthly Commission meeting. Links to join the meeting will be distributed to attendees prior to the meeting.

The Real Estate Branch personnel will continue teleworking from home and being in the office on a rotating basis.

IT'S AN EVEN-NUMBERED YEAR ... AND THAT MEANS ...

It's RENEWAL YEAR!!!

20 hours of CE must be completed, preferably by the November 30th renewal deadline. The 20 hours is comprised of the two core courses, 2021-2022, Parts A and B. BOTH parts must be completed in order to receive core course credit of 6 credit hours. That leaves 14 hours of continuing education elective courses which must be completed by the renewal deadline. If not completed by the November 30th renewal deadline, licensees jeopardize their license

status come January 1, 2023. The November 30th deadline provides enough time for processing of the renewal applications.

- 2. Renewal notification to each licensee will be mailed in October 2022.
- 3. If a "YES" answer is included on the renewal application, the licensee MUST FILE A HARDCOPY license renewal application.
- 4. Principal brokers and brokers-in-charge must complete their license renewal and continuing education requirements BEFORE ANY ASSOCIATED LICENSEE'S RENEWAL WILL BE PROCESSED. The real estate licenses for the brokerage and all branch offices must also be renewed prior to the approval of the license renewals for all associated licensees.
- 5. A newly licensed real estate SALESPERSON receiving their license in 2022 does NOT have to complete the required 20 hours of continuing education to renew their license current and active for the 2023-2024 biennium. THIS DOES NOT APPLY TO NEWLY LICENSED REAL ESTATE BROKERS who received their license in 2022.
- 6. Core B 2021-2022 will be available about the end of June, first week of July 2022. The topic will be "Misrepresentation."
- CE HISTORY: A licensee may access their CE history by logging on to their MyPVL account – <u>https://mypvl.dcca.hawaii.gov</u>. Once logged into their MyPVL account, click on the license number. Click on the "RECE" tab and click "View CE History." All courses completed and reported to the Commission may be viewed.
- Prelicense Schools, Prelicense Instructors, Guest Lecturers, Continuing Education Providers, Continuing Education courses: Please re-register/re-certify by November 30, 2022. The status of the school, instructor, guest lecturer, CE Provider, and CE courses is valid through 12/31/2022.
- 9. Always check your MyPVL account for license status: https://mypyl.dcca.hawaii.gov.
- 10. DO NOT CONFUSE your REALTOR® board membership with your real estate license. The National Association of REALTORS® ("NAR") required the completion of an "ethics" course by December 31, 2021. This is NOT a requirement to maintain/renew your real estate license. Licensees who are board members must check with their local board to determine if the ethics course completed is acceptable. Do not call the Real Estate Branch regarding the ethics course requirement. CE credit to renew a real estate license may be given to a licensee completing an ethics course, as long as that ethics course was approved by the Commission and is offered by a CE Provider, also approved by the Commission.

DID YOU KNOW?

As of February 1, 2022, there are 303 days to the license renewal deadline of November 30, 2022. Don't procrastinate. Plan ahead.



2022 INSTRUCTORS DEVELOPMENT WORKSHOP (IDW)

A Commission-sponsored Instructors Development Workshop ("IDW") will be offered during the spring of 2022. We are targeting April 2022, subject to change. Theresa Barnabei will once again be the presenter. The topic will NOT be a repeat of the previous two IDWs, so please stay tuned for future announcements and plan on registering for the event. Remember, all prelicense instructors and CE instructors must complete an IDW prior to teaching. By completing this upcoming IDW, the prelicense instructor and CE instructor will be able to teach after completing the IDW AND in the 2023-2024 biennium.



EDUCATION SYSTEM UPDATE

Mahalo to those of you who have reported glitches with the new Education System. We continue to work with the developer to get the system operating as it should. This is the RENEWAL YEAR for real estate licensees, so we are painfully aware that any glitches need to be addressed before the wave of renewals starts.

Listed below are the Education System issues still being addressed. (This was reported in the October issue of School Files and include the items which still need to be fixed.)

- Ensuring that the CE Providers' view of licensee's CE data in the CE Portal and the student's view in their MyPVL account is reflecting what we see in the database. Our database shows make-ups, course type, # of credits, all of which we have heard are sometimes missing in the CE Provider and student views.
- 2. If a licensee upgrades from RS to RB, the CE history is not being reflected under the new RB license number. Currently, if a licensee wants to view their CEs taken as an RS and they are now a broker, they must click on their RS license in their MyPVL account.
- 3. CE Providers unable to add attendees who took the same course 2 biennia ago.

Some other issues that CE Providers and Prelicense Schools have flagged, and which have been reported to the developer but need to be fixed are as follows:

1. The verbiage on the certificate is wrong. It says use if reactivating your license after 10/31/20 when it should be 12/31/20.

- 2. When sorting by Course Dates (for prelicensing and continuing education courses), the date is sorted by month and does not indicate the year.
- 3. For continuing education courses, when a course is submitted (all attendees submitted together), the status remains as "open," rather than "submitted."
- 4. When a CE Provider looks up a licensee using the CE Status drop down within the portal, there are RB options (sole, entity, etc.). Since CE Providers cannot distinguish if the licensee is a sole proprietor, entity or a real estate broker-salesperson, we have received reports that the licensee cannot be found. We have asked the developer to condense the list to only one "RB" option. Since licensed Electrician and Plumbers also use the Education Portal, the other licensing types will remain as an option. We have also asked that the list of license types be alphabetized.
- 5. For continuing education courses, there appears to be no option to delete courses once the course date has expired (even if there are no attendees added). If you need to delete a course, you will need to call (808) 586-2643 and ask to speak to Nohe or Charisa.
- 6. After individually submitting an attendee who has completed a course, the list of attendees re-organizes and you cannot continue submitting where you left off. We are currently trying to find a solution for this; however, in the meantime, if you sort by "Action," all the individuals who still need to be submitted will appear at the top. So, hopefully that helps until this issue is resolved.


