## UPDATES - EDUCATION SYSTEM

The new Education System is STILL being tweaked by the system developer. Please continue to notify the Real Estate Branch if you come across any anomalies during the use of the Education System. The issues below are now corrected.

1. CE Providers are now able to add attendees who took the same course 2 biennia ago for CE credit. Note: Hawaii Administrative Rules, Section 16-99-95 states, “. . . a licensee shall not take a continuing education course for which the licensee has already received a certificate within two consecutive biennia.”
2. If a licensee upgrades from RS to RB, the CE history is now being reflected under the new RB license number.

### **Issues that CE Providers and Prelicense Schools have reported to the developer and need to be fixed are as follows:**

1. The CE Providers' view of licensee's CE data in the CE Portal and the student's view in their MyPVL account does not reflect the Education System database. The Education System shows make-ups, course type, # of credits, all of which should also be in the CE Provider and licensee views.
2. The verbiage on the course certificate is incorrect. It says use if reactivating your license after 10/31/20 when it should be 12/31/20.
3. When sorting by Course Dates (for prelicensing and continuing education courses), the date is sorted by month and does not indicate the year.
4. For continuing education courses, when a course is submitted (all attendees submitted together), the status remains as "open," rather than "submitted."

5. When a CE Provider looks up a licensee using the CE Status drop down within the portal, there are RB options (sole, entity, etc.). Since CE Providers cannot distinguish if the licensee is a sole proprietor, entity, real estate broker or a real estate broker-salesperson, we have received reports that the licensee cannot be found. We have asked the developer to condense the list to only one “RB” option. Since licensed Electrician and Plumbers also use the Education Portal, the other licensing types will remain as an option. We have also asked that the list of license types be alphabetized.
6. For continuing education courses, there appears to be no option to delete courses once the course date has expired (even if there are no attendees added). If you need to delete a course, you will need to call (808) 586-2643 and ask to speak to Nohe or Charisa. **This will remain an administrative function.**
7. After individually submitting an attendee who has completed a course, the list of attendees re-organizes and you cannot continue submitting where you left off. We are currently trying to find a solution for this; however, in the meantime, if you sort by “Action,” all the individuals who still need to be submitted will appear at the top. So, hopefully that helps until this issue is resolved.
8. PB’s are unable to view their associated licensee’s CE History.



## **PANDEMIC PROTOCOL**

Customers and vendors of DCCA will no longer be asked to provide proof of vaccination or negative Covid-19 testing when doing business at DCCA. Indoor mask-wearing is encouraged but not mandatory.

The monthly Real Estate Commission and standing committee meetings will continue to be combined into the Commission meeting, which is normally held the last Friday of the month. The meeting will continue to be held via Zoom.

DCCA staff may continue to work a rotating schedule of being in the office and teleworking. DCCA divisions will have different schedules, so please contact the specific division for information.

## **RE-REGISTER/RE-CERTIFY EARLY**

ALL prelicense schools, prelicense instructors, guest lecturers, continuing education providers, and continuing education courses (elective and ARELLO- and Nationally-certified) must re-register/re-certify by December 31, 2022. HOWEVER, you may begin this process in October 2022, and you are encouraged to do so, to avoid the renewal crunch at the end of the year. Re-registering/re-certifying early will ensure the prelicense schools, prelicense instructors, guest lecturers, continuing education providers and continuing education courses are current and valid for the 2023-2024 biennium come January 1, 2023.

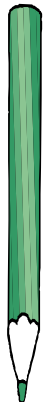
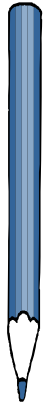

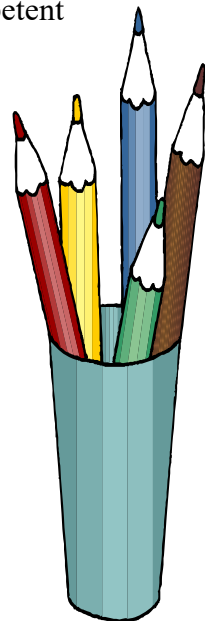
