A brief video regarding the virtual board meeting, including meeting procedures and helpful information regarding how members of the public can participate and

Call to Order:

The Chair called the meeting to order at 9:07 a.m., at which time quorum was established by roll call.

This meeting had a physical location and a virtual location. Chair Yamane, Supervising Executive Officer Fujitani, and Executive Officer Ino were in attendance in-person at the physical location. All other Commissioners were in attendance virtually and confirmed that they were present and alone.

Chair Yamane announced that Commissioners Sean Ginoza, Russell Kyono, and John Love were confirmed for their second terms and thanked them for returning to serve on the Commission.

Chair Yamane noted that this was a renewal year and asked the Commissioners to remind licensees of the November 30, 2022, deadline. He thanked the Real Estate Branch staff for their hard work.

Chair's Report:

The Chair announced that the Commission may move into executive session to consider and evaluate personal information relating to individuals applying for licensure in accordance with section 92-5(a)(1), HRS, and/or to consult with the Commission's attorney on questions and issues pertaining to the Commission's powers, duties, privileges, immunities, and liabilities in accordance with section 92-5(a)(4), HRS.

The Commission shall afford all interested persons an opportunity to submit data, views, or arguments, in writing, on any agenda item and shall provide all interested parties an opportunity to present oral testimony on an agenda item subject to the conditions set forth in section 16-99-83, HAR. The Commission may remove any person or persons, who willfully disrupt a meeting to prevent and compromise the conduct of the meeting in accordance with section 92-3, HRS. Each speaker will be limited to a five-minute time period pursuant with section 16-99-83 (a)(5), HAR.

Commissioner Yamane stated that PSI notified the Real Estate Branch and submitted information that Mr. Graziano breached the security agreement by utilizing a cellular phone during his real estate examination. Mr. Graziano apologized to the Commission, the PSI proctor, and those in attendance, and confirmed that he did use his phone during the PSI exam to help him with 5 questions. He stated that he put in a lot of hard work and asked the Commission for a second chance.

Commissioner La Costa asked Mr. Graziano if he engaged in any real estate business to date. Mr. Graziano responded he has not. He added that he took the real estate salesperson exam a total of 4 times.

Upon a motion by Commissioner Yamane, seconded by Commissioner Andrews, it was moved and unanimously carried by roll call vote to take the matter under advisement.

Administration of Examinations – Remote Proctoring Statistics 7/1/22 - 7/31/22

PSI submitted the monthly proctoring statistics as requested.

Ad Hoc Committee on Education (ACE) - Current member list

Upon a motion by Commissioner La Costa, seconded by Commissioner Andrews, it was moved and unanimously carried by roll call vote to approve the Ad Hoc Committee on Education (ACE) current member list.

Annual Report, Quarterly Bulletin, and School Files

The August 2022 Real Estate Commission Bulletin has been distributed.

Licensing – Applications:

The Chair informed the Commissioners that the information provided to the Commissioners is related only to the issue that is before the Commission for consideration. The other materials submitted are available for the Commissioners review should they desire to review it. If the applicants have an issue, which is personal in nature, they have the right to request that their application be considered in executive session.

# **Darilyn Lee Thomas**

Ms. Thomas was present via teleconference and was asked if she wished to have her application for real estate salesperson considered in executive session. She declined the offer.

Ms. Thomas stated that she answered a few questions incorrectly on her salesperson application because she believed only upcoming charges needed to be disclosed and not charges that occurred 17 years ago.

Commissioner Abe inquired about the applicant's 2021 charge and if terms and conditions were satisfied. Ms. Thomas responded that reckless driving charge occurred in 2019, she has completed the required classes and her court date is scheduled for September 8, 2022.

Upon a motion by Commissioner Yamane, seconded by Commissioner Abe, it was unanimously carried by roll call vote to take the matter under advisement.

## Dallas A. Stone

Mr. Stone was present via teleconference and was asked if he wished to have his request for the removal of conditions on his real estate salesperson license considered in executive session. He declined the offer.

Commissioner Andrews recused herself from discussion and voting and left the virtual meeting.

Mr. Stone stated that he was able to complete all fines and conditions within 3 months, and is before the Commission to request to remove the conditions on his real estate salesperson license.

Upon a motion by Commissioner Yamane, seconded by Commissioner Abe, it was unanimously carried by roll call vote to take the matter under advisement.

Commissioner Andrews rejoined the virtual meeting.

**Executive Session:** 

Upon a motion by Commissioner Ginoza, seconded by Commissioner La Costa, it was voted on and unanimously carried by roll call vote to enter into executive session, pursuant to section 92-5(a)(1), HRS, "To consider and evaluate personal information relating to individuals applying for professional or vocational licenses cited in section 26-9 or both.", and/or section 92-5(a)(8), HRS, "To deliberate or make a decision upon a matter that requires the consideration of information that must be kept confidential pursuant to a state or federal law, or a court order." and/or section 92-5(a)(4), HRS, "To consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities."

Upon a motion by Commissioner Yamane, seconded by Commissioner Senter it was voted on and unanimously carried by roll call vote to move out of executive session.

## **Education Review Committee**

Daniel Graziano – Candidate for Salesperson Examination

Upon a motion by Commissioner La Costa, seconded by Commissioner Kyono, it was voted on and unanimously carried by roll call vote to recommend issuance of a Commission's Proposed Final Order to bar Daniel Graziano from taking any Hawaii real estate licensing exam for a period of 2 years and he will be allowed 60 days from the date of the Proposed Final Order to respond and present oral arguments.

## **Darilyn Lee Thomas**

After review of the information and testimony presented by the applicant, Commissioner Ginoza moved to approve the real estate salesperson license of Darilyn Lee Thomas, with conditions. Commissioner Senter seconded the motion. The motion was voted on and unanimously carried by roll call vote.

The conditional real estate salesperson license is approved for the Applicant, subject to the following conditions:

- 1. That during the term of this conditional license, any violation of the terms shall be grounds for revocation of license.
- That any subsequent criminal conviction whether by nolo contendere or otherwise, of a penal crime directly related to the qualifications, functions or duties of the licensed profession or vocation shall be grounds for revocation of license.
- 3. That failure to provide written notice within 30 days to the licensing authority of any judgment, award, disciplinary sanctions, order, or other determination, which adjudges or finds that the licensee is civilly, criminally, or otherwise liable for any personal injury, property damage or loss caused by the licensee's conduct in the practice of the licensee's profession or vocation shall be grounds for revocation of license.
- 4. That the Applicant shall at all times be associated with and under the direct supervision of a principal broker ("PB") or one or more brokers in charge ("BIC"), for all real estate transactions.
- 5. That the Applicant shall inform the PB, sole proprietor real estate broker, or BIC of a real estate branch office with whom the Applicant associates that the Applicant holds a conditional real estate salesperson license and may only practice pursuant to certain terms of the conditional license. The Applicant shall present to the Applicant's PB, sole proprietor real estate broker, or BIC of a real estate branch office a copy of the Commission-issued conditional letter. The Applicant shall ensure that the PB, sole proprietor real estate broker, or BIC of a real estate branch office acknowledges the terms of the Applicant's conditional license by signing and returning a signed copy of the conditional letter to the Commission.

- 6. That <u>ALL</u> changes of association and/or employment by Applicant to another real estate broker shall be submitted in writing to the Commission. The new PB, sole proprietor real estate broker, or BIC of a real estate branch office shall acknowledge the terms of the Applicant's conditional license within ten (10) days of the change by submitting a completed Change Form along with a copy of the conditional letter signed by the new PB. Failure to attach the signed conditional letter by the new PB may result in disciplinary action.
- 7. That the release of the Applicant from the terms and conditions shall not change any terms of the conditional license.
- 8. That upon successful completion of the terms and conditions, the Applicant must submit a written request to the Commission if the Applicant desires to have the conditions removed.

## Dallas A. Stone

After review of the information and testimony presented by the applicant, Commissioner Senter moved to approve the removal of the conditions attached to the real estate salesperson license of Dallas A. Stone. Commissioner Abe seconded the motion. Commissioners Senter, Abe, Ginoza, Emery, Kyono, La Costa, Love, and Yamane voted aye. Commissioner Andrews abstained from the vote. The motion carried.

Chapter 91, HRS, Adjudicatory Matters: The Chair called for a recess from the meeting at 10:18 a.m., to discuss and deliberate on the following adjudicatory matters, pursuant to Chapter 91, HRS:

In the Matter of the Real Estate Broker's Licenses of Caesar Paet and Cadmus Properties Corporation: REC 2021-228-L

It was noted that there were ministerial errors regarding effective dates on page 2 of the settlement agreement. Dates have been corrected.

Upon a motion by Commissioner Ginoza, seconded by Commissioner La Costa, it was voted on and unanimously carried by roll call vote to accept the settlement agreement.

In the Matter of the Real Estate License of James A. Cole: REC 2018-343-L

Upon a motion by Commissioner La Costa, seconded by Commissioner Kyono, it was voted on and unanimously carried by roll call vote to accept the settlement agreement.
