A brief video regarding the virtual board meeting, including meeting procedures and helpful information regarding how members of the public can participate and

interact with the board during the meeting, was played.

Call to Order: The Chair called the meeting to order at 9:05 a.m., at which time quorum was

established by roll call.

This meeting had a physical location and a virtual location. Chair Yamane, Supervising Executive Officer Fujitani and Executive Officer Ino were in attendance in-person at the physical location. All other Commissioners were in

attendance virtually and confirmed that they were present and alone.

#### Chair's Report:

The Chair announced that the Commission may move into executive session to consider and evaluate personal information relating to individuals applying for licensure in accordance with section 92-5(a)(1), HRS, and/or to consult with the Commission's attorney on questions and issues pertaining to the Commission's powers, duties, privileges, immunities, and liabilities in accordance with section 92-5(a)(4), HRS.

The Chair reminded everyone that the licensing deadline to renew is November 30, 2022 and asked all the Commissioners to pass along the reminder. He stated that next month's Real Estate Commission meeting has been changed to Monday, December 19, 2022.

He advised that Condorama IX will be held on Saturday, November 19<sup>th</sup>. Condominium Specialist Stone advised that this is the 9<sup>th</sup> Condorama and thus far just under 500 people have registered for the presentation. There are five (5) speakers on four (4) topics – 1) Contractor's Insurance, 2) Basics of Covenant Enforcement, 3) Association Annual Operating Budgets and Reserves and 4) Tips on Avoiding and Defending Lawsuits. It is not too late to register, and the presentation is 9:00 a.m. to 11:00 a.m. via webinar.

Each speaker will be limited to a five-minute time period pursuant with section 16-99-83 (a)(5), HAR.

Remote Proctoring Statistics 10/1/22 – 10/31/22

PSI submitted the monthly proctoring statistics as requested. Commissioner La Costa commented that the passing percentage for the salesperson test was remarkably lower than the broker test.

Annual Report, Quarterly Bulletin, and School Files

Commissioner Yamane noted the November 2022 REC Bulletin was distributed.

Licensing – Applications:

The Chair informed the Commissioners that the information provided to the Commissioners is related only to the issue that is before the Commission for consideration. The other materials submitted are available for the Commissioners review should they desire to review it. If the applicants have an issue, which is personal in nature, they have the right to request that their application be considered in executive session.

Chair Yamane announced he would be taking agenda items out of order for efficiency purposes.

#### Tj Michel Hwang

Mr. Hwang was present via teleconference and was asked if he wished to have his application for real estate salesperson considered in executive session. He declined the offer.

Mr. Hwang advised that he has always wanted to pursue a career in real estate and now he is able to do so financially. He regrets his past decision to drink and drive and he has completed the necessary requirements set by the court. He mentioned that he is currently working with a real estate agency. Commissioner La Costa asked if there were 2 arrests on his record. Mr. Hwang advised that there is only one. Commissioner La Costa asked for clarification regarding his statement about working for a real estate agency and if he was doing any real estate activities. Mr. Hwang advised that he was doing administrative work for the company and not participating in any real estate activities. Commissioner Abe asked if his driver's license was still suspended. Mr. Hwang advised that his driver's license was reinstated.

After review of the information and testimony presented by the applicant, Commissioner Andrews moved to approve the real estate salesperson license of Tj Michel Hwang. Commissioner La Costa seconded the motion. The motion was voted on and unanimously carried by roll call vote.

#### Shawn Lee Scarcella

Mr. Scarcella was present via video conference and was asked if he wished to have his application for real estate salesperson considered in executive session. He declined the offer.

Mr. Scarcella advised that he has always wanted to be a realtor and follow in his father's footsteps. He admitted to making bad decisions when he was younger and regrets those decisions. He has paid the fines and completed the requirements set by the court. He has turned his life around and is looking forward to helping people find their home.

After review of the information and testimony presented by the applicant, Commissioner Emery moved to approve the real estate salesperson license of Shawn Lee Scarcella. Commissioner Abe seconded the motion. The motion was voted on and unanimously carried by roll call vote.

#### Macarthur Y. Ige

Commissioner Ginoza voiced his concern to the Commission regarding Mr. Ige not having a driver's license after the 2021 conviction and whether he currently has a driver's license

Commissioner Emery moved to approve the real estate salesperson application for Macarthur Y. Ige. There was no second and the motion died.

Upon a motion by Commissioner Andrews, seconded by Commissioner La Costa, it was moved and unanimously carried by roll call vote to take this matter under advisement.

#### Alexander S. Price

Mr. Price was present via teleconference and was asked if he wished to have his request for preliminary decision application for real estate salesperson considered in executive session. He accepted the offer.
