#### **December 2022 Hawaii Condominium Bulletin**

#### **2023 Legislative Session**

The legislative session opened on January 18<sup>th</sup> with nearly four dozen condominium related bills submitted for discussion and debate. Major upcoming deadlines include first lateral, where bills assigned to more than one committee must move to their final committee and decking, where bills must be passed by assigned committees and filed with their respective chamber's clerk to continue the legislative process. The Commission is here to help with a variety of educational videos about pets, budgets, and insurance, among other topics. The Commission also maintains a wide variety of educational brochures, including condominium governance on topics including owners' access to information and documents, fines and foreclosures, and powers and duties of the agents of the association. The Commission keeps a variety of informational publications on board powers and duties, the business judgement rule, and fiduciary duty. Lastly, the Commission has legislative summaries going back to 2017 and helpful tips for dispute resolution.
