<u>Application – Prelicense Education School – Poha School of Real Estate LLC;</u> <u>Principal – Jill Fukumoto; Salesperson and Broker Curriculum – Live-Classroom and Live-Webinar</u>

Ms. Jill Fukumoto summarized that Poha School of Real Estate LLC is currently a Commission-approved continuing education provider and would now like to become a prelicense education school. Ms. Fukumoto stated that Poha School of Real Estate would offer prelicensing classes in both the live-classroom and live-webinar formats. Ms. Fukumoto also explained that the instructor, Mr. Wang, has 6 years of experience teaching with the Honolulu Board of REALTORS®.

Commissioner La Costa stressed the importance of the inclusion of the code of ethics in the prelicensing courses. Mr. Lee Wang responded that the planned prelicensing courses would briefly touch the code of ethics, and that he would expand on the topic. Commissioner La Costa also requested the courses include requirements for signage requirements when discussing marketing. Mr. Wang replied that such requirements will be incorporated.

Commissioner Andrews raised concerns regarding the course noting outdated information within the course. Mr. Wang responded, asserting that the information used for materials are borrowed from another book as reference, and that they also added information taken from the Real Estate Branch website as part of their course material. Commissioner Andrews requested Poha School of Real Estate review its courses and material and ensure its courses are accurate and up-to-date. Vice Chair Senter reiterated Commissioner Andrews' request.

Upon a motion by Commissioner Andrews, seconded by Commissioner La Costa, it was voted on and unanimously carried to defer the decision to the application "Prelicense Education School – Poha School of Real Estate LLC; Principal – Jill Fukumoto; Salesperson and Broker Curriculum – Live-Classroom and Live-Webinar" until the Commission was presented with updated courses and material.
