#### IDW REQUIRED PRIOR TO TEACHING

The completion of a Real Estate Commission ("REC") approved Instructor's Development Workshop ("IDW") is required of all instructors PRIOR to teaching a prelicense class or a continuing education course as per Hawaii Administrative Rules ("HAR") §16-99-104(e). Proof of IDW completion must be submitted with applications for instructor certifications and recertifications. We encourage instructors to take your IDW course well-ahead of the renewal period.

"Instructors Power Up," sponsored by Hawaii Association of REALTORS® and led by instructor Robert Morris, Jr., was held on March 13, 2023 via Zoom. If you were unable to attend Instructors PowerUp, here are some options to fulfill your IDW requirement:

Carmel Streater Courses\*

"Training 101: Teaching Real Estate,"

"Training 201: Developing a Course,"

"Training 301: Teaching Adults with Learning Disabilities," or

"Training 401: Motivating Adult Learners."

\*For Carmel Streater courses, completion of *only one* training course is necessary to fulfill the IDW requirement. Please note that a course shall only be taken once; a repeated course will not be recognized.

For some out-of-state CE providers, their instructors may have obtained the CDEI ("Certified Distance Education Instructor") certification issued by IDECC ("International Distance Education Certification Center"). A current CDEI certificate is acceptable in lieu of completing the Commission's IDW requirement.

If an instructor has completed an IDW in another jurisdiction, that IDW course materials may be submitted for review by the Commission. If approved, that other-jurisdiction IDW may meet the requirement of completing an IDW prior to teaching here in Hawaii.



#### **REMINDERS / UPDATES**

#### **IMPORTANT REMINDERS**:

#### **FOR PRELICENSE SCHOOLS**

#### Questionable Background Issues:

Make all students aware that the "Request for Preliminary Decision Application" ONLY applies to those with a questionable background issue(s). Questionable background issues include, but are not limited to, criminal convictions (felony, misdemeanor, or court martial), or any civil/administrative/government action, including DUIs, drug/alcohol issues, abuse situations, tax liens, unpaid tax obligations, judgments, unpaid judgments, disciplinary action (for another licensing area or from another state or country), applicants currently serving parole or probation, violations of administrative laws/court orders/government sanctions, etc. IF the student does have a questionable background issue, they may be interested in reviewing and possibly applying for the Request for Preliminary Decision Application before investing additional time and money on the licensing process.

#### Avoid Education System errors:

You may only offer a course that has been registered/re-registered with the Commission. Be sure your course has been registered/re-registered prior to offering.

Upon completion of a course, be certain you are adding the attendee information to the correct course and double-check that the month and year of completion are correct. There have been too many instances when the licensing examination and/or the application for licensure have been questioned and nearly rejected due to incorrect dates being entered.

#### **School Completion Certificates:**

As many of you have transitioned to electronic communication and are now providing School Completion Certificates via email, please be sure your students are aware they will be receiving their School Completion Certificates from you electronically.

#### MyPVL Account:

Students should only "register" <u>once</u> for a MyPVL account and should use the <u>same</u> MyPVL account from prelicense to licensure. This will avoid duplicate accounts, emails, passwords, etc. Students are encouraged to use their personal email, not an email affiliated with an employer. This will avoid being locked out of their MyPVL account should they leave that employer and no longer have access to that email.

Highlight the importance of MyPVL accounts and its functions. Licensees will need to visit their account time and again to renew their licenses every even-numbered year (whether on active or inactive status). Their MyPVL account provides access to their CE history, their license status, the ability to update personal information, and to print their pocket IDs and wall certificates (if applicable).

Remind licensees pocket IDs and wall certificates will not be mailed to them. Licensees will obtain their pocket IDs and wall certificates by printing them through their MyPVL account. Printing directly from MyPVL is free. Printing of wall certificates is only accessible to active licensees.

#### This information should be disseminated to all students when they take prelicensing courses:

- 1. Students shall register for the prelicensing course using their legal name as stated on their government-issued ID. This will avoid the incorrect name from being printed on their school completion certificate and will enable the student to schedule their exam with PSI without incident/rejection.
- 2. Prelicense instructors should clearly emphasize that broker candidates must apply for and receive a broker experience certificate (BE) from the REB prior to sitting for the broker licensing exam with PSI. Without an approved BE, a candidate who successfully passed an exam will not have the passing examination honored.
- 3. Prelicense instructors should clearly emphasize to broker candidates the importance of completing their broker experience (BE) application and their Experience Certification Statement(s) correctly. Make sure correct dates of employment and the correct number of weeks of full-time experience are entered on their Experience Certification Statement(s) that accompany their application for BE. Incorrect applications or required documents will result in rejection and/or delays.

4. Prelicense instructors should remind broker candidates to read the BE application instructions in its entirety. Please note that original signatures are required; DocuSign is not acceptable.

#### **FOR CONTINUING EDUCATION PROVIDERS**

#### Avoid Education System errors:

You may only offer a course that has been registered/re-registered with the Commission. Be sure your course has been registered/re-registered <u>prior</u> to offering.

Upon completion of a continuing education course, be certain you are adding the attendee information to the correct course ID number.

When entering course completion information, please double-check that the correct course dates are entered AND the correct biennium is credited, especially for "make-up" credits.

#### MyPVL Account:

Highlight the importance of MyPVL accounts and its functions. Licensees will need to visit their account time and again to renew their licenses every even-numbered year (whether on active or inactive status). Their MyPVL account provides access to their CE history, their license status, the ability to update personal information, and to print their pocket IDs and wall certificates (if applicable).

Remind licensees pocket IDs and wall certificates will not be mailed to them. Licensees will obtain their pocket IDs and wall certificates by printing them through their MyPVL account. Printing directly from MyPVL is free. Printing of wall certificates is only accessible to active licensees.

#### This information should be disseminated to all licensees when they take CE courses:

- 1. Licensees should confirm their information, specifically their real estate license number, is correct when registering for a CE course(s). This will ensure that the proper courses and credit hours are reported to the licensee's education portal.
- 2. A CE Provider has 10 days to post a course completion. Licensees should be made aware of that timeline and if a course is NOT posted, the licensee should check back with the CE Provider to ensure it was not overlooked.
- 3. Licensees may access their CE information via their MyPVL account at <a href="https://mypvl.dcca.hawaii.gov/">https://mypvl.dcca.hawaii.gov/</a>. Once logged into their MyPVL account, click on their license number. Next, click on the tab "RECE" (Real Estate Continuing Education), then on the "View CE History" tab. Here licensees will be able to view their history of courses completed and reported to the Commission.
