Executive Officer Ino announced that the Commission shall afford all interested persons an opportunity to submit data, views, or arguments in writing, on any agenda item and shall provide all interested parties an opportunity to present oral testimony on an agenda item subject to the conditions set forth in section 16-99-83, HAR. The Commission may remove any person or persons, who willfully disrupt a meeting to prevent and compromise the conduct of the meeting in accordance with section 92-3, HRS. Each speaker will be limited to a five-minute time period pursuant with section 16-99-83(a)(5), HAR.

# **Minutes of Previous Meeting**

Upon a motion by Commissioner Emery, seconded by Commissioner Kyono, it was voted on an unanimously carried to accept the minutes of the February 23, 2024, meeting.

Committees and Program of Work:

#### **Condominium Review Committee**

Consumer Education - DCCA Consumer Fair Report; March 6, 2024

The Real Estate Branch staff took part in DCCA's 2024 Consumer Fair held on March 6th. This year DCCA held the Fair on the fourth floor of the State Capitol. Staff provided a wide range of condominium educational materials and interacted with the public, consumers, legislators, and legislative staff that browsed the Fair.

<u>Consumer Education – 2024 Hawaii Buildings, Facilities & Property Management Expo; March 6 – 7, 2024</u>

Real Estate Branch staff manned a booth at the two-day Expo held at the Blaisdell Exhibition Hall. Staff provided various condominium educational materials for distribution and were able to reach out to property managers, resident and site managers, and association board members. Staff also talked with industry partners regarding upcoming educational outreach opportunities for the Real Estate Branch.

# Condominium Seminars - Condorama Seminar Training Procurement Proposals

The Real Estate Commission procured for a one-time training for approximately 1-1/2 hours to condominium owners via an electronic delivery platform requesting that vendors have in-depth legal and practical knowledge of the Hawaii condominium law, current local and national trends relating to condominium governance, and have experience producing educational events online. Past Condorama offerings have had 1,200 viewers. The Commission received two proposals.

Ms. Hammond's proposal seems to mirror the Commission's ABC's course which would be duplicative of something we already have. She would be a good resource for an FHA loan/HUD program presentation. Ms. Hammond provided no real evidence of large-scale seminar experience but may be useful for a future, more limited scope seminar.

CAI Hawaii in their history of performance have been on-time, on-budget, provided relevant topics with expert speakers in different fields, evaluations from viewers have been positive, and they have past experience of running large seminars. Commission members reviewed both proposals. Commissioner Andrews commented that the proposal by Nicole Hammond was at a lower cost but felt that Ms. Hammond's experience may be better geared at being a presenter rather than the offeror.

Commissioner Emery noted that he is a member of CAI Hawaii but can make an impartial decision with respect to this matter.

After a review of the information provided, Commissioner Andrews moved to select Community Associations Institute Hawaii Chapter (CAI Hawaii) as the vendor to provide the one-time training to condominium owners on an electronic delivery platform based on CAI Hawaii's demonstrated years of experience of providing large scale seminars to 200-1,200 viewers with experts discussing relevant and hot topic condominium issues, in depth legal understanding of condominium law complexities and maintaining prior events for streaming. Commissioner La Costa seconded the motion. The motion was voted on and unanimously carried.

#### **Education Review Committee**

Ad Hoc Committee on Education (ACE) Report - February 9, 2024

A written report of the February 9, 2024 meeting of the Ad Hoc Committee on Education regarding Core Course B was distributed for informational purposes. Commissioner Andrews commented that it was great that the core course will focus on RICO and the recovery fund. Commissioner Abe noted that the course will be very beneficial to real estate licensees and learning about the RICO process.
