Report:

Executive Officer Ino announced that the Commission shall afford all interested persons an opportunity to submit data, views, or arguments in writing, on any

agenda item and shall provide all interested parties an opportunity to present oral testimony on an agenda item subject to the conditions set forth in section 16-99-83, HAR. The Commission may remove any person or persons, who willfully disrupt a meeting to prevent and compromise the conduct of the meeting in accordance with section 92-3, HRS. Each speaker will be limited to a five-minute time period pursuant with section 16-99-83(a)(5), HAR.

Minutes of Previous Meeting

Upon a motion by Commissioner Andrews, seconded by Commissioner Kyono, it was voted on and unanimously carried to accept the minutes of the May 31, 2024, meeting.

Laws and Rules Review Committee

Regulated Industries Complaints Office (RICO): Real Estate Advisory Committee Members

Upon a motion by Commissioner Abe, seconded by Commissioner Kyono, it was voted on and unanimously carried to approve the appointment of the candidate submitted as a RICO Real Estate Advisory Committee Member.

Association of Real Estate License Law Officials (ARELLO) 2024 Mid-Year Meeting Report, New Orleans, LA, April 16 – 18, 2024

The Commission acknowledged receipt of the ARELLO 2024 Mid-Year Meeting report submitted by staff.

Legislative Acts and Resolutions

Chair Yamane informed the Commission that the following Acts were provided for Commission's information.

- a. ACT 011 Relating to the Sunshine Law Requires boards to make available for public inspection board packets, if created, at the time the board packet is distributed to board members but no later than two business days before the board meeting. Provides that public testimony may be distributed to board members before the board meeting. Requires boards to include in the notice to persons requesting notification of meetings, a list of the documents that were compiled by the board and distributed to board members before a board meeting for use at the meeting. Requires boards to post board packets on its website.
- b. ACT 032 Relating to the Residential Landlord-Tenant Code Amends the deadline related to the repair of conditions that constitute health or safety violations. Increases the amount deducted from a tenant's rent for the tenant's actual expenditures to correct health or safety violation and defective conditions. Takes effect 11/1/2024.
- c. ACT 033 Relating to the Landlord-Tenant Code Amends the Residential Landlord-Tenant Code to provide for a process to dispose of the tenant's personal property and surrender the dwelling unit to a landlord when there is a death of a tenant. Takes effect 11/1/2024.
- d. ACT 040 Relating to Energy Establishes the solar hui program to allow multi-family residential property owners to invest in a solar hui investment fund, which will provide repayment of income derived from energy services

agreements to low- and moderate-income households to install solar energy systems. Establishes the solar hui program fund manager position. Appropriates funds.
