RENEWAL REMINDERS

REAL ESTATE LICENSEES

- The real estate license renewal deadline is November 30, as usual. Online and paper renewal applications will be available mid-October 2024.
- Renewal information: Licensees should be reminded to check their MyPVL account for current information on license renewals at www.mypvl.dcca.hawaii.gov.
- CORE B 2023-2024, "Regulation, RICO, and Your License" is available for offering.
- If you were issued a new SALESPERSON license in calendar year 2024 and renew your license by the renewal application deadline, you will be deemed to have completed the equivalent to the continuing education requirement and will not have to complete the continuing education requirement for this license renewal. Renewal fees must still be paid by November 30 to remain CURRENT.
- Continuing Education Equivalency (CEE) Application: The CEE application applies to Hawaii salespersons and brokers who hold a current, unencumbered (no conditions or disciplinary actions attached to the license) real estate salesperson or broker license in another state/jurisdiction, and who have successfully completed the CE requirements in that state/jurisdiction. This equivalency is for **ELECTIVE COURSE HOURS ONLY**. If granted, the licensee will still be required to complete the 2023-2024 core course (Parts A & B) in order to fulfill Hawaii's CE requirement. This application is posted on the Real Estate Branch website at www.hawaii.gov/hirec under the "Forms" section. Once there, click on "Equivalency Applications and Broker Experience Certificate" and locate the "Continuing Education Equivalency" form. This application will be removed from the website midnight December 31, 2024.

CONTINUING EDUCATION PROVIDERS, COURSES

- The renewal deadline for all real estate continuing education providers and continuing education courses is **November 30, 2024** to ensure you remain in compliance. Renewal applications will be accepted from **October 2024**.
- Remember your CE courses must meet the interactivity requirements.
- Completion of an Instructor's Development Workshop (IDW) is required prior to teaching. Providers should monitor the instructors they use to teach offered courses.

PRELICENSE SCHOOLS, INSTRUCTORS, GUEST LECTURERS

- The renewal deadline for all real estate prelicense schools and prelicense instructors is **November 30, 2024** to ensure you remain in compliance. Renewal applications will be accepted from **October 2024**.
- Completion of an Instructor's Development Workshop (IDW) is required prior to teaching. School Principals should monitor the instructors they use to teach offered courses.



CONTINUING EDUCATION Q & A

One of the most common inquiries received by the Real Estate Branch in the months leading up to the November 30th renewal deadline is regarding continuing education (CE). Please share this information with your students!

Here are some commonly asked questions and answers:

Q: Can you tell me how many CE credits I currently have?

A: Licensees may check their CE credits by logging into their MyPVL account by visiting <https://mypvl.dcca.hawaii.gov>.

Once there, click on the license number. Next click on the "RECE" (Real Estate Continuing Education) tab, then on "View CE History." There you will see all courses that have been completed and reported to the Commission.

Q: When should I start taking CEs?

A: Now! All CE courses should be completed prior to submitting your renewal application. Any individual licensee who has renewed but failed to complete the CE requirement will be renewed on an inactive status without further notice.

Q: Where can I find a list of CE courses and providers?

A: Commission-approved courses and providers may be found on the DCCA Education System website at http://hawaiidcca.force.com/pmtx/CE_FUTURE_COURSES?t=c&q=.

Q: I took a CE course yesterday; why don't I see the course credit in my MyPVL account CE History?

A: CE providers have 10 days to report your completed course to the education system. If it has been more than 10 days since the course has been completed, **please contact the CE provider directly for further assistance.**

Q: Can I take the same course that I have taken in the past? Will I receive credit for it?

A: You will not receive credit for a course you have taken during the last renewal period. If the course is a duplicate course, it will NOT be posted to your MyPVL account.

- Q: I have taken more than the required 20 CE hours. Can excess credit hours be applied to the next renewal period?
- A: No. CE course credits do not “rollover.”
- Q: Will my ethics course count toward my 20 CE hours?
- A: Check with the provider and trade organization offering the course if it is a Hawaii Real Estate Commission approved course.
- Q: I recently received my new real estate license. Can I use the prelicense course I took toward my CE requirements?
- A: No. Prelicensing courses and CE courses are not interchangeable.



CORE B, 2023-2024 is NOW AVAILABLE

“Regulation, RICO and Your License”

Core B 2023-2024 is available for offering by providers whose instructors attended the Core B Train-the-Trainer. CE Providers who were named by their instructor(s) when they registered for the Train-the-Trainer have the Core B “subject” listed in their subjects under the education portal. A CE Provider will not be able to offer Core B if Core B does not appear on their subject list.

Both Part A, “3D Rules: Disclose, Disclose, Disclose!” and Part B, “Regulation, RICO, and Your License” must be completed in order to receive credit for the core course.

A CE Provider may create an online version of Core B using the approved core course materials. Remember, CE courses must include interactivity, assessments and remediation for incorrect answers to the assessments/quizzes.

Both Parts A and B will be available through May 2025, in both live and online formats.

REMINDER: SUBMIT ALL CORE COURSE EVALUATIONS

Please continue to submit ONLY the core course evaluations to the Real Estate Branch. At this time, you do not have to submit the course evaluations for any other continuing education elective courses. Submit the core course evaluations in a format that is easily downloadable by staff such as .pdf or Google Forms.

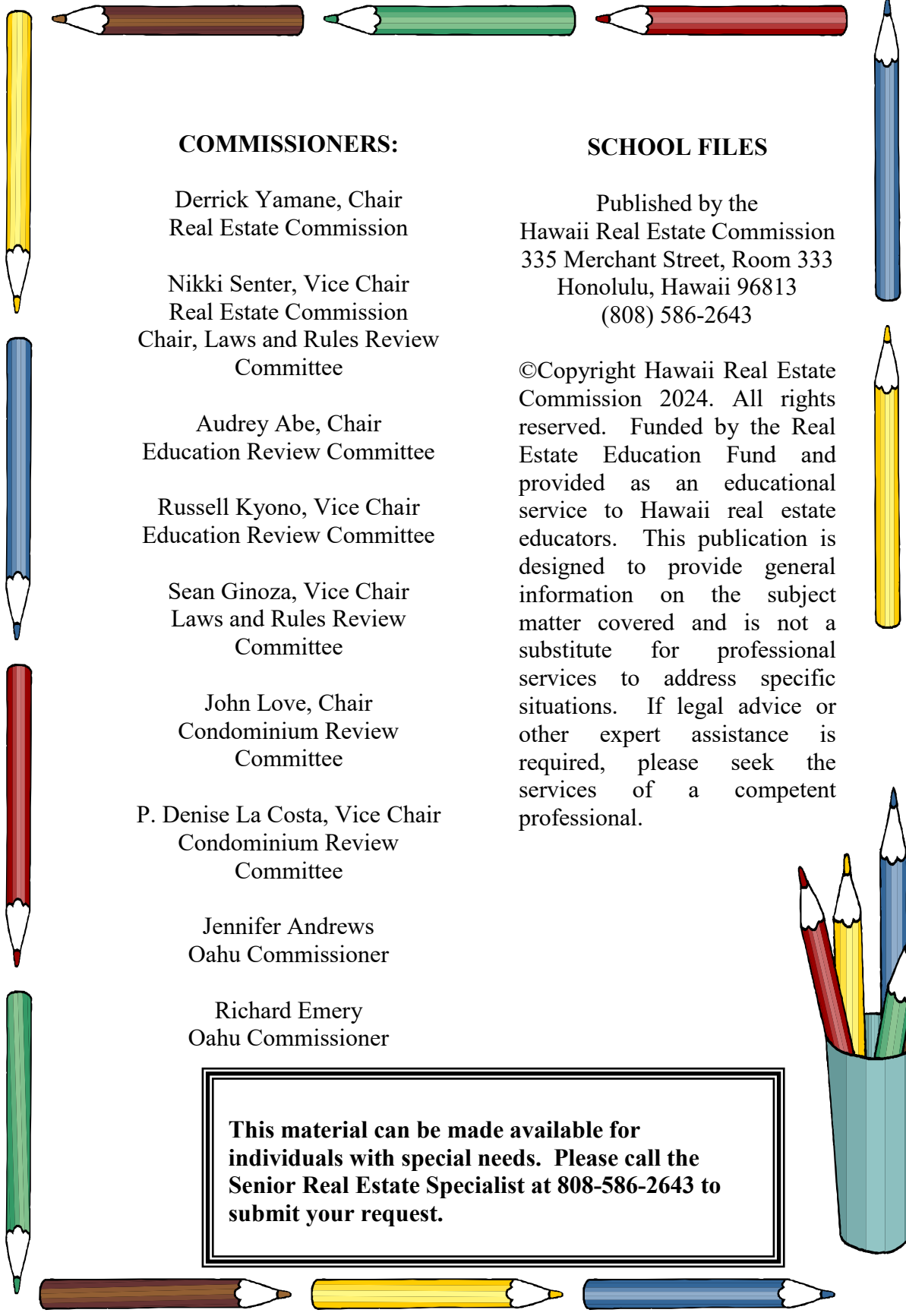
