Call to Order: The Chair called the meeting to order at 9:08 a.m., at which time quorum was

established by roll call.

Chair's Report: The Commission may move into executive session to consider and evaluate

personal information relating to individuals applying for licensure in accordance with section 92-5(a)(1), HRS, and/or to consult with the Commission's attorney on questions and issues pertaining to the Commission's powers, duties, privileges,

immunities, and liabilities in accordance with section 92-5(a)(4), HRS.

Commissioner Love was excused from the meeting. Prior notification of his non-

attendance was received.

Executive Officer's Report:

Executive Officer Ino announced that the Commission shall afford all interested persons an opportunity to submit data, views, or arguments in writing, on any agenda item and shall provide all interested parties an opportunity to present oral testimony on an agenda item subject to the conditions set forth in section 16-99-83, HAR. The Commission may remove any person or persons, who willfully disrupt a meeting to prevent and compromise the conduct of the meeting in accordance with section 92-3, HRS. Each speaker will be limited to a five-minute time period pursuant with section 16-99-83(a)(5), HAR.

Executive Officer Ino advised the audience that the Commission will not be accepting any written or oral testimony pertaining to agenda item 7. a. as it is a Adjudicatory Matter subject to Chapter 91, HRS.

### **Minutes of Previous Meeting**

Upon a motion by Commissioner La Costa, seconded by Commissioner Ginoza, it was voted on and unanimously carried to accept the minutes of the August 23, 2024, meeting.

Committees and Program of Work:

### **Condominium Review Committee**

Program of Work, FY25, Condominium Laws and Education

Executive and Legislative Condo and Property Insurance Task Force request for informal, non-binding interpretation on the use of borrowing from condominium reserves for operating expenses

Condominium Specialist Choy provided a summary of the request, and noted the Hawaii Administrative Rules has ambiguous language governing a condominium's ability to borrow from its reserves. Deputy Attorney General Wong affirmed, confirming that the Hawaii Administrative Rules does not explicitly permit nor prohibit any borrowing.

Commissioner Emery commented that there is a mandatory need to replenish condominium reserves and suggested that a language should be included in the Commission's interpretation requiring condominium reserves to be replenished.

Commissioner Andrews raised concerns about taking allocated funds with those funds already having a set purpose. Commissioner Emery wondered whether the matter has any single solution. He also commented that condominiums who experienced hurricane issues had rising premiums due to deferred maintenance and failing structures.

Condominium Specialist Choy stated\_that the task force only has proposals, and the Commission has proposed rules for chapter 514B, HRS. There are also

adjustments being made in these proposed rules, but the rules itself have not undergone public hearing. Commissioner Abe expressed concern that the matter causes condominiums to exhaust its reserves, and inquired whether there is any temporary financing available. Chair Yamane reminded the Commission that the matter is being heard for the Commission to give an informal, non-binding interpretation. Vice-Chair Senter commented that the matter came to the Commission to assist condominium boards, allowing them to have time to minimize costs.

Upon a motion by Vice-Chair Senter, seconded by Commissioner Andrews, it was voted on and unanimously carried to take the matter under advisement...

### PSI Real Estate Licensing Exam Review Meeting Report

### PSI Hawaii Real Estate Educator's Forum Report

The Commission consolidated its discussion for agenda items 4. b. 2) a) and 4. b. 2) b).

Real Estate Specialist Endo briefly summarized the meeting and explained that the meetings showed current activities being conducted by PSI as it pertained to examinations. Commissioner La Costa sought to clarify what does "non-graded pretest items" meant. Real Estate Specialist Endo explained that these are non-graded test questions, and if these items perform well over time, it will be changed to graded questions. There may be about 5-10 non-graded questions administered to candidates during the exam.

Commissioner La Costa raised concerns about the language pertaining to minimally competent candidates. Real Estate Specialist Endo explained that the minimally competent candidate serves as a baseline, and the Subject Matter Experts will determine the level of minimally competency needed to meet the standards of practice in the industry. Chair Yamane shared having the same question before but stated that the Commission should address the matter consistent with its responsibility to protect the public. Chair Yamane noted that the programs\_make sure that licensees are competent.

Commissioner Emery disclosed that he works part-time with Associa Hawaii's parent company, and thus will recuse from participating in the matter's deliberations.

Vice-Chair Senter disclosed that she has a long-standing relationship with Associa Hawaii and will also recuse from participating in the matter's deliberations.

Commissioner Emery and Vice-Chair Senter left the meeting.

Upon a motion by Commissioner Ginoza, seconded by Commissioner Abe, it was voted on to amend the Commission's Final Order to change the fine from \$1,000.00 to \$85,800.00. Chair Yamane, and Commissioners Abe, Ginoza, and Kyono voted aye. Commissioner Andrews voted nay. Commissioner La Costa abstained. The motion did not carry.

Upon a motion by Commissioner La Costa, seconded by Commissioner Andrews, it was voted on to amend the Commission's Final Order to change the fine from \$1,000.00 to \$367,500.00. Commissioners La Costa and Andrews voted aye. Chair Yamane and Commissioners Abe, Ginoza, and Kyono voted nay. The motion did not carry.

Chair Yamane deferred the matter to a later date.

Following the Commission's review, deliberation, and decision in these matters, pursuant to Chapter 91, HRS, the Chair announced that the Commission was reconvening its scheduled meeting at 12:36 p.m.
