Executive Officer Ino announced that the Commission shall afford all interested persons an opportunity to submit data, views, or arguments in writing, on any agenda item and shall provide all interested parties an opportunity to present oral testimony on an agenda item subject to the conditions set forth in section 16-99-83, HAR. The Commission may remove any person or persons, who willfully disrupt a meeting to prevent and compromise the conduct of the meeting in accordance with section 92-3, HRS. Each speaker will be limited to a five-minute time period pursuant with section 16-99-83(a)(5), HAR.

Upon a motion by Commissioner Andrews, seconded by Commissioner Kyono, it was voted on and unanimously carried to approve the minutes of the November 22, 2024, meeting.

Condominium Review Committee

Consumer Education

<u>Honolulu Board of REALTORS® Winter General Membership Meeting – November</u> 22, 2024

Condominium Education Specialist Sides presented that she attended the Honolulu Board of REALTORS® Winter General Membership Meeting on November 22, 2024, to conduct outreach. The Real Estate Branch provided resources and education to attendees.

Commissioner Andrews conveyed an appreciation for Suzanne Young of Honolulu Board of REALTORS®, and commended staff's presence and hard work.

North Shore Neighborhood Board Agricultural Committee Educational Presentation – November 22, 2024

Condominium Specialist Choy informed the Commission that staff was invited by the Vice Chair of the North Shore Neighborhood Board Agricultural Committee to conduct a presentation on condominium topics and the condominium registration process. The Honolulu Department of Planning and Permitting ("DPP") also attended to answer questions pertaining to subdivisions and ordinances relating to agricultural zoning laws and Special Management Areas. Condominium Specialist Choy noted that attendees asked many questions about the condominium registration process, while questions were raised to DPP pertaining to difficulties in the process of obtaining building permits.

Commissioner Andrews asked whether any attendees inquired about agricultural lands. Condominium Specialist Choy replied that there were none.

Representative La Chica's Mililani Community Talk Story – December 3, 2024

Condominium Education Specialist Sides informed the Commission that Representative Trish La Chica held a Community Talk Story in Mililani on December 3, 2024, regarding the condominium insurance crisis. Specialist Sides was invited to give a presentation about the Real Estate Branch's resources for condominium owners and boards. Other speakers included Insurance Commissioner Gordon Ito and Insurance Agent Alex McLaury.

Commissioner Abe noted that there are only 3 available insurance carriers for condominiums and asked whether there is anything that can be done to improve the situation. Condominium Education Specialist Sides replied that Mr. McLaury discussed the limited number of insurance carriers in his presentation and that insurance rates have decreased slightly in the past few months.

Commissioner Emery commented that insurance carriers are under pressure for reinsurance risks and saw a softening in rate increases in the past couple of months.

Senior Condominium Specialist Kleinhans informed that copies of the public hearing's published notice, guest list, and testimonies were distributed to the Commission, along with a copy of the November 29, 2024, minutes of the public hearing.

The Commission received 3 written testimonies on its proposed condominium draft rules:(1) Richard Emery, testifying in his capacity as a licensed real estate broker, with comments; (2) Philip Nerney, Chairperson of the CAI Legislative Action Committee of the Community Associations Institute, with comments; and (3) Jon McKenna, President of Hawaiiana Management Company, Ltd., with comments.

There were no physical attendees present at the public hearing to provide oral testimony.

Technology and Website

Change Form – Real Estate – Express Change Broker

Supervising Executive Officer Fujitani presented that staff is working with the Public Consulting Group ("PCG"), to create a new online licensee Change Form to streamline real estate licensee broker changes. This new initiative aims to reduce the Professional and Vocational Licensing Division's Licensing Branch's ("LB") manual interaction with the licensee's request and allows for a licensee who wishes to move from their present broker/brokerage to another by completing the change online.

Supervising Executive Officer Fujitani added that quotes were obtained from 3 qualified vendors to develop the new process. Staff is requesting approval for using the Real Estate Education Fund to pay for the initiative and to approve Transeo Solutions as the chosen vendor.
