CORE COURSES 2025-2026

The Commission's mandatory course, Core A, "Advertising, Agency, and Accountability – it's your kuleana!", is currently being offered. Also included in Core A are the 2025 real estate-related legislative updates. Instructors are reminded to check on the status of the legislative bills that are included in Core A and to educate your course attendees. Current bill status may be found by following (clicking on) the links that are included in the Core A Student Resource Manual or by visiting the Hawai'i State Legislature website at capitol.hawaii.gov. For the most up-to-date information on new legislation, it is recommended licensees complete Core A in the first year of the biennium (now!), and Core B in the second year of the biennium.

Core B 2025-2026 will focus on the topic of Property Management, and will include long-term rentals, vacation rentals, commercial rentals, physical property managers, resident managers, custodian-caretaker, condominium associations, case scenarios, and applicable legislative updates. Core B will be developed in 2026.

Reminder – both Core A and Core B courses must be completed in order to receive continuing education credit. If only one core course is completed, the licensee will not receive any core course credit.

Please submit core course and instructor evaluation forms to the Real Estate Branch within 10 days of course completion.

TRAIN-THE-TRAINER – CORE A

Train-the-Trainer was hosted by the Honolulu Board of REALTORS® (HBR) on June 30, 2025. The training was led by course author, Everett Kaneshige, and there were 45 instructors/participants in virtual attendance.

Instructors who missed this session and wish to teach Core A, “Advertising, Agency, and Accountability – it’s your kuleana!”, may email the Real Estate Branch at roster@dcca.hawaii.gov, to request the YouTube link so they may complete this training session. As you are aware, instructors must complete the corresponding training session prior to teaching this or any core course.

Mahalo to HBR for hosting the Train-the-Trainer session again!

REMINDER TO CE PROVIDERS AND INSTRUCTORS:

No modifications shall be made to the Commission's core course.
The approved student handbook, slides and related materials shall remain unchanged.

Any additional slide(s) must be submitted to the Commission for approval prior to implementation and must include a disclaimer indicating they are supplementary and not part of the officially approved core course.

Instructors and CE providers must strictly adhere to the approved course content and meet the three-hour minimum requirement.

Noncompliance may result in disqualification of the instructor and/or removal of the course from the CE provider's approved roster.

TIDBITS FOR CE PROVIDERS

- CE Providers must post CE credits within 10 calendar days of course completion pursuant to Hawaii Administrative Rules §16-99-112(c). CE course completion dates shall adhere to and reflect Hawaiian Time Zone. Should you encounter any system issues or have trouble adding an attendee, notify us immediately at roster@dcca.hawaii.gov
- You may only offer courses that have been certified/re-certified with the Commission. Be sure the course has been certified/re-certified for this biennium prior to offering.
- Upon completion of a continuing education course, be certain you are adding the student information to the correct course ID number AND correct course completion date within the education portal.
- If you receive an error message that a student has already received credit for a course in the previous biennium, notify the student immediately.

Although the student is responsible to ensure they are not repeating a course they received credit for in the previous biennium, reminding them to check their CE courses would be helpful. They may check completed courses by logging into their MyPVL account at mypvl.dcca.hawaii.gov/.

Share this information with all students/licensees:

1. Licensees should confirm their information, specifically their real estate license number, is correct when registering for a CE course(s). This will ensure that the proper courses and credit hours are reported to the licensee's real estate education portal. If the licensee upgrades their license from a salesperson to broker, remind them to use their broker license number.
2. A CE Provider has 10 calendar days to post a course completion. Licensees should be made aware of that timeline.
3. Licensees may access their CE information via their MyPVL account at mypvl.dcca.hawaii.gov/. Once logged into their MyPVL account, click on their license number. Next, click on the tab "RECE" (Real Estate Continuing Education). Here licensees will be able to view their history of courses completed and reported to the Commission.
4. Licensees must renew their real estate license via their MyPVL account by November 30 of every even-numbered year whether on an active or inactive status.

REMINDERS FOR PRELICENSE SCHOOLS

Schools should make all students aware of the "Request for Preliminary Decision Application" for those with a questionable background issue(s). Questionable background issues include, but are not limited to, criminal convictions (felony, misdemeanor, or court martial), or any civil/administrative/government action, including DUIs, drug/alcohol issues, abuse situations, tax liens, unpaid tax obligations, judgments, unpaid judgments, disciplinary action (for another licensing area or from another state or country), applicants currently serving parole or probation, violations of administrative laws/court orders/government sanctions, etc.

School Completion Certificates:

Preliminary School Completion Certificates are issued by the preliminary school, NOT the Real Estate Branch (REB). The printed School Completion Certificate is considered "original" but must be printed full-sized on plain white, 8 ½" by 11" paper.

For schools that have transitioned to electronic communications and are now providing School Completion Certificates via email, please be sure your students are aware they will be receiving their School Completion Certificates from you electronically.

Share this information with all students:

1. Students should register using their legal name as stated on their government-issued ID. This will avoid the incorrect name from being printed on their school completion certificate and will enable the student to schedule their exam with PSI without incident/rejection.
2. eHawaii.gov accounts have migrated to myHawaii. Therefore, upon initial signup for a MyPVL account at mypvl.dcca.hawaii.gov/, students will need to set a password and set up a Multi-Factor Authentication.
3. Students should only "signup" once for a MyPVL account and should use the same MyPVL account from prelicensure to licensure. This will avoid duplicate accounts, emails, passwords, etc.
4. When signing up for their MyPVL account, students are encouraged to use their personal email, not an email affiliated with an employer. This will avoid being locked out of their MyPVL account should they leave that employer and no longer have access to that email.

5. Licensees must renew their real estate license via their MyPVL account by November 30 of every even-numbered year whether on an active or inactive status.
6. Prelicense instructors should clearly emphasize that broker candidates must apply for and receive a broker experience certificate (BE) from the REB prior to sitting for the broker licensing exam with PSI. Without an approved BE, broker candidate exam scores shall be voided.
7. Please continue to distribute the PSI Candidate Information Bulletin. This applies to both live and online courses.
