Aloha and Happy 2026!

It's an **even-numbered year** and that means **it is a renewal year**.

Prelicense Schools, Prelicense Instructors, Guest Lecturers, Continuing Education Providers, Continuing Education courses must re-register/re-certify by November 30, 2026, to remain current and in compliance. Be sure to visit the "Forms" section on our website at www.hawaii.gov/hirec to ensure you submit the most up-to-date application(s).

The real estate license renewal deadline for all salespersons, brokers, and entities is also November 30, 2026. Online renewal will be done via their MyPVL accounts: mypvl.dcca.hawaii.gov and will be available mid-October.

Licensees **must renew their real estate license** by November 30 of every even-numbered year **whether on an active or inactive status**.

Note that all real estate SALESPERSONS who received their license in the even-numbered year of the biennium, 2026, are NOT required to complete the 20 hours of continuing education (CE) to renew their license on a current and active status. **THIS DOES NOT APPLY TO NEWLY LICENSED real estate BROKERS** who received their license in 2026. **BROKERS ARE** required to complete 20 hours of CE.

PSI Exams' eligibility-based licensing examination registration:

Effective December 10, 2025, testing candidates are required to upload the pre-licensing certificate(s) and/or certificate(s) issued by the Hawaii Real Estate Commission prior to testing. PSI will review the certificate(s) and either approve or deny testing within 3 business days. If approved, the testing candidate will receive a 'Welcome to PSI' eligibility email that will assist in scheduling an examination. If the testing candidate is denied, they will receive a message in their online account outlining the missing information and/or documentation.

Please continue to distribute the PSI Candidate Information Bulletin. This applies to both live and online courses.

TIDBITS FOR CE PROVIDERS

Although students/licensees are responsible for ensuring they are not repeating a course they received credit for in the previous biennium, reminding them to check their CE courses would be helpful. They may check completed courses by logging into their MyPVL account at mypvl.dcca.hawaii.gov/. Once logged in, they may click on their real estate license number and then click the "RECE" (Real Estate Continuing Education) tab. Finally, click on "View CE History" to view all the CE courses that have been completed and reported to the Commission.

Reminders:

- Upon completion of a CE course, please ensure you add the student information to the correct course ID number AND correct course completion date within the education portal.
- If you receive an error message that a student has already received credit for a course in the previous biennium, notify the student immediately.
- Providers must post CE credits within 10 calendar days of course completion pursuant to Hawaii Administrative Rules §16-99-112(c).
- CE course completion dates shall adhere to and reflect Hawaiian Time Zone. Should you encounter any system issues or have trouble adding an attendee, notify us immediately at roster@dcca.hawaii.gov

Share this information with all students/licensees:

1. Licensees should confirm their information, specifically their real estate license number, is correct when registering for a CE course(s). This will ensure that the proper courses and credit hours are reported to the licensee's real estate education history through the education system portal. If the licensee upgrades their license from a salesperson to broker, remind them to use their broker license number.
2. A CE Provider has 10 calendar days to post a course completion. Licensees should be made aware of that timeline.
3. MyPVL has an updated interface called myHawaii. Licensees are urged to log in to this updated system at mypvl.dcca.hawaii.gov/ as they are required to verify their email address to access their MyPVL account. In addition, myHawaii has updated their password criteria, therefore, if their original (eHawaii) password credentials do not meet myHawaii's requirements, they will need to update their password and set up a Multi-Factor Authentication.
4. Licensees may access their CE information via their MyPVL account at mypvl.dcca.hawaii.gov/. Once logged into their MyPVL account, click on their license number. Next, click on the tab "RECE" (Real Estate Continuing Education). Here licensees will be able to view their history of courses completed and reported to the Commission.
5. Licensees must renew their real estate license via their MyPVL account by the Commission-prescribed deadline of November 30 of every even-numbered year whether on an active or inactive status.

REMINDERS FOR PRELICENSE SCHOOLS

Questionable Background Issues:

Continue to make students aware of the “Request for Preliminary Decision Application” for those with a questionable background issue(s). Questionable background issues include, but are not limited to, criminal convictions (felony, misdemeanor, or court martial), or any civil/administrative/government action, including DUIs, drug/alcohol issues, abuse situations, tax liens, unpaid tax obligations, judgments, unpaid judgments, disciplinary action (for another licensing area or from another state or country), applicants currently serving parole or probation, violations of administrative laws/court orders/government sanctions, etc.

School Completion Certificates:

The Real Estate Branch (REB) continues to receive calls from students requesting their Prelicense School Completion Certificate (SCC). SCCs are issued by the prelicense school, NOT the REB. The printed School Completion Certificate is considered “original” but must be printed full-sized on plain white, 8 ½” by 11” paper.

For schools that have transitioned to electronic communications and are now providing SCCs via email, please be sure your students are aware they will be receiving their certificates electronically from you, the prelicense school. SCCs must be signed by the school’s principal; a “typewritten signature” will not be accepted.

Share this information with all students:

1. Students should register using their legal name as stated on their government-issued ID. This will avoid the incorrect name from being printed on their school completion certificate and will enable the student to schedule their exam with PSI without incident/rejection.
2. When signing up for their MyPVL account at mypvl.dcca.hawaii.gov/, encourage students to use their personal email, not an email affiliated with an employer. This will avoid being locked out of their account should they leave that employer and no longer have access to that email.
3. MyPVL has an updated interface called myHawaii. myHawaii has updated their password criteria, therefore, upon initial signup for a MyPVL account at mypvl.dcca.hawaii.gov/, students will need to set up a password with Multi-Factor Authentication.
4. Students should only register once for a MyPVL account at mypvl.dcca.hawaii.gov/ and should use the same MyPVL account from prelicensure to licensure. This will avoid duplicate accounts, emails, passwords, etc.
5. Licensees must print their own pocket IDs and wall certificates from their MyPVL accounts.
6. Prelicense instructors should clearly emphasize that broker candidates must apply for and receive a broker experience certificate (BE) from the REB prior to sitting for the broker licensing exam with PSI. Without an approved BE, broker candidate exam scores shall be voided.

BROKER CURRICULUM UPDATE

At its October 24, 2025, monthly meeting, the Real Estate Commission approved Scott Alan Bly, as its consultant to update and amend the Hawaii Real Estate Commission 80-hour broker prelicense curriculum. Scott Alan Bly, Esquire, Principal and Administrator of Bly School of Real Estate, will be working on this long overdue project.

The Request for Quotes (RFQ) to solicit a consultant for the broker's curriculum project was solicited via HlePRO (Hawaii Electronic Procurement System) / State Procurement Office, as required. The scope of services for the RFQ included conforming to current laws, rules, and industry practices, and incorporating "Broker Management" as a new topic area.

The target date for completion of the updated broker's curriculum is mid-July 2026, subject to budgetary and time requirements.

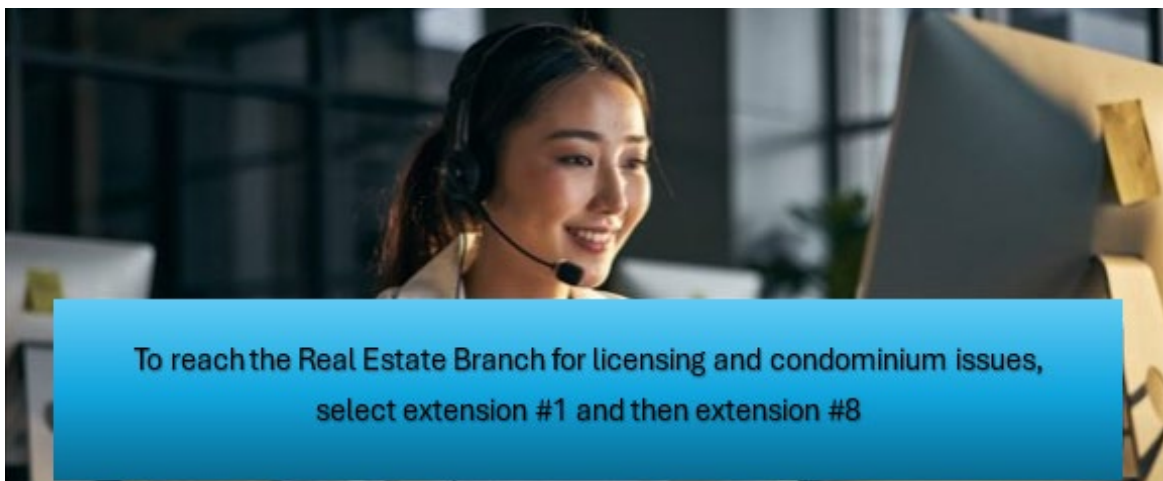


NEW DCCA CALL CENTER AND HOW TO REACH THE REAL ESTATE BRANCH

The state of Hawai'i Department of Commerce and Consumer Affairs (DCCA) launched its new centralized toll-free phone number, 1-844-808-DCCA (3222), designed to make it easier and more efficient for residents, businesses, and consumers to access DCCA services. The new number brings multiple DCCA divisions onto a unified call center platform, improving call routing, case tracking, and consumer support. This effort is part of the department's broader modernization initiative to streamline how the public interacts with state services.

Callers who know which division they need may simply say the division name or wait for the menu prompt to select the division's shortcut number. To reach the Real Estate Branch, select extension #1 and then extension #8.

The DCCA Call Center is open from 7:45 a.m. to 4:30 p.m., Monday through Friday. The Call Center observes the state of Hawaii holiday schedule.

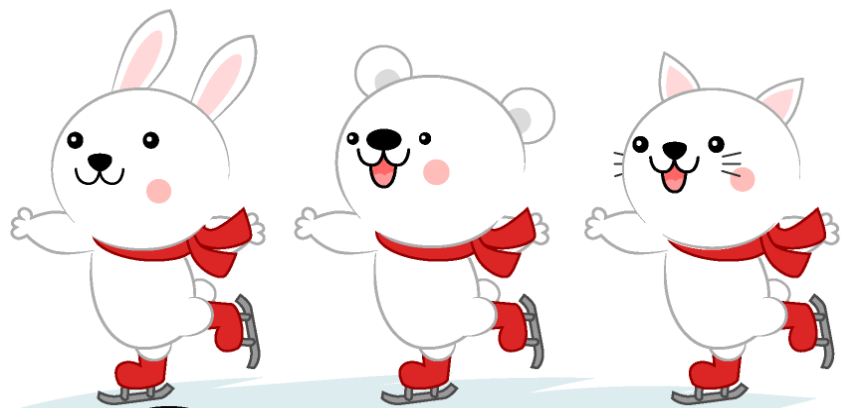
