#### TAKE ADVANTAGE OF MILITARY FINANCIAL AND LEGAL SERVICES:

Explore your financial and legal options with people you can trust (not someone who's earning a commission off your decision).

- If you need financial or legal assistance, immediately contact your base financial counselors.
- Every service branch has military relief societies (such as the Navy-Marine Relief Society); these groups were established to provide advice and emergency assistance to service members and their families.
- Contact your creditors before a payment is late. Other payment options are often available.
