RE: TEMPORARY REDUCTION IN SECURITIES AND FRANCHISE FILING FEES

The Business Registration Division of the Department of Commerce and Consumer Affairs announces that starting January 1, 2016, certain securities and franchise filing fees will be temporarily reduced by 50% from the statutory fee for a one year period. The filing fees will automatically readjust to the statutory fee on January 1, 2017.
