Virtual Meeting Instructions:

A short video regarding virtual meetings was played for attendees. The Chair provided information on internet and phone access for today's virtual meeting and announced that today's meeting was being recorded and that the recording will be posted on the Board's web page.

Call to Order:

The Chair took roll call of the Board members. Chair Oliveira and Mr. Kuo noted that they were present in person.

In accordance with Act 220, SLH 2021, Ms. Moore, Mr. Aratani, and Mr. Dunbar virtually confirmed that they were alone in nonpublic locations.

After taking roll, quorum was established, and the meeting was called to order at 9:17 A.M.

Approval of Minutes:

Approval of the Open and Executive Session Minutes of the February 5, 2026, Meeting

Chair suggested non-substantive edits to the open session minutes of the February 5, 2026, meeting.

DAG Wong requested to remove references to Chapter 91, HRS in the Executive Session Minutes. [Conversations during recess are not captured in board meeting minutes because a recess suspends the formal meeting proceedings under Hawaii's Sunshine Law.]

Upon a motion by Mr. Kuo, seconded by Mr. Aratani, it was voted on and unanimously carried to approve the open and executive session minutes of the February 5, 2026, meeting with edits from the Chair and DAG.

The Chair asked if there was any member of the public requesting to provide public testimony. There were none.

Chair's Reports:

Announcements

Reminder from Chair Oliveira for board members to complete their financial disclosure forms by June 1, 2026.

Delegation to Executive Officer(s) ("EO"):

Delegation to EO(s) -Testing Irregularities Reported by the National Council of State Boards of Nursing ("NCSBN")

EO Chin informed the Board that NCSBN had flagged multiple National Council Licensure Examination ("NCLEX") applicants for testing irregularities, including unusually fast response times, inconsistent performance compared to prior failed exams, and suspicious on-camera behavior. One case from November resulted in a score cancellation under delegated authority, and two additional similar cases were reported in February. Two of the three applicants were connected to a school implicated in the Operation Nightingale investigation.

The Board discussed how to handle these cases moving forward. EO Chin requested guidance and possible delegation of authority to the EOs. DAG Wong advised that NCSBN findings only indicate "irregularities," not confirmed fraud, which limits the

Board's legal basis for denial. Instead, under Hawaii Revised Statutes ("HRS") §457-7, applicants without a valid passing score do not meet licensure requirements, making deferral the more legally appropriate action.

Concerns were raised that deferral could allow potentially dishonest applicants another opportunity, but it was noted that if applicants later pass with a valid score, the Board can consider prior irregularities and impose conditions on licensure. The Board also discussed the appeals process and limitations, including reliance on NCSBN reports in the absence of a Regulated Industries Complaints Office ("RICO") investigation.

The Board concluded that deferral best balances public protection with due process.

Upon a motion by Chair Oliveira, seconded by Mr. Dunbar, it was voted on and unanimously carried to delegate the authority to the Executive Officers to review and defer applications that receive an irregular test outcome result from NCSBN.

Nightingale
Schools:

**Discussion and Proposed Action Regarding Operation
Nightingale**

EO Chin reported that all nursing education transcripts are reviewed on a case-by-case basis to ensure compliance with the Board's statutory and regulatory requirements, including the requirement that at least 40% of credits consist of labs and clinical instruction. Applications are deferred when the submitted documentation does not demonstrate that the minimum educational requirements have been met.

Chair Oliveira recommended formalizing a consistent protocol under the Board's prior delegation to the EOs to ensure uniform application of these standards. The Board discussed applying the same evaluation criteria to all applicants, including those whose educational history includes institutions that may not meet state approval or national accreditation requirements, and noted the importance of consistency with other state regulatory boards.

Based on guidance from DAG Wong, the Board determined that deferral is supported under Hawaii Administrative Rules ("HAR") §16-89-10, which requires applicants to demonstrate completion of a state-approved or nationally accredited nursing education program. Where an applicant's documentation does not establish that these requirements have been satisfied, deferral is appropriate pending sufficient evidence.

Upon a motion by Chair Oliveira, seconded by Mr. Kuo, the Board unanimously voted to delegate authority to the EOs to review and defer applications that do not demonstrate compliance with minimum educational requirements. The Board also directed that general information regarding licensure requirements be made available on the website for public awareness.

EO Chin further reported that a limited number of applications require additional manual review, that certain matters involving licensed individuals are being handled through the appropriate enforcement processes, and that multiple applications are currently pending final disposition.

Session Updates:

Chair Oliveira deferred the agenda item to the next Board meeting to ensure compliance with Sunshine Law requirements. The deferral was necessary because the agenda did not specifically identify the bills under consideration, thereby limiting the public's opportunity to provide testimony on those measures.

Reports:

A. NCSBN Midyear Meeting – Ms. Moore and Chair Oliveira

Ms. Moore and Chair Oliveira attended the NCSBN Midyear Meeting. Ms. Moore reported observing increased scrutiny of regulatory boards nationwide and noted challenges faced by other states, including enforcement practices and fee-related concerns. She also acknowledged Chair Oliveira's report addressing emerging issues such as IV hydration clinics.

Chair Oliveira attended sessions related to the Nurse Licensure Compact ("NLC") to stay informed on developments. She reported that actions taken by non-compact states may affect multistate licensure privileges and emphasized the need for coordination with other states when licensure is encumbered.

Chair Oliveira highlighted national topics discussed at the meeting, including workforce trends, the NCSBN "Environmental Scan," and potential "clean slate" legislation that may limit how far back applicant history can be reviewed. She also summarized items for consideration by the NCSBN delegate assembly, including a proposed NCLEX fee increase effective in 2027, updates to the Model Act and Rules (including clarification of Licensed Practical Nurses ("LPN") scope of practice), and proposed revisions to the Advanced Practice Registered Nurse ("APRN") Compact.

Chair Oliveira further reported that remote proctoring of the NCLEX is not anticipated, as efforts remain focused on enhancing security at testing centers. She also noted presentations on the use of performance dashboards to track application and disciplinary processing metrics.

Additionally, Chair Oliveira summarized discussions regarding federal initiatives that incentivize adoption of licensure compacts and noted potential funding implications for participating states.

Director Laura Reichhardt provided public testimony, expressing ongoing considerations regarding the NLC and state impacts, and supporting the use of board performance dashboards. She also noted that the proposed NCLEX fee increase may disproportionately impact neighbor island applicants who must travel to take the exam.

B. Hawai'i State Center for Nursing ("Center") – Laura Reichhardt, Director-Updates from the 2026 Legislative Session

Director Reichhardt provided an update on the 2026 legislative session. She reported that HCR 105 and SCR 112, originally requesting both a dashboard on hospital nurse staffing ratios and ratio legislation, were amended following clarification requests. The resolutions have been narrowed to request a report on nursing professional organization staffing recommendations only and have passed their first committee.

Ms. Reichhardt also reported on HB 1591, which expands the preceptor tax credit beyond primary care to include additional professions such as behavioral health, APRNs, physician assistants, social workers, and registered dietitians. She noted the measure is not expected to increase state costs but does not address support for local preceptors working with students enrolled in out-of-state online programs, including those pursuing Certified Registered Nurse Anesthetist (“CRNA”) education.

She further discussed HB 1547, establishing a loan repayment program tied to the Rural Health Transformation Program, which requires a multi-year service commitment and is intended to support workforce retention.

Lastly, Ms. Reichhardt reported that SB 2491, an omnibus healthcare bill aimed at aligning licensure laws across multiple professions, did not advance. She noted that stakeholders will continue working on these efforts and requested guidance from the Board and PVL to improve coordination and review ahead of the next legislative session.

C. Hawai’i American Nurses Association (“Hawai’i-ANA”) – Linda Beechinor, Vice President- Updates from the 2026 Legislative Session

Vice President Linda Beechinor provided a report on behalf of HANA President Denise Cohen, who was absent. Ms. Beechinor reported that HANA’s primary legislative focus this session was safe patient staffing standards. She also highlighted efforts to advance legislation allowing volunteer healthcare licensure waivers during declared disasters, noting challenges experienced during recent storms when out-of-state volunteer nurses were unable to practice. She stated that this initiative will continue in the next session. HANA also provided testimony on measures related to youth vaping and tobacco regulation, pesticide exposure near schools, student loan repayment, Medicaid stabilization, APRN issues, and the preceptor tax credit.

Ms. Beechinor reported that HANA has received approved provider status from the American Nurses Credentialing Center (“ANCC”), allowing the organization to offer continuing education programs in Hawai’i.

She also outlined upcoming activities, including a Nurses Week presentation in May, participation in national ANA events and advocacy efforts, and a statewide membership meeting and conference scheduled for September.

Chair asked if there was any member of the public requesting to provide public testimony. There were none.

Executive Session:

Executive Session

Chair Oliveira asked if there was any member of the public requesting to provide public testimony on an application for licensure. There were none.

It was moved by Chair Olivera, seconded by Mr. Kuo motioned to move into executive session in accordance with HRS §92-4 and 92-5(a)(1) and (4) “To consider and evaluate personal information relating to individuals applying for professional or vocational cited in section

29-6 or both;” and “To consult with the Board’s attorney on questions and issues pertaining to the Board’s powers, duties, privileges, immunities, and liabilities”.

It was seconded by Mr. Kuo, voted on and unanimously carried to move into executive session at 10:36 A.M. Upon a motion by Chair Oliveira, seconded by Mr. Kuo, it was voted on and unanimously carried to move out of executive session and move into recess to discuss adjudicatory matters pursuant to HRS Ch. 91 at 11:31 A.M.
