Call to Order: The meeting was called to order at 1:00 p.m., at which time quorum was established.

Approval of the May 11, 2017 Minutes: It was moved by Dr. Bintliff, seconded by Dr. Halford, and carried by a majority, with the exception of Dr. Sept who abstained from the vote, to approve the meeting minutes of the May 11, 2017 meeting as circulated.

Adjudicatory Matters: Chair Desai called for a recess from the meeting at 1:02 p.m. to discuss and deliberate on the following adjudicatory matters pursuant to Chapter 91, HRS.

a. In the Matter of the License to Practice Medicine of Charles Arakaki, M.D.; MED 2017-36-L

Dr. Dao informed members that he will be recusing himself from the discussion and vote of this matter, and left the meeting room 1:03 p.m.

Dr. Egami entered the meeting room at 1:03 p.m.

After discussion, it was moved by Dr. Halford, seconded by Dr. Bintliff, with exception of Dr. Dao who recused himself from the vote and discussion on this matter, and carried by a majority to reject the Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order.

b. In the Matter of the License to Practice Medicine of Timothy D. Beckett, M.D.; MED 2017-16-L

Dr. Dao returned to the meeting room at 1:14 p.m.

After discussion, it was moved by Chair Desai, seconded by Dr. Egami, and unanimously carried to accept the Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order.

c. In the Matter of the License to Practice Medicine of Donald J. Boss, M.D., also known as Donald J. Boss Madsen; MED 2016-243-L

After discussion, it was moved by Dr. Halford, seconded by Dr. Sept, and unanimously carried to accept the Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order.

d. In the Matter of the License to Practice Medicine of Sheryl A. Haggerty, M.D.; MED 2016-250-L

After discussion, it was moved by Dr. Halford, seconded by Dr. Bintliff, and unanimously carried to accept the Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order.

e. In the Matter of the License to Practice Medicine of Ron D. Mark, M.D.; MED 2016-193-L

After discussion, it was moved by Dr. Holt, seconded by Dr. Sept, and unanimously carried to defer the Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order.

The Board noted the discrepancy on page 2, paragraph 6, regarding the disciplinary action taken against Dr. Mark's Michigan medical license.

f. In the Matter of the License to Practice Medicine of James H. Turner, M.D.: MED 2017-25-L

After discussion, it was moved by Dr. Halford, seconded by Chair Desai, and unanimously carried to defer the Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order.

The Board noted the discrepancy on page 2, paragraph 5. Specifically, exhibit "2" referenced in this paragraph refers to the wrong state medical board disciplinary document.

After due consideration of the information received, it was moved by Chair Desai, seconded by Dr. Egami, and unanimously carried to defer Dr. Drake's application pending additional information.

After due consideration of the information received, it was moved by Chair Desai, seconded by Dr. Bintliff, and carried by a majority, with the exception of Dr. Dao who recused himself from the vote

and discussion of this matter, to approve Dr. Ogez's application for licensure.

u. Holly M. Poag, D.O.

After due consideration of the information received, it was moved by Dr. Sept, seconded by Chair Desai, and unanimously carried to approve Dr. Poag's application for licensure subject to certain conditions, basing its decision on the following grounds of the Hawaii Revised Statutes ("HRS"), which find support in the records and files of Dr. Poag's application:

HRS §436B-19(3): Being addicted to, dependent on, or a habitual user of a narcotic, barbiturate, amphetamine, hallucinogen, opium, or cocaine, or other drugs or derivatives of a similar nature.

Based on the foregoing, the Board hereby imposes the following conditions to Dr. Poag's conditional license:

1. Dr. Poag shall, at her sole expense, enter into a monitoring contract with Pu`ulu Lapa`au, Hawaii Program for Healthcare Professionals ("Pu`ulu Lapa`au"). The length of the monitoring contract shall be determined by Pu`ulu Lapa`au. However, said contract may be extended by the Board if the Board believes that reasonable grounds exist.
2. If, at any time, Pu`ulu Lapa`au determines that Dr. Poag is not in compliance with the monitoring contract, she shall immediately notify the Board and immediately cease practicing osteopathic medicine until Pu`ulu Lapa`au specifies to the Board what conditions, if any, it recommends for Dr. Poag to safely resume the practice of osteopathic medicine. Depending upon Pu`ulu Lapa`au's written report and recommendations, the Board may evaluate what, if any, further conditions are warranted for Dr. Poag to practice osteopathic medicine and impose such conditions on her license. If Dr. Poag fails to refrain from using drugs or alcohol, the Board also will consider whether to suspend, revoke, or otherwise discipline her license.
3. During the period of Dr. Poag's conditional license, she shall ensure that Pu`ulu Lapa`au submit quarterly written reports to the Board. These written reports shall include, but not be limited to: 1) Dr. Poag's compliance with the monitoring contract; and 2) Dr. Poag's ability to safely practice as an osteopathic physician. The first quarterly report is due within 90 days from the date of the Board's

letter notifying her of the conditions placed on her conditional license.

4. Should Dr. Poag wish to have any condition removed from her license, Dr. Poag shall make a request in writing to the Board, at which time the Board would consider her request. When doing so, Dr. Poag shall provide evidence of full compliance with her monitoring contract with Pu`ulu Lapa`au and all other conditions placed on her conditional license.

x. Roger S. Sherman, M.D.

After due consideration of the information received, it was moved by Dr. Holt, seconded by Chair Desai, and unanimously carried to approve Dr. Sherman's application pending receipt of a revised application.

z. Chutuoc C. Trandinh, M.D.

After due consideration of the information received, it was moved by Dr. Halford, seconded by Dr. Egami, and unanimously carried to defer Dr. Trandinh's application pending additional information.

cc. William C. Williard, M.D.

After due consideration of the information received, it was moved by Chair Desai, seconded by Dr. Halford, and unanimously carried to approve Dr. Williard's application pending receipt of a revised application.

(ii) Physician Assistant:

a. Dawn M. Harvie, PA-C

After due consideration of the information received, it was moved by Chair Desai, seconded by Dr. Halford, and unanimously carried to approve Ms. Harvie's application for licensure subject to certain conditions, basing its decision on the following grounds of the Hawaii Revised Statutes ("HRS"), which find support in the records and files of Ms. Harvie's application:

HRS §436B-19(3): Being addicted to, dependent on, or a habitual user of a narcotic, barbiturate, amphetamine, hallucinogen, opium, or cocaine, or other drugs or derivatives of a similar nature;

HRS §436B-19(4): Practicing the licensed profession or vocation while impaired by alcohol, drugs, physical disability, or mental instability;

HRS §436B-19(9): Conduct or practice contrary to recognized standards of ethics for the licensed profession or vocation;

HRS §436B-19(12): Failure to comply, observe, or adhere to any law in a manner such that the licensing authority deems the applicant or holder to be an unfit or improper person to hold a license; and

HRS §436B-19(14): Criminal conviction, whether by nolo contendere or otherwise, of a penal crime directly related to the qualifications, functions, or duties of the licensed profession or vocation.

The Board considers Ms. Harvie's conduct as reflected in the records and files of her application to be extremely concerning and contrary to the recognized principles of conduct as adopted by the National Commission on Certification of Physician Assistants ("NCCPA"). Specifically, the Board believes that Ms. Harvie failed to uphold the following NCCPA Principles of Conduct:

- Certified or certifying physician assistants shall practice without impairment from substance abuse and shall practice without impairment from cognitive deficiency or mental illness that, even with appropriate reasonable accommodation, adversely affects their practice; and
- Certified or certifying physician assistants shall behave in a manner that is lawful and ethical, and that upholds all accepted standards of professional practice.

Based on the foregoing, the Board hereby imposes the following conditions to Ms. Harvie's conditional license:

1. Ms. Harvie shall, at her sole expense, enter into a monitoring contract with Pu`ulu Lapa`au, Hawaii Program for Healthcare Professionals ("Pu`ulu Lapa`au"). The length of the monitoring contract shall be determined by Pu`ulu Lapa`au. However, said contract may be extended by the Board if the Board believes that reasonable grounds exist.
2. If, at any time, Pu`ulu Lapa`au determines that Ms. Harvie is not in compliance with the monitoring contract, she shall immediately notify the Board and immediately cease practicing as a physician assistant until Pu`ulu Lapa`au specifies to the Board what conditions, if any, it recommends for Ms. Harvie to safely resume practicing as

a physician assistant. Depending upon Pu`ulu Lapa`au's written report and recommendations, the Board may evaluate what, if any, further conditions are warranted for her to practice as a physician assistant and impose such conditions on her license. If Ms. Harvie fails to refrain from using drugs or alcohol, the Board also will consider whether to suspend, revoke, or otherwise discipline her license.

3. During the period of Ms. Harvie's conditional license, Ms. Harvie shall ensure that Pu`ulu Lapa`au submits quarterly written reports to the Board. These written reports shall include, but not be limited to: 1) Ms. Harvie's compliance with the monitoring contract; and 2) Ms. Harvie's ability to safely practice as physician assistant in all settings. The first quarterly report is due 90 days from the date of the Board's letter notifying her of the conditions placed on her conditional license
4. Ms. Harvie shall notify the Board in writing at least ten (10) business days prior to the start of practicing as a physician assistant in the state of Hawaii. Her written notification shall include, but not be limited to: 1) the names of her Hawaii-licensed supervising physician(s) or osteopathic physician(s); and 2) written acknowledgment by her Hawaii-licensed supervising physician(s) or osteopathic physician(s) of the conditions placed on her conditional license. This information shall be provided anytime she changes or adds a Hawaii-licensed supervising physician(s) or osteopathic physician(s) to her official records with the Board.
5. Should Ms. Harvie wish to have any condition removed from her license Ms. Harvie shall make a request in writing to the Board, at which time the Board would consider her request. When doing so, Ms. Harvie shall provide evidence of full compliance with her monitoring contract with Pu`ulu Lapa`au and all other conditions placed on her conditional license.
