Call to Order: The meeting was called to order at 1:05 p.m., at which time quorum was established.

Election of Officers: The floor was opened for nominations for the office of Chairperson and Vice Chairperson.

Dr. Sept nominated Dr. Geimer-Flanders as Chairperson and Dr. Halford as Vice Chairperson, the nomination was seconded by Dr. Dao. By consensus Dr. Geimer-Flanders and Dr. Halford were elected as Chairperson and Vice Chairperson, respectively.

Approval of the June 8, 2017 It was moved by Dr. Sept, seconded by Dr. Halford, and unanimously carried to approve the minutes of the regular session meeting of June 8,

Minutes: 2017 as circulated, and to approve the minutes of the executive session meeting minutes of the June 8, 2017 meeting with the following amendments:

On page 6, letter q., the first paragraph, should read as follows:

“Dr. Egami [**Sept**]...”

Adjudicatory Matters: Chair Geimer-Flanders called for a recess from the meeting at 1:09 p.m. to discuss and deliberate on the following adjudicatory matters pursuant to Chapter 91, HRS.

- a. In the Matter of the License to Practice Medicine of Erin G. Newman, M.D.; MED 2016-56-L

SDAG Fukumura was excused from the meeting room at 1:09 p.m.

The Board noted that pursuant to Paragraph C.3 of its Final Order dated March 9, 2017, Dr. Newman shall, among other things: satisfactorily complete a continuing medical education (“CME”) course or courses; and within 30 calendar days of receipt of the Board’s Final Order, submit a letter to the Executive Officer. The letter shall include a proposed list of CME courses that Dr. Newman is able to complete and the courses shall be AMA Category 1 or AOA Category 1A approved CME courses related to medical records or medical ethics or professionalism.

At its April 13, 2017 meeting, the Board approved the following courses: Annals of Internal Medicine: Ethics and Professionalism Learning Module; and Medical Record Keeping Course.

Subsequent to the approval of these two courses, the Board received a letter from Alana Peacott-Ricardos, Esq. dated July 5, 2017, regarding the terms of the Final Order as well as certificates of completion for the approved CME courses.

After due consideration of this information, the Board voted by consensus, to inform Dr. Newman that she has satisfied the requirements of Paragraph C.3., of its Final Order dated March 9, 2017.

- b. In the Matter of the License to Practice Medicine of Ron D. Mark, M.D.; MED 2016-193-L

SDAG Fukumura returned to the meeting room at 1:12 p.m.

At its June 8, 2017 meeting, the Board deferred the above matter and noted the discrepancy on page 2, Paragraph A.6., regarding the disciplinary action taken against Dr. Mark’s Michigan medical license. Since that deferral, the Board noted that the discrepancy has since been corrected.

After discussion, it was moved by Dr. Halford, seconded by Dr. Bintliff, and unanimously carried to accept the Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order.

- c. In the Matter of the License to Practice Medicine of Nasrin Mani, M.D.; MED 2017-46-L

After discussion, it was moved by Dr. Bintliff, seconded by Dr. Sept, and unanimously carried to accept the Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order.

After discussion, it was moved by Dr. Halford, seconded by Dr. Egami, and unanimously carried to accept the Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order.

- e. In the Matter of the License to Practice Medicine of David W. Schroeder, M.D.; MED 2016-80-L

After discussion, it was moved by Dr. Holt, seconded by Dr. Halford, and unanimously carried to accept the Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order.

a. Rodney P. Canete, M.D.

After due consideration of the information received as well as Dr. Canete's oral presentation and responses to questions from Board members and staff, it was moved by Dr. Geimer-Flanders, seconded by Dr. Halford, and unanimously carried to defer Dr. Canete's application for licensure.

The Board based its deferment on the following statutory and administrative rule citations:

HRS §453-4(b)(1):

(b) Before any applicant shall be eligible for licensure, the applicant shall furnish proof satisfactory to the board that:

* * *

(1) The applicant is of demonstrated competence and professional knowledge.

HRS §453-8:

(a) In addition to any other actions authorized by law, any license to practice medicine and surgery may be revoked, limited, or suspended by the board at any time in a proceeding before the board, or may be denied, for any cause authorized by law, including but not limited to the following:

* * *

(7) Professional misconduct, hazardous negligence causing bodily injury to another, or manifest incapacity in the practice of medicine or surgery; and

(11) Revocation, suspension, or other disciplinary action by another state or federal agency of a license, certificate, or medical privilege.

(b) If disciplinary action related to the practice of medicine has been taken against the applicant by another state or federal agency, or if the applicant reveals a physical or mental condition that would constitute a violation under this section, then the board may impose one or more of the following requirements as a condition for licensure:

* * *

(1) Physical and mental evaluation of the applicant by a licensed physician or osteopathic physician approved by the board.

HRS §436B-10(a)(9):

(a) Application for a license shall be made on an application form to be furnished by the licensing authority. An applicant shall provide the following information on the application form:

* * *

(9) Any other information the licensing authority may require to investigate an applicant's qualifications for licensure.

Failure to provide the above information and pay the required fees shall be grounds to deny the application for licensure.

HAR § 16-85-7(c):

It shall be each applicant's responsibility to furnish any information and documentation requested by the board. In the event of any change of information provided, the applicant shall notify the board in writing within thirty days of any change.

c. Michael W. Cashman, M.D.

After due consideration of the information received and Dr. Cashman's request to accept, in lieu of its Hospital Form, a supportive letter from Gary L. Peck, M.D. and a first-year summative evaluation signed and submitted to the American Board of Dermatology by Alan N. Moshell, M.D., it was moved by Dr. Halford, seconded by Dr. Bintliff, and unanimously carried to deny Dr. Cashman's request to accept this information in lieu of its Hospital Form.

The Board noted that these two documents do not address past events of concern.

Furthermore, the Board strongly recommends that Dr. Cashman contact the Designated Institutional Officer and/or the new Program Director to have either person complete the Board's Hospital Form or to provide, at a minimum, a letter addressing the Board's concerns.

f. Chutuoc C. Trandinh, M.D.

After due consideration of the information received, it was moved by Dr. Halford, seconded by Dr. Sept, and unanimously carried to approve Dr. Trandinh's application pending receipt of a revised application.

i. Martin K.S. Ishikawa, M.D.

After due consideration of the information received, it was moved by Dr. Dao, seconded by Dr. Egami, and unanimously carried to approve Dr. Ishikawa's application for licensure.

(ii) Request to have the Conditions Removed from a Conditional Medical License:

a. Scottie A. Bussell, M.D.

The Board reviewed Dr. Bussell's letter dated June 25, 2017, requesting that the conditions be removed from his conditional license, License No. MD-17751.

After due consideration of Dr. Bussell's request as well as additional information from other organizations, it was moved by Chair Geimer-Flanders, seconded by Dr. Bintliff, and unanimously carried to remove the conditions placed on Dr. Bussell's conditional license.

(iii) Request for Sponsorship to Retake the United States Medical Licensure Examination (USMLE):

a. Ya Ying Tiffany Wang, M.D.

The Board reviewed Dr. Wang's: 1) letter dated June 30, 2017, requesting that the Board sponsor her to retake all Steps and Step Components of the United State Medical Licensure ("USMLE"); 2) Curriculum Vitae; and 3) USMLE Certified Transcript of Scores.

The Board noted that it had only sponsored an applicant to retake any Step or Step Component of the USMLE if that Step or Step Component was previously passed and exceeds this jurisdiction's previously established time limit for completion of all Steps of the USMLE, and has met all other license requirements in place (i.e. graduation from medical school, completion of at least two years of accredited graduate medical education for foreign medical school graduates, etc.).

After due consideration of the information received, it was moved by Chair Geimer-Flanders, seconded by Dr. Halford, and unanimously carried to deny Dr. Wang's request because, although the Board has repealed its 7-year time limit, it appears that Dr. Wang has not met all other license requirements in place to obtain a medical license in this jurisdiction.
