It was the consensus of the Board that such guard employee registration applications will be handled case by case and must be reviewed by the Board.

Executive Officer's
Report:

a. Guard Employee Renewal Random Audit

The Executive Officer informed the Board that 5% of the guard employees who renewed their guard cards will be randomly audited. Selected guard employees will receive a written notice from the Board and will have 60 days to submit proof of having complied with the following renewal requirement:

CONTINUING EDUCATION (CE): Pursuant to the requirements of §463-10.5 (g) Hawaii Revised Statutes (HRS), all guard registrants, regardless of issuance date, are subject to completing a Board approved four(4) hour course given by an instructor approved by the Board to renew their guard registration. Each guard registrant shall certify on the renewal application that the licensee has satisfied the CE requirements.

Certificates received in response to the audit request will be reviewed by the Executive Officer. Any certificate verifying a course date after June 30, 2016 will be referred to the Regulated Industries Complaints Office as will registrants who fail to provide proof of having to comply with the continuing education requirement.
