Agenda: The agenda for this meeting was filed with the Office of the Lieutenant Governor as required by Hawaii Revised Statutes (“HRS”) section 92-7.

A brief video regarding the virtual board meeting, including meeting procedures and helpful information regarding how members of the public can participate and interact with the board during the meeting, was played.

Call to Order: There being a quorum present, the meeting was called to order at 10:33 a.m. by Chair Denis.

Vice-Chair Inouye, Chief Ferreira, Mr. Collins, Mr. Chu and Chair Dennis confirmed they were present.

Approval of the Board Minutes: Chair Denis asked if there were any corrections to the September 8, 2021 open session minutes and executive session minutes.

It was moved by Vice-Chair Inouye, seconded by Mr. Collins, and unanimously carried to approve the open session and executive session minutes of the September 8, 2021 meeting.

Executive Session: At 10:42 a.m., it was moved by Vice-Chair Inouye, seconded by Chief Ferreira, and unanimously carried to move into executive session pursuant to HRS §92-5 to consider and evaluate personal information relating to individuals applying for professional or vocational licenses cited in section HRS §26-9 or both, and to consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities, as provided in HRS §92-5(a)(1) and (4).

The Board based its decision on the following citation of the Hawaii Revised Statutes (“HRS”), which finds factual support in the records and files of the aforementioned guard employee applicants’ applications:

HRS section 436B-19 provides that;

In addition to any other acts or conditions provided by law, the licensing authority may refuse to renew, reinstate or restore, or may deny revoke, suspend, or condition in any manner, any license for any one or more of the following acts or conditions on the part of the licensee of the applicant thereof:

\* \* \*

- (14) Criminal conviction, whether by nolo contendere or otherwise, of a penal crime directly related to the qualifications, functions, or duties of the licensed profession or vocation.

For reasons contained in the records and files of the aforementioned guard employee applications, the Board placed the following conditions on their conditional licenses:

1. You shall comply with all of the terms and conditions of your parole/ probation.
  - a. You shall provide the Board with semiannual progress reports from their parole/probation officer(s). For the semiannual periods of January to June; and July to December; the progress report shall be due on or before July 31<sup>st</sup> and January 31<sup>st</sup> respectively. The progress reports shall indicate whether you are complying with the terms and conditions of your parole/ probation.
  - b. Upon completion of your terms, you will submit proof of discharge to the Board; and if your probation is amended in any way or is revoked:
  - c. You shall report any such amendment or revocation to the Board within thirty (30) calendar days of the amendment or revocation; and

- d. If you fail to timely notify the Board of such amendment or revocation, this conditional registration shall be automatically revoked without a hearing on the 30<sup>th</sup> day after the date of the amendment or the date your probation/parole was revoked, as applicable;
  2. You shall submit an annual FBI national criminal history record check and State of Hawaii criminal history record check from the Hawaii Criminal Justice Data Center (“**criminal abstracts**”) to the Board.
    - a. These criminal abstracts shall be due on January 31 of each year and shall cover the periods of January to December.
    - b. In order to obtain these criminal abstracts, you shall be fingerprinted electronically at Fieldprint Inc. at your own cost and expense, and
  3. You shall refrain from any actions that may result in your arrest or conviction for any crimes against persons or property (including but not limited to theft, burglary, assault, etc.) or any other act that is directly related to the guard profession.
    - a. You shall report any such arrests or convictions to the Board within thirty (30) calendar days of the arrests or convictions, and
    - b. If you fail to timely notify the Board of such arrests or convictions, this conditional registration shall be automatically revoked without a hearing on the 30<sup>th</sup> day after the date of the arrests or convictions.

After due consideration of the information received, it was moved by Mr. Collins, seconded by Chief Ferreira and unanimously carried to approve Mr. Iose’s application for licensure subject to certain conditions.

B. Election of Chairperson and Vice-Chairperson

C. Permitted Interaction Group to Discuss Updating the 4-Hour CE Course

Chair Denis stated that the purpose of the Permitted Integrated Group (“PIG”) is to investigate and research the best practices of other states with the intent to provide recommendations for the update of the 4-Hour Continuing Education Guard Employee Course for the June 30, 2024 GDE renewal for Board approval.

Having established the scope of the PIG, the Board appointed the following:

EO Fukunaga explained that the PIG will present their recommendations at a future Board meeting. A separate meeting will be held for public comment and Board deliberation.

It was the consensus of the Board to establish the proposed PIG appointing Chair Denis, Vice-Chair Inouye, Mr. Chu, Mr. Heaukulani, Mr. Howard, Mr. Owens, and Mr. Tanaka to report back at a future meeting.

D. Executive Officer Report

1. 2021 Guard Employee Renewal Stats

EO Fukunaga reported on the following renewal statistics:

2021 GDE Renewal: - of the 17,000+ GDEs eligible to renew, 9,640 GDEs renewed on-time

2018 GDE Renewal: - of 14,321 GDEs eligible to renew, 9,004 GDEs renewed on-time

As of November 16, 2021, approximately 400 GDEs restored their registrations. A total of 10,040 GDEs are currently licensed.

2. 2021 Guard Employee Renewal Audit Announcements

EO Fukunaga reported that a total of 561 guard employees were selected for audit to check for compliance with the 4-Hour Continuing Education requirement. Licensees were selected by license number. Audited licensees must submit documentation of their compliance, by December 31, 2021. The CE course must have been completed

between July 1, 2018 and June 30, 2021. If the licensee fails to provide proof of their compliance with the 4-Hour CE requirement, they will be referred to the Regulated Industries Complaints Office (“RICO”).

EO Fukunaga stated information regarding the 2021 GDE Audit as well as a listing of GDEs selected for the audit have been posted to the Board’s website.

3. 2022 Meeting Schedule

EO Fukunaga reported that the 2022 Board meeting schedule has been finalized and posted to the Board’s website.
