Agenda: The agenda for this meeting was posted on the State electronic calendar as required by HRS section 92-7(b).

A short video was played to explain procedures for this virtual meeting and how members of the public can participate and interact with the Board during the meeting.

Call to Order: There being a quorum present, Chairperson Isemoto called the meeting to order at 9:09 a.m.

Amendments to the Agenda: It was moved by Mr. Arita, seconded by Mr. Teves, and unanimously carried to approve the following amendment to the agenda:

Move Mauka Contracting LLC/Colin J. Meehan, RME from "Defer Applications; for further investigation or request for additional documentation" on the Applications Committee Recommendations list to Applications Committee Report under agenda item e.

Minutes: It was moved by Mr. Leong, seconded by Mr. Arita, and unanimously carried to approve the Applications Committee Meeting Minutes of October 4, 2021 and the Board Meeting and Executive Session Meeting Minutes of September 24, 2021, as circulated.

Chapter 91, HRS,  
Adjudicatory  
Matters:

Chairperson Isemoto called for a recess from the Board's meeting at 9:13 a.m. to discuss and deliberate on the following adjudicatory matters pursuant to HRS chapter 91.

1. Settlement Agreements

a. In the Matter of the Contractors' Licenses of Blue Ginger General Construction Inc. and Erminia T.P. Flores; CLB 2019-441-L

RICO received a complaint alleging that in February of 2018, Blue Ginger General Construction Inc. and Erminia T.P. Flores ("Respondents") entered into a contract to build a house for a homeowner in the State of Hawaii in exchange for \$231,600.00. The contract included a one-year warranty which commenced on November 16, 2018.

In February of 2019, the roof started leaking from two vent pipes. Respondents attempted to remedy the issue by having plumbers reseal the vent areas on the roof on several occasions. Thereafter, the roof continued to leak. The homeowners made several attempts to contact Respondents to repair the leak. After receiving no response from Respondents, the homeowners eventually hired someone else to repair the leak.

An Advisory Committee Member (a person who is familiar with the rules, laws, and practices of contractors) opined that Respondents should have known that it

was the roofer's responsibility to repair the leak and that it was poor workmanship to have plumbers attempt to repair the roof.

The Advisory Committee Member further opined that Respondents failed to honor the one-year warranty by not properly repairing the roof leak in a timely manner.

If proven at an administrative hearing, the allegations would constitute violations of the following statute and rule: Hawaii Revised Statutes ("HRS") section 444-17(11) (failure to honor the warranty) and Hawaii Administrative Rules ("HAR") section 16-77-97 (poor workmanship):

Respondents agree to the voluntary surrender of Respondents licenses.

- b. In the Matter of the Contractor License of Steven R. Maratta; CLB 2021-64-L

RICO received information that in or around September 2018, Steven R. Maratta ("Respondent") subcontracted with and paid an unlicensed person, Samuel David Caddle, individually and doing business as Sam Caddle Construction LLC, to perform contracting, electrical, and plumbing work in the City and County of Honolulu, State of Hawaii. RICO alleges that Respondent aided or abetted an unlicensed person to evade HRS Chapter 444, in potential violation of HRS section 444-9.3 (aiding or abetting an unlicensed person to evade HRS Chapter 444).

Respondent agrees to pay an administrative fine in the amount of \$5,500.00.

- c. In the Matter of the Contractors' Licenses of Blue Fin Construction LLC and Vitaliy M. Novikov; CLB 2020-267-L

On or about March 1, 2019 Blue Fin Construction LLC and Vitaliy M. Novikov ("Respondents") entered into a written contract with Complainant. The contract called Respondents to demolish and construct a house located in Honolulu, Hawaii for \$600,000.00. Complainant paid Respondents \$20,000.00.

RICO alleges that Respondents failed to complete the project.

If proven at an administrative hearing, the allegations would constitute violation of the following statute: HRS section 444-17(13) (failure to prosecute project to completion with due diligence).

RICO further alleges that in entering the aforementioned contract, Respondents failed to 1) explain in detail the lien rights of all parties performing under the contract; 2) explain the homeowner's right to demand the bonding on the project; 3) explain how the bond would protect the homeowner or the approximate expense of the bond; and 4) provide notice of the contractor's right to resolve alleged construction defects prior to the commencing any litigation under HRS section 672E-11.

If proven at an administrative hearing, the allegations would constitute violations of the following statutes and rules: HRS section 444-25.5(a)(1) (verbal

disclosures of lien rights); HRS 444-25.5(a)(2) (verbal disclosure of bonding rights); HRS 444-25.5(b)(1) (written disclosure of lien obligations and bonding rights) HRS 444-25.5(b)(2) (disclosure of Respondent's Contractor Repair Act rights) HAR section 16-77-79(a)(4) (disclosure of bonding rights) and HAR 16-77-80(a)(7) (disclosure of lien rights).

Respondents agree to pay an administrative fine in the amount of \$5,000.00.

After discussion it was moved by Mr. Arita, seconded by Mr. Nishek, and unanimously carried, to approve the Settlement Agreement Prior to Filing of Petition for Disciplinary Action in the above cases.

Following the Board's review, deliberation and decisions in these matters, pursuant to HRS chapter 91, Chairperson Isemoto announced that the Board was reconvening to its open meeting at 9:29 a.m.
