Vice Chair Brown noted that for the bills that address 340B pricing carried over from last legislative session (found on pages 5 and 7), should reflect a consistent vote between bills. He noted that there was ample discussion last year that raised issues, although the Board supported the intent of the bills.

Chair Isobe noted that the minutes did not appear to include a discussion on meeting minutes.

EO Fernandez asked when the Board had the discussion.

Chair Isobe noted that it would have been in the preparation for the next meeting as she had expressed interest in getting an update on the rules revision approved by the Board last year.

After asking for any other changes, the motion was made by Chair Isobe to approve the meeting minutes as amended, seconded by Vice Chair Brown, and unanimously carried by the Board members present.

Chair Isobe informed attendees that the Board had accepted the settlement agreement listed above.

Report from

Chair Isobe invited Dr. Corrie Sanders representing the Hawaii Pharmacists Association (HPhA) to provide their report after she arrived to the meeting.

Dr. Sanders delivered her report on behalf of HPhA, beginning with legislative updates regarding bills HB2161 and HB2168 and confirming that the President of the American Pharmacists Association would attend an upcoming event to deliver remarks in person, which she described as a significant opportunity for the profession. She also reported that HPhA's Capital Advocacy Day had been tentatively scheduled for March 16<sup>th</sup> pending room confirmation expected later that day.

Dr. Sanders informed the Board that regarding HB2161, the Consumer

Protection and Commerce committee had adopted HPhA's recommended fee structure of \$50 per year for pharmacists and \$100 per year for the other three entities under DCCA, and she clarified that the House Finance committee would incorporate these fees into the next draft of the bill during the upcoming hearing cycle. She added that appropriations language remained in the bill only as a placeholder for potential future surplus funds, even though no appropriations were being sought at that time.

Dr. Sanders explained that the long-term funding model followed the example of the Center for Nursing, with one full time employee funded by licensing fees and any future program growth supported by federal or state project grants rather than fee increases, which she emphasized were not intended to rise further without legislative action.

Toward the end of her report, Dr. Sanders updated the Board on the upcoming rollout of the Universal MPJE, noting that five states had already signed on for implementation in April and that additional states were expected to adopt it in the fall. She advised that the Board would need to discuss the implications for Hawai'i, particularly for pharmacy students preparing for licensure exams.

Legislative  
Session:

After introducing the agenda item, Chair Isobe opened the discussion to the bills on the agenda.

**A. Bills for Tracking**

1. SB324-Relating to Pharmacists

*Mandates reimbursement for services provided by participating registered pharmacists practicing within their scope of practice by private and public health plans in the State beginning January 1, 2026.*

2. SB1579-Relating to Pharmacists

*Mandates reimbursement for services provided by participating registered pharmacists practicing within their scope of practice by private and public health plans in the State after 7/1/2026.*

3. SB2047-Relating to Pharmacy Benefit Managers

*Establishes requirements for pharmacy benefit managers that reimburse contracting pharmacies for drugs on a maximum allowable cost basis, including maximum allowable cost lists, and maximum allowable cost reports, and complaints process.*

4. SB2208-Relating to Pharmacy Benefit Managers

*Requires the Department of Human Services to establish or select and contract with a third-party administrator to serve as the State Pharmacy Benefit Manager (PBM) who shall be responsible for administering all pharmacy benefits for medicaid beneficiaries enrolled with medicaid*

*managed care organization. Requires medicaid managed care organizations to contract with and utilize the State PBM. Establishes requirements to procure the State PBM in addition to the requirements under state law governing purchases of health and human services. Establishes requirements and prohibitions for the contract to be used by the DHS when contracting with the state PBM. Requires the DHS to establish a single-preferred drug list to be used by the State PBM. Requires the DHS to consult with the Med-QUEST Healthcare Advisory Committee on the development, implementation, and oversight of the State PBM program. Requires reports to the Legislature. Appropriates funds.*

5. SB1509 HD1-Relating to Prescription Drugs

*Requires the Legislative Reference Bureau to conduct a study on best practices for the regulation of pharmacy benefit managers and reduction in prescription drug costs for health insurance plan beneficiaries. Requires a report to the Legislature. Effective 12/31/2050. (HD1)*

6. SB1495 SD1-Relating to Hearing Aids

*Exempts from the general excise tax, gross receipts received by a hospital, infirmary, medical clinic, health care facility, pharmacy, or a practitioner licensed to administer drugs to an individual, from the sale of hearing aids. Effective 12/31/2050. Sunsets 1/1/2027. (SD1)*

7. HB205 HD1-Relating to Workers' Compensation

*Establishes a payment rate not to exceed cost plus forty per cent for nonprescription drugs, over-the-counter drugs, or nonlegend drugs for workers' compensation purposes, subject to certain conditions. Effective 7/1/3000. (HD1)*

8. HB216-Relating to Prescription Drugs

*Establishes requirements for the clinical review criteria and clinical practical guidelines used to establish step therapy protocols. Provides a process for a patient to request an exception to using step therapy protocols. Establishes insurance coverage requirements relating to the use of step therapy protocols and standards to appeal an adverse step therapy exception determination.*

9. HB872 HD1-Relating to Health

*Authorizes health care practitioners to make undesignated prescriptions of single-use epinephrine for the purpose of stocking a supply at various types of businesses and state and county government offices, including public schools. Effective 7/1/3000. (HD1)*

10. HB903 HD1-Relating to Student Health

*Authorizes a school to maintain a stock supply of bronchodilators to be administered under certain conditions. Authorizes certain employees of a*

*school and department personnel to administer certain medication in emergency situations, under certain conditions. Amends prescription drug labeling requirements to include certain information related to a school, if applicable. Effective 7/1/3000. (HD1)*

11. HB933 HD1-Relating to General Excise Tax Reductions

*Reduces the general excise tax rate on the gross proceeds or gross income from the sale of groceries that are eligible under the Supplemental Nutrition Assistance Program (SNAP) or Special Supplemental Nutrition Program for Women, Infants, and Children (WIC), regardless of the means of purchase and the program eligibility of the purchaser. Reduces the general excise tax rate on the gross proceeds or income from the sale of nonprescription drugs. Requires DBEDT to conduct an economic cost-benefit analysis on the general excise tax reductions. Effective 7/1/3000. (HD1)*

12. HB959-Relating to Taxation

*Exempts the sale of groceries and nonprescription drugs from the general excise tax. Incrementally increases the general excise tax over four years, with the increased proceeds during certain fiscal years to be deposited into the general fund. Removes the state income tax on unemployment compensation benefits. Doubles the standard deduction for individuals earning less than \$100,000 and joint returns earning less than \$200,000. Repeals the incremental increases on standard income tax deduction amounts. Increases the minimum income threshold and exemption amount for the low-income household renters' income tax credit. Removes the tax liability for the first \$100,000 of individual income earned. Establishes the Maui Recovery Special Fund to be used for recovery programs related to the 2023 Maui wildfires. Appropriates funds. Applies to taxable years beginning after 12/31/2024.*

13. HB1611-Relating to Taxation

*Beginning 1/1/2027, establishes a yearly reduction in the general excise tax rate on groceries and nonprescription drugs on a tiered schedule, until 1/1/2034 and thereafter, when a full general excise tax exemption applies. Beginning 1/1/2028, provides a general excise tax exemption on the wholesale sale of groceries and nonprescription drugs. Beginning 1/1/2027, prohibits the counties from imposing a county surcharge on groceries and nonprescription drugs.*

14. HB1648-Relating to Workers' Compensation

*Prohibits health care providers from prescribing or dispensing nonprescription drugs, over-the-counter drugs, and non legend drugs for workers' compensation patients.*

15. HB1767-Relating to Opioid Antagonists

*Beginning 1/1/2027, requires health insurers, mutual benefit societies, and health maintenance organizations that issue policies, contracts, plans, or agreements that provide prescription drug coverage to provide coverage for at least one generic opioid antagonist and device.*

16. **SB226-Relating to Prescription Drugs**

*Establishes requirements for the clinical review criteria and clinical practical guidelines used to establish step therapy protocols. Provides a process for a patient to request an exception to using step therapy protocols. Establishes insurance coverage requirements relating to the use of step therapy protocols and standards to appeal an adverse step therapy exception determination.*

17. **SB480-Relating to Health**

*Prohibits drug manufacturers and wholesale distributors from restricting or denying access for pharmacies contracted with 340B covered entities to purchase 340B drugs at a discounted price under the federal 340B Drug Pricing Program. Imposes civil penalties for engaging in unfair or deceptive acts or practices in the conduct of any trade or commerce.*

18. **SB531-Relating to Education**

*Establishes provisions for the storage and maintenance of a stock supply of bronchodilators at schools. Requires the Department of Education to establish a protocol for the storage, usage, and administration of bronchodilators. Establishes provisions regarding the administration of certain medications by a volunteer at Department of Education schools. Clarifies labeling requirements for bronchodilator prescriptions issued to the Department of Education for a stock supply of bronchodilators.*

19. **SB874-Relating to Veterinary Medicine**

*Requires veterinarians to provide a written prescription, upon the request of a client, for any animal patient of a client with whom the veterinarian has established an existing veterinarian-client-patient relationship. Allows pharmacies licensed in the State to dispense medications prescribed by veterinarians. Authorizes the Hawai'i Board of Veterinary Medicine to establish penalties, which may include fines or suspension or revocation of a license.*

20. **SB875-Relating to General excise Tax Reductions**

*Reduces the general excise tax rate on the gross proceeds or income from the sale of groceries that are eligible under the supplemental nutrition assistance program (SNAP) or special supplemental nutrition program for women, infants, and children (WIC), regardless of the means of purchase and the program eligibility of the purchaser. Reduces the general excise tax rate on the gross proceeds or income from the sale of nonprescription*

*drugs. Requires DBEDT to conduct an economic cost-benefit analysis on the GET reductions.*

21. SB956-Relating to Prescription Drugs

*Allows a patient seen in-person by another health care provider in the same medical group as the prescribing physician to be prescribed an opiate prescription for a three-day supply or less via telehealth.*

22. SB1043 HD1-Relating to Taxation

*Reduces the general excise tax rate imposed on nonprescription drugs by one half. Effective 7/1/3000. (HD1)*

23. SB2104-Relating to the General Excise Tax

*Implements a phased repeal of the state general excise tax on the sale of groceries and nonprescription drugs in the State. Prohibits counties from establishing county surcharges on the state general excise tax on gross income or gross proceeds from the sale of groceries and nonprescription drugs in the State. Prohibition on county surcharges to be repealed on 12/31/2030.*

24. SB2106-Relating to Health

*Prohibits the sale of nonprescription diet pills and dietary supplements for weight loss or muscle building to any person under eighteen years of age. Requires retail establishments and delivery sellers to follow certain protocols regarding certain products to prevent access by minors to the restricted products.*

25. SB2610-Relating to Emergency Medication in Schools

*Establishes provisions regarding the volunteered administration of certain medications by authorized persons at public schools, including requirements for parent authorization, administration instruction, and liability protections. Expands permitted emergency treatments to include epinephrine, inhalers, seizure rescue medication, glucagon, insulin, and blood-glucose monitoring.*

The Board noted its decision to track the above bills at the last meeting.

**B. Bills concerning Pharmacy and Pharmacists**

26. HB223 HD1-Relating to Pharmacy

*Establishes the Daniel K. Inouye College of Pharmacy Special Fund to support pharmacist workforce assessment and planning efforts. Establishes the pharmacist workforce assessment fee. Appropriates funds. Effective 7/1/3000. (HD1)*

The Board discussed HB223 with EO Fernandez confirming that HB223 HD1 was a carryover bill from the previous session and stated that although it was not currently being heard, it remained relevant because the newly introduced HB2161 was substantially similar, incorporating changes requested by the Board last year.

EO Fernandez asked DAG Wong whether the Board could formally reaffirm its position on HB223 so that he could apply the same position to HB2161 in testimony.

DAG Wong advised that since item HB223 was on the agenda, the Board could restate its position on HB223 and note that it was similar to HB2161, even though HB2161 itself was not listed.

The Board discussed concerns about possible future fee increases under the bill and agreed that its formal position should state that the Board did not support any increase in fees beyond those already proposed.

Chair Isobe moved to support the intent of HB223 HD1, to include a statement opposing additional fee increases in the future, and to acknowledge on record that HB223 HD1 was substantially similar to HB2161, thereby allowing the same Board position to apply. The motion was seconded by Mr. Rabang, and with objections or abstentions from members, the motion was approved.

27. HB561-Relating to Pharmacists

Authorizes a registered pharmacist under contract with a covered entity for purposes of the federal 340B Drug Pricing Program to supervise via telehealth the filling or receipt of a prescription in certain circumstances.

EO Fernandez reported that HB561 was most likely dead for the session because it had not moved out of its first committee referral. He explained that HB561 was a double-referral bill that needed to be heard by the Health

Committee, but because the deadline for lateral filing was the following day (after the meeting), the bill would have needed to be heard and filed on the same day to remain viable. EO Fernandez noted that the Health Committee typically hears its bills early in the session, and the absence of a hearing by this stage strongly indicated that HB561 would not advance.

Board members briefly acknowledged this status, and the discussion moved on once it was clear the bill would not progress further in the current legislative cycle.

28. HB 1643-Relating to Pharmacy

Specifies a framework for the administration of audits of records of pharmacists and pharmacies.

As a point of focus for the Board, EO Fernandez reported that slight confusion arose at the House Health committee hearing from one sentence in the Board's testimony intended to express the Board's concern about excessive audits was mistaken by the committee Chair to suggest the bill would increase audits, which was not the Board's intent. The Board reviewed the originally drafted language of the testimony compared to the final language to see where the issue arose.

Dr. Sanders of HPhA asked whether the Board had a specific recommendation for a "reasonable limit" on audit frequency, noting that the statement in the testimony might invite questions from legislators.

Members discussed the difficulty of setting such a limit because audits varied significantly in size, type, and frequency, and any numerical threshold could unintentionally worsen workloads if audits were simply consolidated into larger batches. After the discussion, the Board reached consensus that the final sentence of the testimony, which recommended that a "reasonable limit" on audits be considered, should be removed to avoid misinterpretation.

On a motion by Vice Chair Brown, seconded by Chair Isobe, and with Mr. Rabang noting his abstention from the vote, the remaining members of the Board voted to support the intent of the bill.

29. SB1279 HD1-Relating to Pharmacists

Authorizes a registered pharmacist under contract with a covered entity for purposes of the federal 340B Drug Pricing Program to supervise the filling or receipt of a prescription via telehealth in certain circumstances. Effective 7/1/3000. (HD1)

EO Fernandez briefly noted the bill was dead. No further discussion from the Board.

C. **Bills concerning prescriptions and other subjects related to Pharmacy**

30. SB2038-Relating to Medication Labeling

Authorizes certain pregnant persons to receive abortion medication with a label that does not bear their name and other identifying information.

EO Fernandez noted that Senate Health and Human Services committee reviewed the bill and after some discussion about its purpose, chose to defer the bill.

31. HB1539-Relating to Prescription Drugs

Repeals certain prohibitions on the imposition of fees, conditions, or requirements on community retail pharmacies that are not imposed on mail order pharmacies.

The Board discussed HB1539 briefly.

EO Fernandez informed the Board that HB1539 was likely dead for the session, explaining that although it had been referred to committee, the absence of hearings indicated that the bill would not advance. No further discussion or action regarding HB1539 occurred.

32. **SB2283-Relating to Prescription Drugs**

Repeals certain prohibitions on the imposition of fees, conditions, or requirements on community retail pharmacies that are not imposed on mail order pharmacies.

The Board discussed SB2283 only briefly, with EO Fernandez informing the Board that SB2283 had been deferred on February 13 by the Senate Health and Human Services committee.

1. **GFC Pharma LLC**

On a motion by Chair Isobe, seconded by Vice Chair Brown, the Board voted to grant conditional approval for GFC Pharma, contingent upon receiving a corrected application reflecting the proper classification of purpose for the permit, pursuant to section 465-15.

2. **National Health RX LLC**

On a motion by Vice Chair Brown, seconded by Chair Isobe, the Board voted to conditionally approve National Health RX, requiring the pharmacy to submit the final confirmation from the Nevada

Board that all conditional inspection requirements had been fully met. Notice is due to the Board by July 31<sup>st</sup>.

**3. Premier Pharmaceuticals LLC**

On a motion by Chair Isobe, seconded by Mr. Rabang, the Board voted to approve the application pending receipt of a current license verification for Dr. Jacob Fuchs.

**4. ProCompounding LLC**

On a motion by Chair Isobe, seconded by Vice Chair Brown, the Board voted to approve the application, excluding Pharmacist William Colburn.

**5. The Tranzonic Companies**

On a motion by Chair Isobe, seconded by Vice Chair Brown, the Board voted to defer the application to request additional information.

**6. Willowbend Pharma Select LLC**

On a motion by Chair Isobe, seconded by Dr. Shih, the Board voted to approve the application.
