Meetings: It was moved by Mr. Hansen, seconded by Mr. Johnsen, and carried by majority vote (Mr. Chow abstained) to approve the minutes of the February 23, 2016 meeting as circulated.

It was moved by Vice Chairperson Wong, seconded by Mr. Johnsen and unanimously carried to approve the minutes of the August 23, 2016 meeting.

Chair's Report: Chairperson De Luz reported that the letter to Governor Ige regarding motor vehicle transfer of ownership information was sent.

Mr. Short added that the National Highway Traffic Safety Administration ("NHTSA") will mandate that dealers comply

Executive Officer's Report:

- a. Chapter 16-53, Hawaii Administrative Rules, entitled "Fees Relating to Boards and Commissions"

The Executive Officer reported that on October 1, 2016 the Governor signed Chapter 16-53, HAR to be effective October 10, 2016 regarding licensing fee increases. The fee increase is approximately 20%.

Chairperson De Luz recessed the meeting at 9:25 a.m.

- b. In the Matter of the Motor Vehicle Salesperson's License of EDISON CHEN, MVI 2016-8-L

SETTLEMENT AGREEMENT PRIOR TO FILING OF PETITION FOR DISCIPLINARY ACTION AND BOARD'S FINAL ORDER.

Chairperson De Luz reconvened the meeting at 10:23 a.m.

After discussion it was moved by Mr. Chow, seconded by Mr. Johnsen, and unanimously carried to approve the Settlement Agreement for the Motor Vehicle Dealer's License of Qui's Company, Inc., doing business as Autobiz, MVI 2016-7-L in which:

1. The Respondent does not admit to violating any law or rule, but acknowledges that RICO has sufficient cause to file a Petition for Disciplinary Action against Respondent's license.
2. Respondent enters into this Settlement Agreement as a compromise of the claims and to conserve on the expenses of proceeding with an administrative hearing on this matter.
3. Respondent agrees to pay a fine in the amount of FIVE THOUSAND AND NO U.S. DOLLARS (\$5,000.00).
4. If Respondent fails to fully and timely comply with the terms of this Settlement Agreement as set forth, Respondent's license shall be automatically revoked upon RICO's filing of an affidavit with the Board attesting to such failure.

After discussion it was moved by Mr. Hansen, seconded by Mr. Chow, and unanimously carried to approve the Settlement Agreement for the Motor Vehicle Salesperson's License of Edison Chen, MVI 2016-8-L in which:

1. The Respondent does not admit to violating any law or rule, but acknowledges that RICO has sufficient cause to file a Petition for Disciplinary Action against Respondent's license.
2. Respondent enters into this Settlement Agreement as a compromise of the claims and to conserve on the expenses of proceeding with an administrative hearing on this matter.
3. Respondent agrees to pay a fine in the amount of ONE THOUSAND AND NO U.S. DOLLARS (\$1,000.00).
4. If Respondent fails to fully and timely comply with the terms of this Settlement Agreement as set forth, Respondent's license shall be automatically revoked upon RICO's filing of an affidavit with the Board attesting to such failure.

Chairperson De Luz announced he was taking the agenda out of order to discuss applications.

Executive Session: At 9:33 a.m., it was moved by Vice Chairperson Wong, seconded by Mr. Short, and unanimously carried to enter into Executive Session to consider and evaluate personal information relating to the individual applying for licensure in accordance with HRS, §92-5(a) (1), and to consult with the Board's attorney on questions and issues pertaining to the Board's powers, duties, privileges, immunities, and liabilities in accordance with HRS §92-5(a) (4), Hawaii Revised Statutes.

EXECUTIVE SESSION

At 10:39 a.m., it was moved by Vice Chairperson Wong, seconded by Mr. Short, and unanimously carried to return to the Board's regular order of business.

Upon a motion by Mr. Hansen, seconded by Mr. Chow, it was unanimously carried to ratify the above lists for the licenses sought (as attached).

b. Applications

- (i) Nathaniel K. Diego – Motor Vehicle Salesperson

It was moved by Mr. Johnsen, seconded by Mr. Chow and unanimously carried to approve the motor vehicle salesperson application for the above.

- (ii) Austin I.C.K. Figueroa – Motor Vehicle Salesperson

It was moved by Vice Chairperson Wong, seconded by Mr. Hansen and unanimously carried to approve the motor vehicle salesperson application for the above subject to receipt of a signed statement from the dealer principal.

- (iii) Albert Dumaran, Jr. – Motor Vehicle Salesperson

It was moved by Vice Chairperson Wong, seconded by Mr. Hansen and carried by majority vote with Vice Chairperson Wong, Mr. Hansen, Mr. Johnsen and Mr. Chow voting aye, Mr. Short abstaining and Chairperson De Luz voting nay to approve a conditional motor vehicle salesperson's license pursuant to HRS section 436B-19 for the above.

- (iv) Shane Eric Breeden – Motor Vehicle Salesperson
Certificate of License Transfer
August 1, 2014

It was moved by Vice Chairperson Wong, seconded by Mr. Short and unanimously carried to deny Servco's request to amend Servco Subaru Honolulu's licensing record to backdate the employment date of the above as August 1, 2014 but approved the record to reflect the employment date of the above as October 7, 2016, the date of the Servco letter requesting the August 1, 2014 amendment date.

The Board based its decision on the following:

HRS section 437-27 provides in relevant part that:

“If the status of any licensee changes during the period for which the license is issued because of:

- (1) Changes in officers, directors, or limited partners of the licensee or termination of the employment of any licensed salesperson;

* *
the licensee shall within fifteen days thereafter file with the board notice of such change containing such information as may be required by the board;" (Emphasis added).

In addition, HRS section 436B-17 states that:

"Each licensee shall file with the licensing authority the licensee's current mailing, business, and residence address. It shall be the licensee's duty to provide written notice to the licensing authority of any change of address within thirty days of the change." (Emphasis added).

The Board concurred that Servco and/or Mr. Breeden should have caught the error on the pocket ID card issued upon licensure and on the blue courtesy Renewal Notice sent to Mr. Breeden c/o Servco's mailing address.

(v) Harbor Motors, Inc. – Motor Vehicle Dealer Relocation

It was moved by Mr. Hansen, seconded by Mr. Short and unanimously carried to approve the Motor Vehicle Dealer Relocation application for the above.

(vi) Mash Inc. – Motor Vehicle Relocation

It was moved by Vice Chairperson Wong, seconded by Mr. Hansen and unanimously carried to approve the Motor Vehicle Relocation application for the above subject to submission of a signed letter stating the motor vehicle dealer activity termination date for Cox Auto Sales and Rental LLC.

(vii) Royal Enfield North American Limited – Motor Vehicle Distributor

It was moved by Mr. Hansen, seconded by Mr. Short and unanimously carried to approve the Motor Vehicle Distributor application for the above subject to the appointment of a Motor Vehicle Dealer by the distributor.

- Old Business:
- a. Request for clarification from Steven C. Yarbrough: Is a person who provides resources that allow a consumer to gather information relevant to a motor vehicle purchase, and never represents a consumer in any negotiations, required to obtain a motor vehicle consumer consultant license?

Mr. Yarbrough was present and distributed Auto Avail Inc. information to the Board. The Board reviewed the information provided and Mr. Yarbrough informed the Board that he does not charge a dealership fee, does not have a business arrangement with Lending Tree and a consumer can also access this information on their own.

DAG Tam informed the Board that the services that Mr. Yarbrough's Auto Avail Inc. offers does not fall under the consumer consultant definition pursuant to HRS section 437-1.1 which states in relevant part:

.....The term "dealer" excludes a person who sells or purchases motor vehicles in the capacity of:

- (6) A consumer consultant who is not engaged in the business of selling, soliciting, offering, or attempting to negotiate sales or exchanges of motor vehicles or any interest therein for any dealer, and who for a fee provides specialized information and expertise in motor vehicle sales transactions to consumers who wish to purchase or lease motor vehicles; provided that the consumer consultant shall register and pay a fee to the board prior to offering consultant services;

After further discussion, it was moved by Mr. Short, seconded by Mr. Hansen and unanimously carried that based solely on the information provided, a consultant's license is not required for a person who provides resources that allow a consumer to gather information relevant to a motor vehicle purchase and never represents a consumer in any negotiations.
