Call to Order: The Chair called the meeting to order at 9:00 a.m., at which time quorum was established.

Chair's Report: The Chair announced that the Commission may move into executive session to consider and evaluate personal information relating to individuals applying for licensure in accordance with section 92-5(a)(1), HRS, and/or to consult with the Commission's attorney on questions and issues pertaining to the Commission's powers, duties, privileges, immunities, and liabilities in accordance with section 92-5(a)(4), HRS.

Commissioner Pang was excused from the meeting. Prior notification of his non-attendance was received.

Executive Officer's Report: The Commission shall afford all interested persons an opportunity to submit data, views, or arguments, in writing, on any agenda item and shall provide all interested parties an opportunity to present oral testimony on an agenda item subject to the conditions set forth in Section 16-99-83, HAR. The Commission may remove any person or persons, who willfully disrupt a meeting to prevent and compromise the conduct of the meeting in accordance with Section 92-3, HRS.

Minutes of Previous Meeting

Upon a motion by Commissioner Faulkner, seconded by Commissioner Wada, it was voted on and unanimously carried to accept the minutes of the March 23, 2018 meeting.

Laws and Rules Review Committee – Program of Work, FY 18 – Legislative and Government Participation Report

House Bill No. 1874, HD1, SD2 Relating to Condominiums

Supervising Executive Officer (SEO) Fujitani informed the Commission that House Bill No. 1874 was passed with amendments. Amendments were date changes – Effective 1/2/2019; Sunsets 6/20/2023.

Senate Bill No. 2524, SD1, HD1 Relating to County Land Use Requirements
SEO Fujitani informed the Commission that Senate Bill No. 2524 was going to conference today and will keep them informed.

Condominium Review Committee – Option to Renew Contract for up to two fiscal years for Professional Services of Condominium Consultants

Condominium Specialist Choy requested the Commission exercise its two-year option to renew condominium consultant contracts.

Upon a motion by Commissioner Lee, seconded by Commissioner Faulkner, it was voted on and unanimously carried to approve the 2-year option to renew.

Licensing – Ratification:

Upon a motion by Commissioner Cobb, seconded by Commissioner Ginoza, it was voted on and unanimously carried to ratify the attached list.

Chair Senter announced she would be taking agenda items out of order for efficiency purposes.

Licensing – Applications:

The EO informed the Commissioners that the information provided to the Commissioners is related only to the issue that is before the Commission for consideration. The other materials submitted are available for the Commissioners review should they desire to review it. If the applicants have an issue, which is personal in nature, they have the right to request that their application be considered in executive session.

Licensing – Applications:

Sandra G. Siracusa

Ms. Siracusa was present and was asked if she wished to have her application for real estate salesperson considered in executive session. She declined the offer.

Commissioner Lee asked Ms. Siracusa to clarify her role in Metro Motors. Applicant stated that although Metro Motors was under her name, she played a very passive role in the business and didn't know what was going on. She added her husband ran the business and it was under her name because her husband couldn't get his license due to a gun violation in his past. Commissioner Lee asked if Ms. Siracusa understood the responsibilities that came along with the business. Applicant responded she was an art major and not a business person. She added she did not understand business but she has learned to.

Commissioner Klein asked Ms. Siracusa if she was aware Metro Motors was unable to provide certificates of title to purchasers. Applicant responded titles arrive late if it's coming from a bank or the mainland. She stated 99% of the time it happened, it was remedied by returning money to the purchasers. Commissioner Klein asked Ms. Siracusa why she stated she wasn't a business person. Applicant responded she knew nothing about the business or accounting and that detailing cars was her forte.

Commissioner Arakaki inquired about pending RICO matter. Applicant answered she was uncertain whether anything was pending with RICO, but Metro Motors is no longer in business as they claimed bankruptcy and was asked to voluntarily surrender their license.

Commissioner Cobb asked applicant if she knew what responsibilities and laws come with having a real estate salesperson's license. Ms. Siracusa responded she knows salespeople have their duties but they also have a broker with expertise to rely on. Commissioner Cobb commented applicant had her salesperson's license in 1985 and let her license expire and asked if applicant was ready. Ms. Siracusa responded she was selling time shares in 1985 and then decided to go to college. She added she is currently a part time teacher, wanted to do residential sales, and was now ready to do something for herself.

Commissioner Klein asked how old applicant was when she started Metro Motors. Ms. Siracusa answered she was 35 years old at the time.

John Raymond Filighera

Mr. Filighera was present and was asked if he wished to have his application for real estate broker considered in executive session. He declined the offer.

Mr. Filighera had two additional distribution documents for the Commission. He stated the first addition was regarding his bankruptcy attorney, Judson Thomas Farley, who had been disbarred and the second document was a letter from a forensic auditor, Kimberly Lopez, who stated no evidence of co-mingling of accounts was found.

Commissioner Faulkner inquired whether applicant wanted his own brokerage or if he would be working under another broker. Mr. Filighera responded he would work for another broker and eventually would like to have his own brokerage. Applicant stated he would like to retire in Hawaii and added he is a licensed mortgage originator as well.

Chapter 91, HRS,

In the Matter of the Real Estate Salesperson's License of Anthony Bartlett: REC 2017-370-L

Upon a motion by Commissioner Cobb, seconded by Commissioner Faulkner, it was voted on and unanimously carried to accept the settlement agreement.

In the Matter of the Real Estate License of Phillip C. Burchett: REC 2017-367-L

Upon a motion by Commissioner Faulkner, seconded by Commissioner Lee, it was voted on and unanimously carried to accept the settlement agreement.

In the Matter of the Real Estate Salesperson's License of Jared C. Gates: REC 2017-413-L

Upon a motion by Commissioner Wada, seconded by Commissioner Lee, it was voted on and unanimously carried to accept the settlement agreement.

Following the Commission's review, deliberation, and decisions in these matters, pursuant to Chapter 91, HRS, the Chair announced that the Commission was reconvening its scheduled meeting at 9:31 a.m.

Executive Session:

Upon a motion by Commissioner Klein, seconded by Commissioner Wada, it was voted on and unanimously carried to enter into executive session, pursuant to section 92-5(a)(1), HRS, "To consider and evaluate personal information, relating to individuals applying for professional or vocational licenses cited in section 26-9 or both;" and pursuant to section 92-5(a)(4), HRS, "To consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities."

Upon a motion by Commissioner Lee, seconded by Commissioner Faulkner, it was voted on and unanimously carried to move out of executive session.

Licensing –
Applications:

Jamin Michael Smith

After review of the information presented by the applicant, Commissioner Lee moved to approve the real estate salesperson's license of Jamin Michael Smith. Commissioner Klein seconded the motion. The motion was voted on and unanimously carried.

Sandra G. Siracusa

After review of the information presented by the applicant, Commissioner Arakaki moved to deny the real estate salesperson's license of Sandra G. Siracusa. Commissioner Klein seconded the motion. Commissioner Wada abstained from the vote. The motion was voted on and carried.

The Commission based their decision on the following grounds of the Hawaii Revised Statutes ("HRS"), which find factual support in the records and files of her application:

"§467-8 **Prerequisites for license, registration, or certificate.** (a) No license, registration, or certificate under this chapter shall be issued to:

- (3) Any person who does not possess a reputation for or record of competency, honesty, truthfulness, financial integrity, and fair dealing;"

"§436B-19 **Grounds for refusal to renew, reinstate or restore and for revocation, suspension, denial, or condition of licenses.** In addition to any other acts or conditions provided by law, the licensing authority may refuse to renew, reinstate or restore or may deny, revoke, suspend, or condition in any manner, any license for any one or more of the following acts or conditions on the part of the licensee or the applicant thereof:

- (8) Failure to maintain a record or history of competency, trustworthiness, fair dealing, and financial integrity; and
- (11) Engaging in business under a past or present license issued pursuant to the licensing laws, in a manner causing injury to one or more members of the public;"

Juliann R. Sokach

After review of the information presented by the applicant, Commissioner Cobb moved to most likely deny the real estate salesperson's license application of Juliann R. Sokach. Commissioner Arakaki seconded the motion. Commissioner Wada abstained from the vote. The motion was voted on and carried.

John Raymond Filighera

After review of the information presented by the applicant, Commissioner Lee moved to approve the broker's license of John Raymond Filighera. Commissioner Faulkner seconded the motion. The motion was voted on and unanimously carried.
