Call to Order: The Chair called the meeting to order at 9:01 a.m., at which time quorum was established.

Chair's Report: The Chair announced that the Commission may move into executive session to consider and evaluate personal information relating to individuals applying for licensure in accordance with section 92-5(a)(1), HRS, and/or to consult with the Commission's attorney on questions and issues pertaining to the Commission's powers, duties, privileges, immunities, and liabilities in accordance with section 92-5(a)(4), HRS.

Commissioners Arakaki, Klein, and Lee were excused from the meeting. Prior notification of their non-attendance was received.

Executive Officer's
Report:

The Commission shall afford all interested persons an opportunity to submit data, views, or arguments, in writing, on any agenda item and shall provide all interested parties an opportunity to present oral testimony on an agenda item subject to the conditions set forth in Section 16-99-83, HAR. The Commission may remove any person or persons, who willfully disrupt a meeting to prevent and compromise the conduct of the meeting in accordance with Section 92-3, HRS.

Executive Officer Ino ("EO") introduced Lorie Sides, new Condominium Education Outreach Specialist, to the Commission.

Announcement

Supervising Executive Officer Fujitani ("SEO") announced Chair Nikki Senter and Commissioner Rowena Cobb both completed their second four-year term on the Hawaii Real Estate Commission. EO Ino and SEO Fujitani acknowledged Commissioners Senter and Cobb for their exceptional service and presented them with Certificates of Appreciation from the Professional and Vocational Licensing Division, Real Estate Branch.

In appreciation for their outstanding contributions and assistance provided, Commissioner Pang presented Commissioner Senter and Commissioner Cobb with plaques from the Real Estate Commission.

Minutes of Previous Meeting

Upon a motion by Commissioner Faulkner, seconded by Commissioner Pang, it was voted on and unanimously carried to accept the minutes of the May 25, 2018 meeting.

Committees and
Program of Work:

Laws and Rules Review Committee Condominium Review Committee Education Review Committee

Education Review Committee – Continuing Education Administration, Curriculum, Courses, Providers, and Instructors Continuing Education Core Course, "Core B 2017-2018 – Agency and the Practice of Dual Agency and 2018 Real Estate Related Legislation"

Everett Kaneshige was present and informed the Commission that Core B was developed using a different approach. Core B will be more interactive and geared to get licensees to understand the concept of agency and of dual agency through small group discussions of multiple case scenarios. He added instructors must create an open learning environment regarding agency and dual agency as agency deals with fiduciary matters. The bottom line is compliance with the existing laws and rules no matter what the actual practice may be in the industry.

Education Review Committee – Continuing Education Course Monitoring

Senior Real Estate Specialist Fujimura informed the Commission that continuing education providers are currently given advance notice that a monitor will be attending a course. Staff recommends that monitors be anonymous. To achieve this, staff suggests monitors register and pay for continuing education course and be reimbursed by the real estate education fund upon completion of course.

Upon a motion by Commissioner Cobb, seconded by Commissioner Ginoza, it was voted on and unanimously carried to allow reimbursement from the real estate education fund for continuing education course monitoring pursuant to HRS 467-19-B and HAR 16-99-46.

Licensing – Ratification: Upon a motion by Commissioner Pang, seconded by Commissioner Ginoza, it was voted on and unanimously carried to ratify the attached list.

Executive Officer’s Report: The Commission shall afford all interested persons an opportunity to submit data, views, or arguments, in writing, on any agenda item and shall provide all interested parties an opportunity to present oral testimony on an agenda item subject to the conditions set forth in Section 16-99-83, HAR. The Commission may remove any person or persons, who willfully disrupt a meeting to prevent and compromise the conduct of the meeting in accordance with Section 92-3, HRS.

Licensing – Applications: The EO informed the Commissioners that the information provided to the Commissioners is related only to the issue that is before the Commission for consideration. The other materials submitted are available for the Commissioners review should they desire to review it. If the applicants have an issue, which is personal in nature, they have the right to request that their application be considered in executive session.

Licensing – Applications: **Robert John Kirkpatrick**
Mr. Kirkpatrick was present and was asked if he wished to have his application for real estate salesperson considered in executive session. He declined the offer.
Applicant informed the Commission he was in attendance to answer any questions the Commission may have and stated all cases were dismissed except for one. Commissioner Pang asked Mr. Kirkpatrick for more information regarding the domestic violence and disorderly conduct infractions. Applicant responded both incidents were dismissed because video surveillance cleared him.

Commissioner Pang moved to take the matter under advisement. Commissioner Faulkner seconded the motion. The motion was voted on and carried.

Andrew S. Sabo

Mr. Sabo was present and was asked if he wished to have his application for real estate salesperson considered in executive session. He accepted the offer.

Upon a motion by Commissioner Pang, seconded by Commissioner Faulkner, it was voted on and unanimously carried to accept the settlement agreement.

In the Matter of the Real Estate Broker's Licenses of Derk M. VanKonynenburg and Eastdil Secured, LLC: REC 2017-275-L

Upon a motion by Commissioner Wada, seconded by Commissioner Cobb, it was voted on and unanimously carried to accept the settlement agreement.

In the Matter of the Real Estate License of Cindy L. Vicoy: REC 2016-40-L;

Upon a motion by Commissioner Faulkner, seconded by Commissioner Pang, it was voted on and unanimously carried to approve the Commission's Final Order.

Following the Commission's review, deliberation, and decisions in these matters, pursuant to Chapter 91, HRS, the Chair announced that the Commission was reconvening its scheduled meeting at 9:52 a.m.

Upon a motion by Commissioner Pang, seconded by Commissioner Wada, it was voted on and unanimously carried to move out of executive session.

Licensing –
Applications:

Robert John Kirkpatrick

After review of the information presented by the applicant, Commissioner Pang moved to approve the real estate salesperson's license of Robert John Kirkpatrick. Commissioner Faulkner seconded the motion. The motion was voted on and unanimously carried.

Andrew S. Sabo

After due consideration of information presented by the applicant, Commissioner Cobb moved to deny the real estate salesperson's license of Andrew S. Sabo unless, within sixty (60) calendar days, applicant submits written proof of payment, written proof of discharge, or an approved written payment plan with the Internal Revenue Service (IRS) and/or the State of Hawaii, Department of Taxation (DOTAX) for all outstanding tax obligations.

The Commission based their decision on the following grounds of the Hawaii Revised Statutes ("HRS"), which find factual support in the records and files of his application:

"§467-8 **Prerequisites for license, registration, or certificate.** (a) No license, registration, or certificate under this chapter shall be issued to:

(3) Any person who does not possess a reputation for or record of competency, honesty, truthfulness, financial integrity, and fair dealing;"

"§436B-19 **Grounds for refusal to renew, reinstate or restore and for revocation, suspension, denial, or condition of licenses.** In addition to any other acts or conditions provided by law, the licensing authority may refuse to

renew, reinstate or restore or may deny, revoke, suspend, or condition in any manner, any license for any one or more of the following acts or conditions on the part of the licensee or the applicant thereof:

(1) Failure to meet or maintain the conditions and requirements necessary to qualify for the granting of a license;

(8) Failure to maintain a record or history of competency, trustworthiness, fair dealing, and financial integrity;

(12) Failure to comply, observe, or adhere to any law in a manner such that the licensing authority deems the application or holder to be an unfit or improper person to hold a license;"
