Upon a motion by Commissioner Lee, seconded by Commissioner Ginoza, it was voted on and unanimously carried to accept the addition to the RICO Real Estate Advisory Committee.

Provider – The Real Estate Café; Savannah D. Lighty, Administrator

Senior Real Estate Specialist Fujimura stated the provider attended Train the Trainer for Core B 2017 - 2018.

Upon a motion by Commissioner Lee, seconded by Commissioner Arakaki, it was voted on and unanimously carried to approve "The Real Estate Cafe" as a continuing education provider.

Course – "TRUST-IT! A Land trust course to inspire the new real estate advisor"; Author/Owner: Saul Lerner, Ph.D., LL.M; Provider: Abe Lee Seminars; Course Categories: Contracts, Investment, Real Estate Law, Property Ownership and Development; Clock Hours: 3

Commissioner Faulkner commented the required total minutes on the course curriculum add up to 170 minutes, instead of the required 180 minutes (3 hours).

Executive Officer Ino requested the author remove the first line of the last paragraph on page 9 regarding the "Hawaii Real Estate Commission" determining who is considered "an authority".

Executive Officer Ino stated the author appears to be self-promoting his "Aloha Commitment Trust" as indicated in Section 2.

Deputy Attorney General Wong stated the author should include a disclaimer in the course materials.

Course – "TRUST-IT! A Land trust course to inspire the new real estate advisor"; Author/Owner: Saul Larner, Ph.D., LL.M; Provider: Abe Lee Seminars; Course Categories: Contracts, Investment, Real Estate Law, Property Ownership and Development; Clock Hours: 3

Upon a motion by Commissioner Arakaki, seconded by Commissioner Lee, it was voted on and unanimously approved to defer the course and requested author resubmit course subject to further review. "TRUST-IT! A land trust course to inspire the new real estate advisor" as a 3 credit hour continuing education elective course, under the course categories Contracts, Investment, Real Estate Law, Property Ownership and Development, subject to the following recommendations:

1. Review the total number of minutes of the course as the total should be 180 minutes.
2. Remove Real Estate Commission references
3. Remove any references regarding self-promoting language regarding Aloha Commitment Trust
4. Include the standard REC disclaimer
5. Review course materials for typos and grammatical errors
6. Simplify the course for real estate licensees using general and basic concepts of land trusts.
7. Enroll in an Instructors Development Workshop ("IDW") prior to teaching.

Course – "Legal Issues in Commercial Real Estate Transactions – Part II"; Author/Owner: Lori K. Amano, Esq.; Provider: Russ Goode Seminars; Course Categories: Contracts, Real Estate Law, Property Management, Property Ownership and Development; Risk Management; Clock Hours: 3

Commissioner Arakaki motioned to approve "Legal Issues in Commercial Real Estate Transactions" as a 3 credit hour continuing education course, under the course categories: Contracts, Real Estate Law, Property Management, Property Ownership and Development. The motion was seconded by Commissioner Ginoza. Commissioners Arakaki, Ginoza, Pang, Faulkner, Klein, Kyono, Lee and Wada voted aye. Commissioner Love abstained from the vote. The motion was carried.

Course – "Professionalism, Part 1"; Author – James M. K. Stone, Jr.; Provider: West Hawaii Association of REALTORS®; Course Categories: Real Estate Law, Risk Management; Other – Professionalism; Clock Hours: 3

Mr. James M.K. Stone was present to answer any questions or concerns the Commission may have. Mr. Stone announced the course is part 1 of an anticipated 4 series course, and part 1 is a general course on professionalism. The issue of most concern at the NAR conference was professionalism. The West Hawaii Association of Realtors® asked him to develop a CE course on professionalism including licensing statutes, RICO violations, standard forms, and lastly, organizing and drafting correspondence as the topics for the four-part course series. The course will be available for all Hawaii islands and for private companies.

Chairman Pang asked if he thought of offering the course in an on-line format.

Mr. Stone answered "no" because his classes are interactive where the class is engaged with the course materials and because there is a "measured amount of stress" in the class presentation, all of which may be compromised in an online format.

Upon a motion by Commissioner Klein, seconded by Commissioner Wada, it was voted on and unanimously carried to approve "Professionalism, Part 1" as a 3 credit hour continuing education course, under the course categories Real Estate Law, Risk Management; Other – Professionalism.
