Call to Order: The Chair called the meeting to order at 9:02 a.m., at which time quorum was established.

Chair's Report: The Chair announced that the Commission may move into executive session to consider and evaluate personal information relating to individuals applying for licensure in accordance with section 92-5(a)(1), HRS, and/or to consult with the Commission's attorney on questions and issues pertaining to the Commission's powers, duties, privileges, immunities, and liabilities in accordance with section 92-5(a)(4), HRS.

Chair Pang informed the Commission that he and Supervising Executive Officer (SEO) Fujitani met with the Hawaii Association of Realtors® and shared his goals for this upcoming term which included mandatory high school diploma and background checks for prospective licensees. Chair Pang stated that written information will be provided to the Hawaii Association of REALTORS®. Chair added he and SEO Fujitani will also meet with the Honolulu Board of Realtors.

Commissioners Arakaki and Wada were excused from the meeting. Prior notification of their non-attendance was received.

Each speaker will be limited to a five-minute time period pursuant with section 16-99-83 (a)(5), HAR.

Upon a motion by Commissioner Lee, seconded by Commissioner Kyono, it was voted on and unanimously carried to accept the settlement agreement.

In the Matter of the Real Estate License of Robert F. Vafaie: REC 2018-150-L

Upon a motion by Commissioner Faulkner, seconded by Commissioner Love, it was voted on and unanimously carried to accept the settlement agreement.

In the Matter of the Real Estate Broker's License of Barbara K. Jelks: REC 2018-188-L

Upon a motion by Commissioner Faulkner, seconded by Commissioner Ginoza, it was voted on and unanimously carried to accept the settlement agreement.

In the Matter of the Real Estate License of Michael Alan Littman: REC-2015-83-L

Upon a motion by Commissioner Klein, seconded by Commissioner Kyono, it was voted on and unanimously carried to approve the Commission's Final Order.

The Executive Officer informed the Commissioners that the information provided to the Commissioners is related only to the issue that is before the Commission for consideration. The other materials submitted are available for the Commissioners review should they desire to review it. If the applicants have an issue, which is personal in nature, they have the right to request that their application be considered in executive session.

Applications:

Andres David Luevano

Mr. Luevano was present and was asked if he wished to have his application for real estate salesperson considered in executive session. He declined the offer.

Mr. Luevano stated he was present to answer any questions the Commission may have. He stated he was convicted of selling alcohol to minors while was working at a gas station in 2008. Mr. Luevano added on Easter of 2008, his cousin and his wife had an altercation and applicant decided to drive his cousin's wife home. He was subsequently arrested for driving under the influence.

Commissioner Lee asked what Mr. Luevano had been doing for the last 5 years. Applicant responded he and his wife moved to Hawaii and he was in the Army Reserves working at Fort Shafter first as a civil engineer and currently works as a mechanical engineer. Applicant added he was also a certified fitness trainer.

Upon a motion by Commissioner Lee, seconded by Commissioner Klein, it was voted on and unanimously carried to take the matter under advisement.

Request for Approval to use the name Clark Realty

John Connelley, Sarah Cocke, Esq., Ross Uehara-Tilton, Esq., William C. Byrnes, Esq., and Frank Goodale were present to address the Commission. Chair Pang informed the Commission that Clark Realty and the tradename Clark Realty, was being acquired by Venture Group Three, LLC.

Commissioner Lee inquired what John Connelley's capacity was in this request. Mr. Connelley stated he was helping to facilitate paperwork.

Mr. Goodale informed the Commission that he worked with Putty Clark from 1994 and was the principal broker around the time of Mr. Clark's death. Mr. Goodale stated there were unfinished items and he assisted with the trust. He added he was trying to ensure a good home for Clark Realty's 100+ agents and believes it is in the best interest of the agents and of the family trust to align with the Locations Group.

Mr. Connelley informed the Commission that Venture Group Three LLC's entity application has been approved.

Upon a motion by Commissioner Klein, seconded by Commissioner Kyono, it was voted on and unanimously carried to approve the request to use the name Clark Realty.
