Call to Order: The Chair called the meeting to order at 9:02 a.m., at which time quorum was established.

Chair's Report: The Chair announced that the Commission may move into executive session to consider and evaluate personal information relating to individuals applying for licensure in accordance with section 92-5(a)(1), HRS, and/or to consult with the Commission's attorney on questions and issues pertaining to the Commission's powers, duties, privileges, immunities, and liabilities in accordance with section 92-5(a)(4), HRS.

Executive Officer's Report: The Commission shall afford all interested persons an opportunity to submit data, views, or arguments, in writing, on any agenda item and shall provide all interested parties an opportunity to present oral testimony on an agenda item subject to the conditions set forth in section 16-99-83, HAR. The Commission may remove any person or persons, who willfully disrupt a meeting to prevent and compromise the conduct of the meeting in accordance with section 92-3, HRS. Each speaker will be limited to a five-minute time period pursuant with section 16-99-83 (a)(5), HAR.

Minutes of Previous Meeting

Upon a motion by Commissioner Arakaki, seconded by Commissioner Lee, it was voted on and unanimously carried to accept the minutes of the December 21, 2018 meeting.

Committees and Program of Work:

Laws and Rules Review Committee
Condominium Review Committee
Education Review Committee

Laws and Rules Review Committee – Advertising and Team Names Subcommittee

Commissioner Arakaki announced the subcommittee recommended proposed language to include teams be comprised of more than two licensees, that team names should not be larger than the brokerage name, and that unlicensed conduct should be a part of broker's rules.

Executive Officer Ino added he has created a spreadsheet that outlined original language and new language and will be provided at the next Laws and Rules Review Committee meeting.

Chair Pang informed the Commission that the Advertising and Team Names subcommittee has been reconfigured and will now be comprised of Executive Officer Ino, Commissioners Arakaki, Klein, Faulkner, and Love. Commissioner Love moved to approve the updated subcommittee. Commissioner Ginoza seconded the motion. The motion was voted on and unanimously carried.

Supervising Executive Officer Fujitani informed the Commission that House Bill 63, requiring high school diploma or equivalency be a requirement for real estate licensure, that would take effect on July 1, 2020, was introduced to the legislature.

Licensing – Ratification:

Upon a motion by Commissioner Ginoza, seconded by Commissioner Klein, it was voted on and unanimously carried to ratify the January 18, 2019, Approved Applications List.

Chapter 91, HRS, Adjudicatory Matters:

The Chair called for a recess from the meeting at 9:09 a.m., to discuss and deliberate on the following adjudicatory matters, pursuant to Chapter 91, HRS:

(Commissioner Wada arrived at 9:10 a.m.)

In the Matter of the Real Estate License of Karen Ostlie, aka Karen Y. Ostlie: REC 2018-232-L

Upon a motion by Commissioner Faulkner, seconded by Commissioner Ginoza, it was voted on and unanimously carried to accept the settlement agreement.

In the Matter of the Real Estate License of E.D. Christensen dba Dyanne Christensen: REC 2017-24-L

Upon a motion by Commissioner Lee, seconded by Commissioner Faulkner, it was voted on and unanimously carried to accept the settlement agreement.

Following the Commission's review, deliberation, and decisions in these matters, pursuant to Chapter 91, HRS, the Chair announced that the Commission was reconvening its scheduled meeting at 9:12 a.m.

Licensing –
Applications:

The Executive Officer informed the Commissioners that the information provided to the Commissioners is related only to the issue that is before the Commission for consideration. The other materials submitted are available for the Commissioners review should they desire to review it. If the applicants have an issue, which is personal in nature, they have the right to request that their application be considered in executive session.

Licensing –
Applications:

Vinh Duc Ta

Mr. Ta was present and was asked if he wished to have his application for real estate broker considered in executive session. He declined the offer.

The applicant appeared with his principal broker, Stan Young. Mr. Young informed the Commission that he has worked with Mr. Ta for several years and that the applicant has shown integrity and feels he will serve very well as a broker. Mr. Young stated that he and the applicant will continue to work together very closely.

Chair Pang asked what kind of real estate the brokerage practiced. Mr. Young responded property management and some sales. Chair Pang asked how many properties they managed and how many properties have they sold. Mr. Young answered they managed 10 different properties and had approximately 100 accounts and that the applicant sold 3 properties. Mr. Young added he oversaw the applicant's work and that he was competent.

Mr. Ta informed the Commission that his experience varied and that he also helped his clients with financial issues such as avoiding foreclosure.

Chair Pang informed the applicant that the real estate industry dictates you must divulge pertinent information and non-disclosure would not be acceptable. Mr. Young responded that he was aware of the rule but was not aware of the applicant's conviction. Chair Pang reminded Mr. Young that the PB is responsible for his associated licensees. Mr. Ta stated that he didn't understand the question on his real estate application and that he didn't intend to non-disclose. He added he thought his conviction was public record. Chair Pang asked the applicant what he would do if he didn't understand an issue pertaining to a real estate transaction. Mr. Ta responded he would ask his PB.

Commissioner Arakaki moved to take the matter under advisement. Commissioner Lee seconded the motion. The motion was voted on and unanimously carried.

Rocky Barnett

After review of the information presented by the applicant, Commissioner Arakaki moved to take the matter under advisement. Commissioner Faulkner seconded the motion. The motion was voted on and unanimously carried.

Executive Session: Upon a motion by Commissioner Lee, seconded by Commissioner Ginoza, it was voted on and unanimously carried to enter into executive session, pursuant to section 92-5(a)(8), HRS, "To deliberate or make a decision upon a matter that requires the consideration of information that must be kept confidential pursuant to a state or federal law, or a court order." And pursuant to section 92-5(a)(4), HRS, "To consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities."

Upon a motion by Commissioner Ginoza, seconded by Commissioner Kyono, it was voted on and unanimously carried to move out of executive session.

Vinh Duc Ta

After review of the information presented by the applicant, Commissioner Wada moved to approve the real estate broker's license of Vinh Duc Ta, with conditions. Commissioner Kyono seconded the motion. The motion was voted on and unanimously carried.

The conditional real estate broker license is **approved** for the Applicant, subject to the following conditions:

1. That during the term of parole/probation, any violation of the terms of the parole/probation, by the Applicant, shall be grounds for revocation of license.
2. That any subsequent criminal conviction whether by nolo contendere or otherwise, of a penal crime directly related to the qualifications, functions or duties of the licensed profession or vocation shall be grounds for revocation of license.
3. That failure to provide written notice within 30 days to the licensing authority of any judgment, award, disciplinary sanctions, order, or other determination, which adjudges or finds that the licensee is civilly, criminally or otherwise liable for any personal injury, property damage or loss caused by the licensee's conduct in the practice of the licensee's profession or vocation shall be grounds for revocation of license.
4. That the Applicant shall at all times be associated with and under the direct supervision of a principal broker ("PB") or one or more brokers in charge ("BIC"), for all real estate transactions.
5. That the Applicant shall inform the PB, sole proprietor real estate broker, or BIC of a real estate branch office with whom the Applicant associates that the Applicant holds a conditional real estate broker license and may only practice pursuant to certain terms of the conditional license. The Applicant shall present to the Applicant's PB, sole proprietor real estate broker, or BIC of a real estate branch office a copy of the Commission-issued conditional letter. The Applicant shall ensure that the PB, sole proprietor real estate broker, or BIC of a real estate branch office acknowledges the terms of the Applicant's conditional license by signing and returning a signed copy of the conditional letter to the Commission.

6. That **ALL** changes of association and/or employment by Applicant to another real estate broker shall be submitted in writing to the Commission. The new PB, sole proprietor real estate broker, or BIC of a real estate branch office shall acknowledge the terms of the Applicant's conditional license within ten (10) days of the change by submitting a completed Change Form along with a copy of the conditional letter signed by the new PB. Failure to attach the signed conditional letter by the new PB may result in disciplinary action.
7. That the release of the Applicant from parole/probation shall not change any terms of the conditional license.
8. That upon successful completion of parole/probation, the Applicant must submit a written request to the Commission if the Applicant desires to have the conditions removed.

Rocky Barnett

After review of the information presented by the applicant, Commissioner Lee moved to approve the request to remove conditions on the real estate salesperson's license of Rocky Barnett. Commissioner Faulkner seconded the motion. The motion was voted on and unanimously carried.
