Call to Order: There being a quorum present, Chairperson Nishek called the meeting to order at 9:07 a.m.

Agenda: The agenda was posted on the State electronic calendar as required by Hawaii Revised Statutes ("HRS") section 92-7(b).

1. Scope of Activity Committee:

- a. Ryan Eslava

Is a contractor's license required to create and sell a portable solar powered trailer?

Mr. Eslava explained his intent to manufacture solar generators designed for emergency deployment or farm use, intended to provide power in remote locations. He stated that he would primarily be the manufacturer and seller, stating he would not be acting as an electrician or performing installations into a permanent structure.

Mr. Suehiro confirmed with Mr. Eslava that the unit would be on a trailer, would not be laboratory listed, and that Mr. Eslava would not be installing it. Mr. Suehiro advised that if grounding is performed onsite, a C-13 Electrical Contractor license is required. Mr. Suehiro also recommended that Mr. Eslava to determine if an Underwriters Laboratory Listing (ULL) would be required to sell the units to the public, regardless of installation.

Mr. Polischek clarified that the discussion was limited to whether a C-13 license is required and indicated the unit could be sold.

Mr. Alejado recommended that although selling the unit would not require a license, bringing the unit onsite and performing grounding would require a C-13 Electrical contractor license.

Based solely on the information and oral testimony provided, Mr. Alejado made the motion, seconded by Mr. Polischek, and unanimously carried, to approve the recommendations of the Scope Committee on item (a).

The Contractors Examination summaries for January 2026 were distributed to the Board for their information.

2026 Legislation

1. Relating to Remedies

a. HB 1900, HD 1

Prohibits actions based on a building code violation unless the violation was a material violation of the building code. Specifies that claimants must comply with the Contractor Repair Act and bars persons from joining a class action for failure to comply with the Contractor Repair Act. Repeals the requirement that inspections and testing be completed within nine months. Deletes duplicative language for when persons may accept a settlement offer. Limits the amount a claimant can recover if the claimant rejects a contractor's reasonable proposal for inspection or a reasonable offer to remedy.

The House Committee on Consumer Protection and Commerce (CPC) held a hearing on H.B. 1900 on February 3, 2026, and passed the bill with the following amendments:

- (1) Reverting to the existing statutory language with respect to:
 - (A) The ten-year statute of repose for damages based on construction to improve real property;
 - (B) The effect of the ten-year statute of repose on other statutes of limitations;
 - (C) The contents of a notice of claim for construction defect; and
 - (D) The timeframe for a claimant to accept a proposal to inspect the premises for an asserted construction defect; and
- (2) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

Board position: TRACK

2. Relating to the Owner-Builder Exemption

a. HB 1743

Repeals the leasing restriction on owner-builders who obtain an owner-builder exemption to act as their own contractor and who build or improve residential or farm buildings or structures on property they own or lease and do not offer the buildings or structures for sale. Requires an owner or lessee to provide signed written notice that a residential structure offered for lease or sublease was built or improved by an individual who is not a licensed contractor.

The House Committee on Housing (HSG) held a hearing on H.B. 1743 on February 3, 2026.

The Board submitted testimony that has historically opposed similar measures. The bill would repeal the one-year leasing restriction and remove the requirement that owner-builders construct residential or farm structures for their own use or that of specified family members, while requiring written notice if a leased structure was built by an unlicensed individual. The Board opposed similar measures because these longstanding limitations are intended to prevent abuse of the owner-builder exemption to circumvent contractor licensing laws.

The House Committee on Housing (HSG) passed the bill with the following amendments:

- (1) Changing the effective date to July 1, 3000, to encourage further discussion.

3. Relating to the Insurance Fraud

a. SB2948

Increases the scope of insurance fraud and certain offenses. Augments offenses by contractors and insurers during a declared emergency. Clarifies the penalties for the offense of insurance fraud and the capabilities and operations of the Insurance Fraud Investigations Branch, including the annual report to the Legislature and the protection of sensitive information. Adds protection for insurance fraud whistleblowers. Authorizes the Insurance Commissioner to

establish a centralized database for authorized agencies to track insurance fraud data. Appropriates funds.

The Senate Committee on Commerce and Consumer Protection (CPN) held a hearing on S.B. 2948 on February 11, 2026, and passed the bill with the following amendments:

- (1) Deleting the definitions of "claims harvesting" and "post-loss assignment abuse" to avoid overlap with existing statute;
- (2) Deleting language that would have enabled the National Council of Insurance Legislators to access the centralized insurance fraud database;
- (3) Inserting language that clarifies disclosures on the database shall adhere to chapter 92F, Hawaii Revised Statutes;
- (4) Inserting language that clarifies that an insurance professional who reasonably relies on information from a third-party shall not be found to have knowingly omitted material facts;
- (5) Deleting language that would have changed the value threshold for violations and restoring existing statutory language;
- (6) Deleting language that would have required the Insurance Commissioner to require certain contractors to maintain proof of bonding or financial responsibility as a condition of engaging in insured contracting activity and instead inserting language that clarifies that the Insurance Commissioner may coordinate with certain authorities to assure contractor financial responsibility;
- (7) Inserting an effective date of July 1, 2050, to encourage further discussion; and
- (8) Making technical, nonsubstantive amendments for the purposes of clarity and consistency.

The Board commented that S.B. 2948 appears to allow the insurance industry to encroach into areas already regulated under existing contractor laws, particularly regarding contractor oversight and financial responsibility. The Board noted that current law already addresses many of the bill's objectives, suggesting that additional statutory changes may be unnecessary.

Board Position: COMMENT (HRS 444 and HAR 16-77 already require financial integrity).

b. HB2379

Increases the scope of insurance fraud and certain offenses. Augments offenses by contractors and insurers during a declared emergency. Clarifies the penalties for the offense of insurance fraud and the capabilities and operations of the Insurance Fraud Investigations Branch, including the annual report to the Legislature and the protection of sensitive information. Adds protection for insurance fraud whistleblowers. Authorizes the Insurance Commissioner to establish a centralized database for authorized agencies to track insurance fraud data. Appropriates funds.

Board Position: COMMENT (HRS 444 and HAR 16-77 already require financial integrity).

4. Relating to Consumer Protection

a. HB1644

Requires any person or entity selling a residential solar energy device to comply with consumer protection laws. Prohibits the sale of a residential solar energy device without a contractor's license or contractual affiliation with a licensed contractor. Requires a standardized disclosure form to be developed by the Department of Commerce and Consumer Affairs for use in all residential solar proposals and contracts.

The House Committee on Energy & Environmental Protection (EEP) held a hearing on H.B. 1644 on February 11, 2026, and passed the bill with the following amendments:

- (1) Changing the effective date to July 1, 3000, to encourage further discussion; and
- (2) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

The Board commented that the bill would require individuals or entities selling residential solar energy devices to comply with consumer protection laws, prohibit sales without a contractor's license or affiliation with a licensed contractor, and mandate a standardized disclosure form, may be inconsistent with section Hawaii Administrative Rules (HAR) 16-77-4 regarding contractor sales requirements. The Board indicated concern about potential conflicts or overlap with existing administrative rules governing contractor solicitation and sales activities, suggesting that clarification is needed.

Board position: COMMENT (based on discussion above).

b. SB2032, SD 1

Requires any person or entity selling a residential solar energy device to comply with consumer protection laws. Prohibits the sale of a residential solar energy device without a contractor's license or contractual affiliation with a licensed contractor. Requires a standardized disclosure form to be developed by the Department of Commerce and Consumer Affairs for use in all residential solar proposals and contracts. (SD1)

The Senate Committee on Energy and Intergovernmental Affairs (EIG) held a hearing on S.B. 2032 on February 3, 2026.

The Board offered testimony that the measure would require compliance with consumer protection laws for residential solar sales, prohibit sales without proper contractor licensure or contractual affiliation, and mandate a standardized disclosure form. The Board noted that the term "contractual affiliation" may require clearer definition.

The Senate Committee on Energy and Intergovernmental Affairs (EIG) passed S.B. 2032 with the following amendments:

- (1) Requiring the disclosure form required for the sale of a residential solar energy device to include both the total system cash price and financing price;
- (2) Exempting small portable solar generation devices from the disclosure requirements for solar energy devices; and
- (3) Making technical, nonsubstantive amendments for the purposes of clarity and consistency.

Board position: COMMENT (based on discussion above).

5. Relating to County Labor Standards

a. HB1660, HD 1

Authorizes the counties to require contractors to disclose information regarding their employees' wages, benefits, hours, and employment status and deny, revoke, or suspend a building permit application for violating laws relating to wages, benefits, hours, and employment status, under certain conditions. Effective 7/1/3000. (HD1)

The House Committee on Labor (LAB) held a hearing on H.B. 1660 on February 3, 2026.

The Committee passed the measure with amendments:

- (1) Changing the effective date to July 1, 3000, to encourage further discussion; and
- (2) Making technical, nonsubstantive amendments for clarity, consistency, and style.

On February 12, 2026 the House Committee on Consumer Protection & Commerce (CPC) held a hearing on H.B. 1660 H.D. 1.

The Committee passed the measure without amendments.

The Board expressed concern that the bill does not address contractor recourse and that penalizing permits ultimately harms property owners rather than contractors, potentially causing project delays, increased costs, and financial hardship.

Board position: COMMENT (based on discussion above).

b. SB2140

Authorizes the counties to require contractors to disclose information regarding their employees' wages, benefits, hours, and employment status and deny, revoke, or suspend a building permit application for violating laws relating to wages, benefits, hours, and employment status, under certain conditions.

The Senate Committee on Labor and Technology (LBT) held a hearing on S.B. 2140 on February 6, 2026.

The Committee passed the measure with no amendments.

Board position: COMMENT (based on discussion above).

6. Relating to Housing

a. HB2362, HD1

Requires the counties to automatically approve permits for hurricane retrofitting under certain conditions. Effective 7/1/3000. (HD1)

The House Committee on Housing (HSG) held a hearing on H.B. 2362 on February 6, 2026, and passed the measure with the following amendments.

- (1) Changing the effective date to July 1, 3000, to encourage further discussion; and
- (2) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

Board position: REMOVE from tracking list.

b. HB1721, HD1

Clarifies insurance, indemnification, and certain certificate of occupancy requirements for purposes of expedited permits. Repeals 6/30/2031. Effective 7/1/3000. (HD1)

The House Committee on Housing (HSG) heard H.B. 1721, H.D. 1 on February 4, 2026.

The Committee passed as amended:

- (1) Changing the effective date to July 1, 3000, to encourage further discussion; and
- (2) Making a technical, nonsubstantive amendment for the purposes of clarity, consistency, and style.

Board position: TRACK

7. Relating to State Construction Projects

a. HB2514

Establishes the Office of the State Construction Manager within the Department of Accounting and General Services, overseen by the State Construction Manager, to organize, manage, and oversee design review of, and issue design approvals for, state construction projects. Exempts state construction projects from county building permit, inspection, and certificate of occupancy requirements under certain circumstances, as determined by the State Construction Manager. Establishes the Design Review Special Fund and appropriates funds into and out of the fund.

Board position: REMOVE tracking list.

b. SB2543

Establishes the Office of the State Construction Manager within the Department of Accounting and General Services,

overseen by the State Construction Manager, to organize, manage, and oversee design review of, and issue design approvals for, state construction projects. Exempts state construction projects from county building permit, inspection, and certificate of occupancy requirements under certain circumstances, as determined by the State Construction Manager. Establishes the Design Review Special Fund and appropriates funds into and out of the fund.

Board position: REMOVE tracking list.

8. Relating to State Construction Projects

a. HB1984, HD 11

By 7/1/2027, requires government entities in the State that issue building permits to establish a self-certification process for behind-the-meter, customer-sited solar distributed energy resource systems that deems permit applications approved and allows applicants to proceed to build solar distributed energy resource systems immediately. Requires government entities in the State that issue building permits to develop guidance for determining specific conditions when a Federal Emergency Management Agency-mandated No-Rise Certification is not required for a solar distributed energy resource system located in a regulatory floodway. Effective 7/1/3000. (HD1)

The Committee on Energy & Environmental Protection (EEP) held a hearing on February 5, 2026, and amended the measure by:

- (1) Inserting a deadline of July 1, 2027, for government entities to establish the self-certification processes;
- (2) Exempting member-owned electric cooperatives from the self-certification process requirement;
- (3) Changing the effective date to July 1, 3000, to encourage further discussion; and
- (4) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

The House Committee on WAL held a hearing on February 10, 2026, and passed as amended in HD1.

Testimony was prepared to offer comments, re: the Board does not object to the intent of this bill to lower administrative barriers during the permitting process, it should not be done at the risk of consumer safety. This bill includes commercial on-site solar distributed energy resource systems which raises serious concerns. Commercial and large utility-scale

photovoltaic plant projects are complex and do not appear to be suited to a self-certification permit process. Staff were instructed not to provide testimony as this is a permitting/county matter.

The Board discussed public safety issues regarding commercial projects.

Board position: OPPOSE (based on discussion above).

b. SB2352

Requires government entities in the State that issue building permits to establish a self-certification process for behind-the-meter, customer-sited solar distributed energy resource systems that deems permit applications approved and allows applicants to proceed to build solar distributed energy resource system immediately. Requires government entities in the State that issue building permits to develop guidance for determining specific conditions when a Federal Emergency Management Agency-mandated No-Rise Certification is not required for a solar distributed energy resource system located in a regulatory floodway. The Senate Committee(s) on Energy and Intergovernmental Affairs (EIG) and Senate Committee on Government Operations heard S.B. 2352.

The House Committee on Energy & Environmental Protection (EEP) held a hearing on February 5, 2026, and amended the measure by:

The measure was passed as amended with the following:

- (1) Clarifying that landscape architects shall not be included in the definition of "licensed design professional", to provide an attestation for the self-certification process that the proposed project is not located within a special flood hazard area;
- (2) Exempting member-owned electric cooperatives from the self-certification requirements for behind-the-meter, customer-sited solar distributed energy resource system projects;
- (3) Amending section 1 to reflect its amended purpose;
- (4) Inserting an effective date of April 19, 2042, to encourage further discussion; and
- (5) Making technical, nonsubstantive amendments for the purposes of clarity and consistency.

The Board discussed public safety issues regarding commercial projects.

Board position: OPPOSE (based on discussion above).

c. SB2327

Requires government entities in the State that issue building permits to implement SolarAPP+ or a functionally equivalent online automated permitting platform that verifies code compliance and issues permits to licensed contractors for solar distributed energy resource systems in real-time by 1/1/2027. Requires government entities in the State that issue building permits in areas served by an investor-owned electric utility to adopt a self-certification process for solar distributed energy resource systems that are not SolarAPP+ compatible.

Board position: OPPOSE (see SB2352).

9. Relating to Government Contracting

a. HB 2295

Raises the ceiling for the prevailing wages exemption on public works construction projects from \$2,000 to \$5,000 for governmental contracting agencies. Creates exemption to contractors licensing laws for public works construction projects valued up to \$5,000 for governmental contracting agencies.

The House Committee on Labor heard H.B. 2295 on February 19, 2026, and deferred the measure.

The Board members expressed concerns of increasing unlicensed activity .

Board position: OPPOSE (based on discussion above).

b. SB 3114

Raises the ceiling for the prevailing wages exemption on public works construction projects from \$2,000 to \$5,000 for governmental contracting agencies. Creates exemption to contractors licensing laws for public works construction projects valued up to \$5,000 for governmental contracting agencies.

Board position: OPPOSE (based on discussion above).
